WORK SESSION

Deputy Supervisor Metz called the meeting to order. Town Attorney Kevin Sweeny and Acting Town Engineer Sharon Robinson were also present.

PRIVATE COMMERCIAL GARBAGE PICKUPS

Town Clerk Alice Roker explained that there are two changes requested to the Town Code concerning commercial garbage pickups. Joe Hughes, Code Enforcement Agent for the Building Department has asked that the Board include the police department as enforcement agents in this chapter. The other change requested by the Town Clerk is to increase the penalties for non-compliance with the town code.

The Town Board agreed to advertise these proposed changes at the next Town Board meeting for a public hearing in February.

SEWERAGE PUMPING STATIONS

Acting Town Engineer Sharon Robinson provided the Town Board with a report which takes a hard look at all of the pumping stations in the Town of Yorktown.
