A local law to amend Chapter 280 of the Code of the Town of Yorktown entitled "WATER," by amend-

### Section I. Statement of Authority.

This Local Law is authorized by the New York State Constitution, the provisions of the New York Municipal Home Rule Law, the provisions of the Statute of Local Governments, the relevant provisions of the Town Law of the State of New York, the laws of the Town of Yorktown and the general police power vested with the Town of Yorktown to promote the health, safety and welfare of all residents and property owners in the Town.

Section II. Section 280-19(E)(1) of the Town Code entitled "WATER:DISCONTINUANCE OF SERVICE" is amended as follows:

A customer may have his water service discontinued by notifying the Water Department, in writing, at least five days in advance of the desired date of discontinuance. Water charges to that date will be billed to the owner at the next regular billing date. If the request to discontinue service is in connection with a change of ownership of the property a final water meter reading will be conducted and a final bill prepared. During the final water meter reading the water meter will be inspected, and if the Water Department determines that the water meter is in need of replacement for any reason, a fee of \$275.00 will be added to the final water bill.

### Section III. Severability.

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudicated finally by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby

declared to be the legislative intent that the remainder of this local law would have been adopted had any such provisions been excluded.

Section IV. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section V. Effective Date.

This Local Law shall become effective upon filing in the office of the Secretary of State in accordance with the provisions of the Municipal Home Rule Law.
