Senior Advisory Board General Meeting Friday, September 20, 2019

Meeting called to order at 1:00 pm by chair RoseMarie Panio.

A light lunch was provided by NewYork-Presbyterian Hudson Valley Hospital as members entered the meeting room consisting of wraps, fruit and water.

Gil Kaufman led us in the pledge of allegiance, followed by moment of silence.

RoseMarie introduced Dr. Thomas R. Hickernell, Orthopedic Surgeon at NewYork-Presbyterian/Hudson Valley Hospital. He spoke about recent advances in hip surgery, what happens during surgery and what to expect after surgery. There were questions after his presentation.

RoseMarie then introduced John Kinkart, a volunteer member of the Yorktown Planning Board. He spoke about what housing options are available in the Yorktown area for 55+ residents. He explained the difference between single town houses versus condominiums. When asked why more senior homes/condominiums are not available he suggested that one reason might be that there is very little land available in Yorktown and that a density bonus has been denied to developers.
