# III. Meeting Minutes (November 16, 2022) with Subsequent New Activity Added

Attendees: Nancy Milanese, Bridget Krowe, Lynn Briggs, Christine Sisler

### 1. YHPC Team Members

-On October 28, 2021, requested that Supervisor Slater acknowledge Ed Pell in conjunction with Hyatt Cemetery preservation, with chronological thread; no response received yet.

### New

-On December 2, sent follow up email to Supervisor Slater requesting that the Town resolve the future of the Hyatt Cemetery and create an enduring memory to honor Dr. Ed Pell (before Supervisor leaves office); provided original request date, December 28, 2019.

### Background

On October 20, 2020, the Town Board passed a resolution agreeing to pay for one half of the associated cost of a Quonset hut to store the disassembled Zino barn timbers with donors proving the funding for the other part of the cost; private individuals honored their part of the agreement; we expected the Town's committed obligation to come from the Town's general accounting fund, not the YHPC account.

It appears that Planning Department may have removed \$5K on October 29, 2020 from one of our YHPC accounts without our knowledge or approval signature to pay for \$5000 of the \$6325 Town obligation.

Sent emails to Supervisor Slater to determine why \$5K removed from YHPC account to pay for Quonset Hut for storage of Zino barn timbers; Comptroller provided documentation history; the issue is not that the Town did or did not pay its obligation but that the Town extracted its obligation from the YHPC, who had already secured the donors for its portion of the agreement; requesting the return of the funds to the YHPC account.

On August 25, sent Supervisor Slater/rest of Town Board another email indicating "there is no debate over the Town's commitment to meet its obligation ... the issue is where the Town sources the funds ..... Please let us know when the funds will be returned." No response.

On October 31, sent Supervisor Slater another email: "We know you are super busy with year-end matters and also campaigning. Can you let the YHPC know who we can work with to return the \$5K to our Commission account? We are anxious to get our 2023 Yorktown 250 programs underway and we are dependent on these fund to move forward." No response yet.

#### New

On December 2, 2022, YHPC sent follow up email to Supervisor Slater requesting the \$5K "accounting error" be resolved and that the funds be returned before he leaves office, provided original request date, October 31, 2022. No response as of yet.

#### **Pursued Alternate Path**

On November 9 and follow up on November 16, 2022, requested meeting with Luciana Haughwout, our Town Board liaison, to review our 2023 programs, plans and funding; received response on November 22 asking for dates we were unavailable; offered alternative, no word yet.

#### New

On December 12, 2022, sent email follow up asking for December 15 anytime? Waiting for response.

### Other Funding Pursuits (New)

On November 30, submitted funding request for \$17443 to Westchester County Board of Legislators, through our legislator, Vedat Gashi, for funding support for the Digital Audio Tour and four replacement bronze markers; made the first tier of consideration, to hear shortly.

Contacted Michael Martin, Records Advisory Officer, Towns, NY State Archives, who provided me with two sections of the local government records law, 57a, Retentions, Historic Preservation Records, C02 856; MU1 336 or Discretionary planning review case file, C02 430: MU1 402; M1 345; in these two areas, the retention schedule is provided; next steps include requesting the assistance of our YHPC liaison as part of our future meeting.

On December 2, sent follow up email to Supervisor Slater asking for a resolution before he leaves office; provided original request date, September 20, 2021; no response yet.

-Continue to submit Input to the Planning Board: 10 SEQRA site plan reviews completed; now Planning Board is determine environmental impacts from development, board contemplating Full Environmental Assessment Form assessment (no further public input) vs Environmental Impact Study (required if one Adverse Effect significance finding) and public input required in scoping EIS

-received approval from Town Board resolution on November 15, 2022, to advertise RFP for Historic Consultant: Authorize Advertisement for Professional Consulting Services for Historic Properties, Structures, and Landscapes

Resolved, the Town Clerk is authorized to advertise for Professional Consulting Services to support the Town Board and Planning Board on development applications, development proposals, long and shortterm planning projects and other related efforts as it pertains to the issue of historic properties, structures, and Landscape

11. Mobile Audio Tour Guide (see Budget 2023 above)\*\*

### **Desired Result**

-Develop a digital mobile narrated audio tour guide to navigate and discover the historical significance of each point of interest of the story

Scope

-Fifteen Yorktown Revolutionary War sites including selected encampment sites and Andre stops through Yorktown

Approach

-develop the information requirements (what is the story to be told-text, audio), accompanying videos, still photographs, and other resource links

-solicit proposals from digital application vendors

-conduct a test of a digital application vendor with a small subset of sites

Progress

-conducted preliminary interviews with four potential vendors: The Clio, Otocast, Lantern Audio, TravelStorysGPS

-topline initial assessment:

... The Clio-limited "smart functionality"; more like a Wikipedia for points of interest, WCHS choice, makes sense to add profiles for the Andre/Arnold points of interest to The Clio

...Otocast-Ossining based, robust function, 200 tours around US, reasonable cost

...LanternVideo-W3R application, broker, looks for best fit, very expensive

... TravelStorysGPS-has produced several local projects and local historical familiarity, competitive price
