

NOTICE OF SPECIAL ELECTION

YORKTOWN HEIGHTS FIRE DISTRICT, IN THE

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the Yorktown Heights Fire District (hereinafter called "Fire District"), in the Town of Yorktown, Westchester County, New York, will be held at the Main Firehouse, 1916 Commerce Street, Yorktown Heights, in the Town and the Fire District, on Tuesday, June 17, 2014. The polls shall open at 4:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on April 29, 2014, the following Proposition will be submitted to the qualified voters of the Fire District for approval or disapproval:

SHALL EACH OF THE FOLLOWING DESCRIBED BOND RESOLUTIONS ADOPTED BY the Board of Fire Commissioners (the "Board") of the Yorktown Heights Fire District (the "Fire District"), in the Town of Yorktown (the "Town"), Westchester County, New York, on April 29, 2014, BE APPROVED?:

(A) authorizing the issuance of serial bonds in the principal amount of not to exceed \$625,000, to finance that portion (\$625,000) of the appropriation for the Project, as hereinafter defined, which is not to be expended from the "Real Property Acquisition and Improvement Capital Reserve Fund" (the "Capital Reserve Fund"); appropriating \$1,100,000 from the Capital Reserve Fund and the \$625,000 bonds authorized herein for the Project, for a total appropriation of \$1,725,000; authorizing the construction of a new one-story firehouse, designated the Kitchawan Fire and Rescue Station, on land owned by the Fire District and situate therein on Kitchawan Road, in the Town, including grading or improvement of the site and purchase of the original furnishings, equipment, machinery or apparatus required for the purposes for which said firehouse is to be used ("Project"); stating the estimated maximum cost thereof is \$1,725,000, stating (i) that the period of probable usefulness of the Project is twenty-five (25) years, (ii) it has been determined that, pursuant to SEQRA, the Project is an Unlisted Action and a Negative Declaration has been issued and filed and (iii) the plan of financing is the levy and collection of taxes to pay the principal of said bonds and the interest thereon as the same become due and payable, and

(B) authorizing the issuance of serial bonds in the principal amount of not to exceed \$1,500,000, to finance the appropriation for the Project, as hereinafter defined; appropriating \$1,500,000 for the Project; authorizing the construction of a second story addition to and the reconstruction of the firehouse located on 794 Locksley Road in the Town, designated the Locksley Road Fire Station, including grading or improvement of the site and purchase of the original furnishings, equipment, machinery or apparatus required for the purposes for which said firehouse is to be used ("Project"); stating the estimated maximum cost thereof is \$1,500,000, including preliminary costs and costs incidental thereto and to the financing thereof; and stating that (i) the period of probable usefulness of the Project is ten (10) years, (ii) it has been determined that, pursuant to SEQRA, the Project is a Type II Action and no further review is necessary and (iii) the plan of financing is the levy and collection of taxes to pay the principal of said bonds and the interest thereon as the same become due and payable.

All residents of the Fire District who were duly registered to vote with the Westchester County Board of Elections on or before May 27, 2014, shall be eligible to vote at said Special Election.
