Meeting of the Town Board, Town of Yorktown held on February 6, 2018 at the Town Hall, 363 Underhill Avenue, Yorktown Heights, New York 10598.

TOWN BOARD MEETING

Supervisor Ilan Gilbert called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved into Executive Session to discuss personnel issues concerning individual employees, an item that would imperil effective law enforcement, if disclosed, and contract negotiations and litigation. Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Supervisor Gilbert led the Pledge of Allegiance.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

DURING THE REPORT FROM THE TOWN SUPERVISOR

Supervisor Gilbert mentioned that he has spent the last couple of weeks working on constituent issues and meeting with condominium associations regarding recycling issues. He also stated that the Town has been contacted by many residents regarding broken utility poles and they have been in touch with the various utility companies to repair and rectify these situations. Supervisor Gilbert said that if you see a utility pole situation that requires attention, please contact his office.

Supervisor Gilbert also stated that the Parks and Recreation Commission is now heading up the Granite Knolls Sports and Recreational Facility project.

Supervisor Gilbert invited Karren Perez, Direction of Section 8 Housing, to come before the Board. Ms. Perez announced the lottery for affordable housing project on Kear Street and at the Crossroads in Somers is February 8. Eligibility requirements are online and the Housing Action Council in Tarrytown is accepting applications now in person. Ms. Perez also said that she is available as a resource for any person with housing issues.

Supervisor Gilbert introduced the new interim Town Attorney and the Oxman Law Group. Marc Oxman stated that he is honored to represent the Town. The Oxman Law Group is a composite of 12 lawyers representing different areas of the law. Each of these attorneys will be available to the Town but the point person will be the interim Town Attorney Richard S. Abbate.

DURING REPORTS FROM THE TOWN COUNCIL

Councilman Tom Diana gave kudos to the Police Department for the speedy arrest of those responsible for the recent bomb scare at the high school. He also thanked the Police for the recent drug arrest in Town. The Police Chief and he are working on a program and more information will be forthcoming which he thinks the community will find interesting.

Councilwoman Roker yielded her time to Westchester County Legislator Michael Kaplowitz who was present for the honor being given to Sal Rivera. He congratulated the new board and new administration and he and John Testa look forward to working with them. He spoke about how affordable housing has changed over the years and that there is no longer a stigma attached to the term "affordable housing." It is an economic investment in the quality and diversity of our community and has become a way for our residents to be able to remain in their hometown.

Councilman Patel stated that he attended the Westchester Municipal Officials Association meeting and remarked how interesting and informative it was. He also stated that he received very interesting information regarding school programs in Ossining.

Councilman Lachterman stated that he is having trouble with what he perceives to be a lack of transparency that the Town Board has demonstrated in choosing the Oxman Law Group. He feels that this is a patronage situation and one that is being forced on the Town. He also feels that this is an ethics violation in that Mr. Oxman should have disclosed up front that he was representing a resident who had a lawsuit against the Town.

Supervisor Gilbert again stated that this is an interim appointment that fills the gap between former Town Attorney Michael McDermott's resignation date and the appointment of a permanent Town Attorney. He said that he was very familiar with the work and reputation of the Oxman Law Group and decided on them for the gap period. An RFP (Request for Proposals) will be published in the near future to search for permanent representation.

Councilman Diana agreed with Councilman Lachterman by stating that there is a transparency issue, especially since the issue of transparency was a campaign issue for the new members of the Town Board. He stated that he believes the Town could have survived the 5 or 6 weeks without an interim attorney since both the supervisor and his assistant are attorneys.

Councilwoman Roker began by saying that although she respects both Councilmen Lachterman's and Diana's opinions, they will have to respectfully agree to disagree on this issue. She stated that this same conversation has been discussed over the last three meetings and it is now time to move on.

DURING REPORT FROM HIGHWAY SUPERINTENDENT

Highway Superintendent David Paganelli announced the upcoming nasty weather and cautioned that there will be freezing rain and black ice. He asked that residents call his office if they notice potholes that need repair.

PRESENTATION

Mrs. Noreen O'Driscoll, Director of Yorktown Senior Services and Nutrition Center, and Chief of Police Robert Noble came before the Town Board to commend the drivers of the Yorktown Senior Center who deliver meals to the elderly and homebound. Ms. O'Driscoll related stories of how these drivers have been in situations where they have been directly responsible for aiding seniors who they have found incapacitated while doing their deliveries. Both Ms. O'Driscoll and Chief Noble remarked how all of those being recognized have been in situations where they were responsible for 911 calls to assist seniors who have been in physical danger. Chief Noble mentioned his admiration for not just their job responsibilities, but also for their awareness of the people they serve.

Proclamations from New York State Assemblyman Byrne and New York State Senator Murphy were read. John Winton from Senator Murphy's office expressed his admiration for the senior community in Yorktown and how the Town provides for its seniors. Westchester County Legislator Michael Kaplowitz presented a proclamation from the Westchester County Board of Legislators announcing that February 10th will now be known as Salvatore Rivera Day.

Chief Noble also spoke about the Alliance for Safe Kids Save-A-Life Forum to be held on March 18, 2018 at Lakeland High School from noon to 3:00 p.m. He stated that this program is great because it tries to put kids in positive places to do good things and make the right choices.

Councilman Lachterman said that the Save-A-Life Forum is a terrific program because it brings real life situations to the students that can have tremendous impacts on them. Councilman Diana spoke how the opioid crisis has now become a national epidemic.

Mr. John Winton from Senator Murphy's office spoke of a taskforce hearing of the NYS Senate Taskforce on Heroin and Opioid Addiction that is being held on February 15th at 6:30 p.m. at Pace University in Pleasantville. Everyone is encouraged to attend. A main topic will be an investigation of state regulations regarding sober homes and sober living.

Supervisor Gilbert remarked that it comes down to enforcement, education, prevention, and then recovery. He said the opioid crisis needed to be approached with a global solution. Supervisor Gilbert said he hopes to announce soon the creation of a commission for the Town to address all of the different aspects of drug addition, since a multi-prong approach is the best way to help combat the problem.

Westchester County Legislator Michael Kaplowitz stated that, late in December, the county attorney had been authorized to join lawsuits against the "Big Pharma," the large pharmaceutical companies. So Westchester County will be in the courtroom with lots of other entities against these companies. He explained that it would be analogous to the lawsuits brought against the big tobacco companies.

COURTESY OF THE FLOOR

Mr. John McMullen, poet laureate, said that the first poetry workshop held at the library was a success. He recited his poem, "Ice on Lake Mahopac."

Mr. Grigory Kravtsov, resident, first thanked the Town Board for moving Courtesy of the Floor to the beginning of the meeting. He then said that he is hoping that the new Board would consider his claim that the Town over-enforced the Wetland Ordinance against his property; namely, that the previous administration would not listen when he brought his proposal to make his home and property both insurable and sellable. He likened the process to being railroaded, and now the property is engulfed by floods. He is in trouble with his mortgage holder because he can no longer obtain insurance for the flooded property and the bank wants to foreclose on the mortgage. He stated that the previous administration wrongfully enforced the wetland ordinance to the detriment of the homeowner. His stated his property also took on water from the broken dam at Sparkle Lake which caused a tremendous amount of damage. Mr. Kravtsov stated that this is actually what caused the loss of his insurance and the bank to send their representative to foreclose on the mortgage. He mortgage. He hopes that this administration will be more constructive and sympathetic to the plight of homeowners who find themselves on the receiving end of the wrongheaded protection of wetlands.

Mr. Jay Kopstein, resident, asked what has the Town done or is doing about the unlawful and unsafe construction practices that are taking place at the Kear Street housing project. The contractor has obstructed unsafely and unlawfully traffic for the last several weeks. What has the Town done or is doing at the old Hilltop Gas Station site to gain compliance with the site plan that the Town approved at the request of the new owner, who now is not in compliance with his own request? Tonight's resolution regarding the limited Master Plan for the Roma Building and the Weyant does not designate the area to be studied. He spoke of the negative traffic impact these projects would have on the surrounding areas, and these areas need to be included in such a study. He also stated that he disagrees with Councilman Diana on a statement he made regarding the duties of the Town Attorney that could be covered by the Supervisor and assistant during an interim period. Mr. Kopstein stated that the Town Supervisor was not elected to be the Town Attorney, even though he has a good reputation as an attorney. The same was said for Stewart Glass. Acting as attorneys for the Town is not part of their current responsibilities.

Mr. Ed Ciffone, resident, stated that decisions should be made on unfinished capital projects; namely, moving the Highway Garage project. He said that the Supervisor needs to make a decision on this and can get out of the contract with the architect. Mr. Ciffone stated that with the surplus in the fund balance (10.7 million) the previous board could have done moving the garage. The sports complex is also going to be an issue that the Board will have to decide where the rest of the money is going to come from. Mr. Ciffone did say that he is glad the Granite Knolls Sports Complex is now back in the hands of the Parks & Recreation Commission and the Parks & Recreation Department. Mr. Ciffone asked if a decision will be made soon regarding a second Courtesy of the Floor.

Supervisor Gilbert said that they have not yet decided on a second Courtesy of the Floor but his initial feeling is that when the Board has an agenda the length that they have, one Courtesy of the Floor and the opportunity to speak during public hearings may be sufficient.

Mr. Ciffone addressed Councilman Lachterman regarding an article that was written about how the former Town Attorney, Michael McDermott, was hired. He said that the article stated that the only person interviewed for the job at that time was Mr. McDermott. Councilman Lachterman said that

Jeannette Koster should be contacted. He stated that he did not want to open that door because he did not want to embarrass anyone, but went on to mention campaign contributions and said that Mr. Ciffone is barking up the wrong tree. Councilman Lachterman stated that the article is wrong and that Ms. Koster should be asked if she was interviewed.

Mr. Dan Strauss, resident, thanked the Board for microphones at all meetings, moving Courtesy of the Floor, and for more public input. He brought up the problem of open, overflowing garbage dumpsters, specifically siting Maple Hill Street. Mr. Strauss said that business in town is floundering and it could not flounder more if you do not pick up trash. No one would want to come to do business here if it is not cleaned up. He invited the Town Board and advisory boards to go and look at the back of the businesses on Maple Hill Street to see for themselves.

Mr. Rob Puff, resident, read a statement that he is disappointed in the newly elected members of the board in what he perceives to be a lack of integrity regarding the hiring of the Oxman Law Group as acting town counsel, especially in the wake of a pending lawsuit, and said that reeks of political payback. He stated that it was done without notice on the agenda, which smacks of hypocrisy given their campaign tactics months before. He asks that the Board go on the record to explain how and why this decision can be justified.

Mr. Ken Belfer, president of Lake Mohegan Improvement District, thanked all of those involved and responsible for the bid and award of the aquatic weed harvester.

Dr. Pell, resident, asked the Board begin immediately to restore the Hyatt Burying Ground.

Mr. Greg Bernard, former councilmember, asked if the Board has discussed the liaisons to the advisory boards. He asked if the RFP that went out for a traffic study be pursued and placed on a work session.

Ms. Geri Schwalb, resident, asked if the Board would consider doing something about the sober home on Underhill Road, which the newspaper says is now operational.

Upon motion made by Councilman Lachterman, seconded by Councilman Diana, Courtesy of the Floor was closed.

In response to Geri Schwalb, Supervisor Gilbert stated that former town attorney, Michael McDermott and the Building Department looked into speaking with the author of the article to see what facts the article was based on, since the Town did not have and actual basis for going onto the property and determining if there was activity.

Supervisor Gilbert stated that he has already given his reasons for why he hired the Oxman Law Group at previous meetings and will not address it further. He did address the reason why is was not on the agenda: the night that it was done was the last public hearing the Town had where it could have been public before Mr. McDermott's resignation. Mr. McDermott made it clear that he wanted a clean cut and therefore, his request was honored. Councilman Lachterman said that the agenda came out late that night and the item could have been placed on it. Councilman Lachterman asked Town Attorney Richard Abbate if there was any overlap with the Oxman firm and Mike McDermott regarding ongoing cases, particularly the sober home. Mr. Abbate stated he had not had any direct conversations with Mr. McDermott, and he has just received the files on the sober home.

Councilwoman Roker stated that she had spoken with John Landi, Building Inspector, regarding the sober home. She said that part of this discussion needed to take place in closed session since there are legal issues involved. She said that Mr. Landi visited the sober home but was not invited in, which is their prerogative, but despite that, he has a handle on the situation.

Councilman Lachterman addressed Mr. Kravtsov's issue by saying that he never came before the Board in the last two years with a wetland permit application. The problem he has is years and years old and there is also litigation involved. As far as the Granite Knolls project and Mr. Ciffone's comments, it is not the \$4.6 million as he quoted because there was money given the first time around - \$6.1 million in total that was there for the fields - so there is not the gap that Mr. Ciffone thinks there is. However, Supervisor Gilbert said that there appears to be some short fall that is being worked on.

Councilman Roker addressed Mr. Bernard's comments by saying that she is concerned about the area of the traffic study because that is where the new Granite Knolls sports complex will be which will increase traffic. She also addressed Mr. Kopstein's comments about the Kear Street project and said that she has also noticed that it has frequently become a one-way street, as he observed. She said that she would speak with Chief Noble about what can be done. Mr. Kopstein stated that you do not need to contact the police – this is a code enforcement issue that can be addressed by the code enforcement officer.

ADVERTISE PUBLIC HEARING TO AMEND CHAPTER 168-1 MASTER FEE SCHEDULE

Councilman Lachterman stated that he felt this law was just changed for the purpose of transparency and does not think that it needs to be changed back. He feels that it detracts from transparency by taking it off public hearings.

Supervisor Gilbert stated that the only reason this has been brought up is because every time the fee schedule is changed, it will necessitate a refiling and reprinting of the law. It was actually recommended by the former town attorney. Supervisor Gilbert and the Board decided that it was not necessary to pursue and the resolution was withdrawn.

AUTHORIZE THE YORKTOWN PLANNING DEPARTMENT TO PRODUCE A TARGETED LIMITED MASTER PLAN FOR THE WEYANT PROPERTY AND THE ROMA BUILDING This Resolution was tabled to a future Town Board meeting

WHEREAS, the Town of Yorktown Town Board has received two petitions to rezone property within the Yorktown Heights hamlet; and

WHEREAS, said petitions are for adjacent and abutting properties known as The Weyant, located at 2040 Crompond Road and known on the tax maps of the Town of Yorktown as tax ID 37.14-2-32, and the Roma Building, located at 2038 Saw Mill River Road and known on the tax maps of the Town of Yorktown as tax ID 37.14-2-33; and

WHEREAS, the Town of Yorktown Town Board, desiring to investigate and understand the cumulative impacts of the proposed uses, planning and layout characteristics, architectural considerations, traffic impacts, inter alia, and to identify appropriate mitigation measures, wishes to study the properties together and produce a targeted limited master plan for both properties; now

THEREFORE BE IT RESOLVED, that the Town of Yorktown Town Board authorizes the Yorktown Planning Department to coordinate the respective petitioners and their professional representatives in cooperation toward producing a targeted limited master plan, and further authorizes the Planning Department to produce any necessary technical material required for completion of same; and

BE IT FURTHER RESOLVED, that no funds for outside consultants are authorized by this resolution, and any necessary service identified by the Planning Department that is required to complete the said master plan shall be reviewed and authorized by the Town Board prior to any service being rendered.

Councilman Diana suggested that since the Weyant property has been a project in existence for a year, it does not seem fair to hold up their process for the sake of the Roma building. They are two separate properties of two different zones. He would like to have Mr. DeVito back in at a work session to go over his plan of what he wants to do – he was looking to find an answer before he moved on pursuing his project. To lump these two projects together at this time is not a good idea. He would like the Board to be able to give Mr. DeVito an idea of how the Board feels about his project at a work session so that he can move on to holding a neighborhood meeting with the residents in the area. Councilwoman Roker said that she would like to see this done and according to the Planning Department, this will not be a yearlong study. She would like to see what effects these buildings would have on the community behind them. Councilman Diana said that he doesn't give much credence to what the Roma building owners want to do and that is why it doesn't seem fair to hold up the Weyant owners. Mr. DeVito is now proposing a much lesser scale than what he originally proposed. Councilman Patel believes it should be discussed with the Board again. Councilman Lachterman said that he spoke with Ms. Lee, who represents the builders for the Roma Building, and asked what it is that really works for them. She replied that they don't know yet, because they haven't looked at the numbers. He just feels that they do not really know what they want and to hold up the Weyant project doesn't seem fair. Ms. Roker agreed to bring Mr. DeVito back and is willing to table the resolution.

EXECUTIVE SESSION

Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved into Executive Session to discuss contract negotiations and legal matters. Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved out of Executive Session and adjourned the meeting.
