#### TOWN BOARD MEETING

Supervisor Matthew Slater called the meeting to order.

#### **EXECUTIVE SESSION**

Upon motion made by Councilperson Lachterman, seconded by Councilperson Diana, the Town Board moved into Executive Session to discuss the employment of a particular person. Upon motion made by Councilperson Roker, seconded by Councilperson Patel, the Town Board moved out of Executive Session and proceeded with the meeting.

### PLEDGE OF ALLEGIANCE

Supervisor Slater led the Pledge of Allegiance.

#### MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

### SUPERVISOR MATTHEW SLATER'S REPORT TO THE TOWN

Supervisor Slater announced the publication of the most current Refuse and Recycling Department schedule, which highlighted a residential E-Waste Day, Car Tires (\$5.00), and Textile Collection from 7:30 A.M. to 2:30 P.M. on Friday, February 28<sup>th</sup>. Supervisor Slater announced that any resident who has used motor oil can bring to the Yorktown Highway Garage or the Central Garage between the hours of 7:00 A.M. and 2:00 P.M., Monday through Friday. The used motor oil is used to heat both of the garages. Supervisor Slater thanked the Refuse and Recycling Department for their litter clean up in certain areas of Town.

Supervisor Slater mentioned that steps at the Albert A. Capellini Community and Cultural Center continue to be worked on. He thanked the Building and Maintenance staff as well as the Landmarks Preservation Commission and the Planning Department who are working on the repair.

Supervisor Slater said the Water Department responded to a water main break at Windmill and Broadview last week. He said they did an incredible job on the repair. Water bills have been sent out and may be paid online using the Town's website. Supervisor Slater said he received a letter from residents at Jefferson Village recognizing Kathleen Romanich from the Water Department who saved them over \$500 in their water bills.

Supervisor Slater announced there are some board openings and they are looking for some volunteers to help fill these spots. The openings are as follows: Zoning Board, Conservation Board (3 openings), Parks and Recreation (2 openings).

Supervisor Slater reminded everyone of the program at White Oak Farm this coming weekend when they will be tree tapping for maple syrup.

Supervisor Slater recognized Lieutenant Thomas Gentner for thirty-nine years of service at the Yorktown Police Department and the Yorktown community.

Supervisor Slater said that this past Saturday he was joined by Highway Superintendent David Paganelli and Chief of Police Robert Noble, as well as the Mohegan Volunteer Fire Association to recognize Russ Campbell who has been serving the fire association for fifty years.

Supervisor Slater said that last night he joined the Yorktown Volunteer Ambulance Corps when they reelected their officers at their monthly meeting. The Ambulance Corps shared some of their statistics: January total calls – 125, medical emergencies – 97 calls, ALS (Advanced Life Support) – 30 calls, BLS (Basic Life Support) – 63 calls, number of patients transported – 93, loaded miles – 907.4, total hours - 919. Supervisor Slater thanked them all for their volunteer service.

#### REPORTS FROM THE TOWN COUNCIL

Councilperson Patel announced his attendance at the Association of Towns meeting held in New York City.

Councilperson Roker commented a vote that was taken in her absence at a past meeting. She said that there is no statutory law that prohibits a town board from voting on someone who will go beyond the supervisor's term of office. There are a couple of common law cases, which may be similar but not the same. She said she asked the Town and City Clerks Association of Westchester if they were aware of this practice and she was told no. Councilperson Roker said she looked at past minutes of December 2017 where the Town Board accepted the resignation of a Parks & Recreation Commission member whose term of office was ending on December 31, 2019 and appointed someone to the Parks & Recreation Commission for seven years – the same thing that the Board said we should not have done. Councilperson Roker said that when "re-upping" someone for a volunteer board, she likes to look at their body of work. She said that when Diana Quast was first appointed to the Commission she worked with "skateboard moms" and worked with the County and County Legislator Michael Kaplowitz to obtain funding for the skateboard park. Councilperson Roker said Mrs. Quast then went on to work on the dog park in Yorktown. She said she would not go through everything that Mrs. Quast has done for the Commission; she just wanted to explain why her vote would be against what had been done, particularly after looking at the December 2017 minutes, which was two weeks before a new supervisor had taken over.

Councilperson Diana wished Lieutenant Gentner all the best in his retirement and mentioned his long history of knowing him. He said the previously mentioned water main break was particularly troublesome because it was transite pipe and the Department of Health imposes additional testing necessary when repairing transite pipe because of its construction. Councilperson Diana explained that this is a reason that there may be a delay in turning water back on.

Councilperson Lachterman reminded everyone that the Senior Advisory Committee is meeting this Friday, February 21 at 1:00 P.M. in Town Hall. The first meeting of the Veterans Advisory Board will occur on February 26 at 7:00 P.M. in the AACCCC in Room 16. Councilperson Lachterman said the Congressional Census is not the same as the federal census that will be coming out in March. He said it is very important that all residents participate in the federal census. He recognized Police Dispatcher Beth Sherwood for helping a resident who had a power outage. He mentioned ribbon-cuttings that occurred over the last week: All Seasons Wine and Spirits and Lala's Exotic Cuts. Councilperson Lachterman said coming up shortly will be the new virtual reality studio, Imagine VR Studio, opening at the Jefferson Valley Mall on March 8, 12:00 P.M. to 3:00 P.M., which will also be a fundraiser for the Alliance for Safe Kids.

Councilperson Patel said that today Senator Chuck Schumer, the NYS Deputy Governor, and members of the Association of Towns announced how important it is to be counted in the upcoming census. He said that in order to apply for the money that belongs to us, we need to be counted.

### **POET LAUREATE**

### PRESENTATION BY YORKTOWN POLICE DEPARTMENT

Chief Robert Noble thanked the Board for their best wishes on Lieutenant Thomas Gentner's retirement after nearly 40 years working for the Yorktown Police Department.

Chief Noble announced the Spring and Fall 2019 Yorktown Police Department Awards to the following:

Police Officer James Hannigan for his involvement in the graffiti investigation that Yorktown and surrounding communities were experiencing. Officer Hannigan was awarded the Excellent Police Duty certificate.

Chief Noble presented the following Civilian Certificate of Appreciation Awards for those who provided assistance to the Yorktown Police Department:

Branch Manager Leslie Dellipaoli of the Putnam County Savings Bank (PCSB) in Jefferson Valley, along with employees Ann Walter, Christina Tosito, for bringing to light a scam that came to their attention involving a local customer. Their actions prevented a customer from losing a life savings of approximately \$26,000. Ms. Dellipaoli said this was an excellent and reminder for them, as bankers, of their responsibility to truly know their customers and their normal banking activity.

Dr. Christian Russo and Patty Abroscado of Family Chiropractic and Injury in Shrub Oak for offering their services to provide free orthotic fittings to members of the Yorktown Police Department. Dr. Russo and Ms. Abroscado took time out of the practice to accommodate the various shifts of the police department. Dr. Russo thanked Chief Noble for the recognition and the police department for the opportunity and for their service.

Mrs. Karan Moseman, whose husband, Charlie Moseman, is a 60-year veteran of the Yorktown Fire Department, received a Certificate of Appreciation for her thoughtfulness over nearly thirty years in providing the police department with homemade cakes and baked goods. Mrs. Moseman thanked Chief Noble and said how much she enjoys baking.

Supervisor Slater and the Town Board accepted the retirement of Lieutenant Thomas Gentner from the Yorktown Police Department effective February 14, 2020, ending a 39-year career with the police department.

WHEREAS, the Town of Yorktown is focused on becoming Westchester County's fourth certified Climate Smart Community; and

WHEREAS, a requirement to achieving certification is forming a Climate Smart Communities Task Force; and

WHEREAS, the Town of Yorktown established the formation of the Climate Smart Communities Task Force at a Town Board meeting on January  $7^{th}$ ; and

WHEREAS, the Task Force is charged with developing a strategy and work plan for establishing a baseline for the Town's current emissions, for recommending reduction targets, for identifying new strategies for reductions and energy efficiency, and for recommending ways in which these strategies can be incorporated into the Town's economic development and planning efforts;

NOW THEREFORE BE IT RESOLVED, that Greg Brown, Keith Holmes, Paul Moskowitz, Sarah Wilson and Swarnav Pujari are hereby appointed to the Climate Smart Communities Task Force; and

BE IT FURTHER RESOLVED, that their terms shall end on December 31, 2021; and

BE IT FURTHER RESOLVED, that Swarnav Pujari is hereby appointed Chairman of the Climate Smart Communities Task Force with the term of said leadership post ending on December 31, 2021.

Upon motion made by Councilperson Lachterman, seconded by Councilperson Diana,

Be It Resolved, that Jennifer M. Leonard of Jefferson Valley, NY, is hereby appointed as an Intermediate Clerk, job class code 0187-01, from Eligible List No. 02-100, effective February 19<sup>th</sup>,

2020, in the Building Department, to be paid from Yorktown CSEA Salary Schedule A-1, Group 3, Step 2, which is \$43,790.00 annually,

Be It Further Resolved, that this appointment is subject to a probationary period of not less than 12 nor more than 52 weeks, commencing on the first date of appointment on February 19<sup>th</sup>, 2020.

### DURING COURTESY OF THE FLOOR, the following people spoke,

Mr. Jay Kopstein, resident, said he had questions regarding CapturePoint – the system for the Community Pass program being used by Parks and Recreation – and the method of data storage. Where are the servers and the backups? How are addresses verified? What kind of encryption is being used and is there a VPN? Will the Town have to pay for an additional ISP address or will the Town ISP be used? Will there be a service/convenience fee for credit card use?

Mrs. Marcia Stone, resident, came to speak of what she considered a partisan removal of Diana Quast from the Parks and Recreation Commission. She voiced concerns that she and members of the community have regarding the appointment of alternate member, Rick Romanski, as Mrs. Quast's replacement. Mrs. Stone raised a conflict of interest issue with this appointment and Mr. Romanski's for-profit business. She said the Board should not consider reducing or eliminating fees for use of facilities and/or equipment for sports groups.

Mr. Dan Strauss, resident, asked if there is a conflict of interest with Mr. Romanski, why was he appointed as an alternate in the first place. He said he heard it was a political payback. Mr. Strauss also said he does not think the Town needs a branding campaign. Mr. Strauss also raised the issue of residents illegally parking in fire zones and the lack of enforcement.

Ms. Phyllis Schraer, resident, stated her support of Diana Quast, a fourteen-year member of the Parks & Recreation Commission whose appointment was rescinded. She stated that Mrs. Quast was replaced with a Republican who appears to have financial ties to the fields. She said that the woman whose position was renewed has since decided to retire and now there are no women on the Commission. Ms. Schraer also said that there is still an elected official on the Commission, even though this has been raised as problematic to the Board. She said this was a partisan decision, which has now created an imbalance on the Commission.

Ms. Fran DiBernardo, resident, opposed the removal of Diana Quast from the Parks & Recreation Commission. She said there was no real justification for her removal and asked what do the Town Board and the Parks & Recreation Commission hope to accomplish by this removal that could not have been accomplished before. Ms. DiBernardo said there is no real, clear direction. She said the attempts to justify Mrs. Quast's removal were unbelievable and inadequate. She said the Commission now has zero diversity and too many members, who represent sports only. Ms. DiBernardo said Mrs. Quast brought both the skate park and the dog park to Yorktown that represents other uses of our recreational spaces in Town.

Ms. Louise DeMarco, resident, asked about the current status of the Diversified Properties project (Summit Hill) at Route 6N and Hill Boulevard. She said she was told by Mr. Esposito, President of the Chamber of Commerce, had been in direct contact with Diversified Properties and who told him they were definitely going to pursue the project. She would like to know their current status.

Mr. Brian Silik, resident, also spoke of the Diversified Properties project and wanted to know the status of the traffic study that was supposed to be done in the area.

Ms. Grace Capperino, resident, protested the removal of Diana Quast from the Parks & Recreation Commission. She believes that it was a partisan decision and that there is no ethical or statutory reason for her removal.

Mr. John Flynn, resident, said he served on the Planning Board for several years and worked with Diana Quast and the Parks & Recreation Commission. He complimented her performance on the Commission, stating that she was excellent at program management, strategy, handling financial questions, consensus building, etc. He said she was also consistently present at meetings. Mr. Flynn said he was very troubled by the Town Board's decision. He said Mrs. Quast is exactly what the Town needs in a board volunteer. He, too, feels this was a partisan decision.

Mr. Paul Jeffries, resident, voiced his concern over Diana Quast's removal from the Parks & Recreation Commission. He said she has produced a lot for the Town, including receiving grants for parks and recreation purposes. Mr. Jeffries asked what does the Board and/or Mrs. Quast's replacement plan to do that is at least up to the same level of accomplishment and commitment as Mrs. Quast had in her role as volunteer.

Mr. Marc Lieberman, resident, also mentioned Mrs. Quast's accomplishments: Patriot Skate Park, Sylvan Glen Dog Park, Holiday Electric Light Parade, receiving grant money for a playground for children of all abilities at Granite Knolls. Mr. Lieberman felt a partisan decision was made by the Board. Mr. Lieberman presented Mrs. Quast with a Certificate of Appreciation from many Yorktown residents.

Mr. John McMullen, resident, said the proposed development by Diversified Properties is not on Route 6N, but actually East Main Street. He said the addition of the 150 units would put demands on this road which do not now exist.

Ms. Susan Siegel, resident, asked how the rescinding resolution on the agenda this evening would affect the timeframe of the repair of the Mohegan Avenue Retaining Wall.

Mr. Sergio Esposito, President of the Chamber of Commerce, said that the Town should not be charging fees to any of the sports organizations in Town since they provide a service to the Town and to the children. He doubted that the Town would want to take on this responsibility. Mr. Esposito said that Mr. Romanski, as member of the Parks & Recreation Commission, will bring valuable insight to the Commission. Mr. Esposito suggested that Mr. Romanski might want to recuse himself from any vote that involves fees to sports organizations. He went on to say that they have not heard from Diversified Properties, as yet.

Upon motion made by Councilperson Diana, seconded by Councilperson Roker, Courtesy of the Floor was closed.

Supervisor Slater (responding to Ms. Siegel) said the material replacement study is not due until next week. In the meantime, the RFP will be going out within the week and will not affect the timeframe for the project. The RFP is for project oversight only – not the project itself.

Councilperson Roker asked Planning Director John Tegeder to respond to Mr. Silik's comments about the traffic study that was to be done for the Diversified Properties project. Mr. Tegeder said their application has been inactive since last summer – there has been virtually no activity whatsoever.

Supervisor Slater said the Town's Ethics Code (Section 45-5) dictates that if there is a conflict of interest, voting members must recuse themselves.

Councilperson Diana stated his position on the idea of a partisan vote on the Parks & Recreation Commission. He said an elected official and/or department head should not be on a board and voted as such. Councilperson Lachterman said when this situation arose at the end of last year, he asked former Supervisor Gilbert not to hold a vote until he was present and that it needed further discussion. He said he would like to see a parent of a special needs child to sit on the Commission. Councilperson Roker said that a law should be proposed to make the changes that both Councilpersons Diana and Lachterman would like to see.

Supervisor Slater said that they are working with the Parks & Recreation Department and Commission to recognize both Mrs. Quast's and Mrs. Caporale's accomplishments.

Councilperson Diana agreed with Mr. Strauss' observation of parking in fire zones.

Parks & Recreation Superintendent Jim Martorano addressed Mr. Kopstein's concerns regarding CapturePoint. There are only two major companies that are providing this type of service and CapturePoint is by far the best program for Yorktown. The issue of residents with unclear residency can be inputted directly to clear up any ambiguity. Mr. Martorano said CapturePoint is a PCI-compliant company with Security Standards Council; they use a rock-solid data center called Equinix and use Amazon Web Services Cloud that does not store credit card data. He said that this a user-populated data, so if you are not comfortable putting something into their system, you do not have to – you can do it in person at Parks & Recreation. Supervisor Slater emphasized that the Town is not mandating online registration; you can still go into the Parks & Recreation office to register for programs.

Mr. Martorano said there is not a separate convenience charge it is built in to the fee, regardless of method of payment. A discussion took place about possibly discounting cash payments.

WHEREAS, Black History Month gives our community time to reflect on the struggles and triumphs of African-Americans throughout our national society; and

WHEREAS, African-Americans have made invaluable contributions to the American cause, including protecting our liberties and democratic society; and

WHEREAS, the Town of Yorktown acknowledges and applauds the many contributions that African-American members of society have made including but not limited to John Sweat Rock, Frederick Douglass, W. E. B. Du Bois, Martin Luther King Jr., Thurgood Marshall, Duke Ellington, Maya Angelou, Guion Bluford, and Jackie Robinson; and

WHEREAS, the Yorktown Historical Society will present an educational program titled "New York's African Heritage" at the John C. Hart Memorial Library on Thursday, February 20, 2020 in recognition of Black History Month;

NOW THEREFORE BE IT RESOLVED, that the Town of Yorktown recognizes February as Black History Month; and

BE IT FURTHER RESOLVED, the Town of Yorktown stands as a community of hope, generosity and acceptance to everyone, regardless of religion, race, national origin, ethnicity, culture or orientation.

NOW, THEREFORE BE IT RESOLVED, that the Town of Yorktown recognizes cultural heritage tourism as one of the primary strategic drivers to leverage and use our historic assets for community revitalization and enhancing our quality of life.

# CREATE THE YORKTOWN 250 COMMITTEE TO COMMEMORATE THE 250<sup>TH</sup> ANNIVERSARY OF OUR NATION IN CONJUNCTION WITH STATE, REGIONAL, COUNTY AND LOCAL INITIATIVES

#### **RESOLUTION #67**

Upon motion made by Councilperson Lachterman, seconded by Councilperson Diana,

WHEREAS, the United States Congress has established the United States Semiquincentennial Act of 2016, Public Law 114-196, finding that July 4, 2026, the 250<sup>th</sup> anniversary of the founding of the United States, as marked by the Declaration of Independence in 1776, and the historic events preceding that anniversary are 1) of major significance in the development of the national heritage of the United States of individual liberty, representative government, and the attainment of equal and inalienable rights, and 2) have had a profound influence throughout the world; and

WHEREAS, the purpose of this Act is to establish a Commission to provide for the observance and commemoration of the 250<sup>th</sup> anniversary of the founding of the United States and related events through local, State, national and international activities planned, encouraged, developed and coordinated by a national commission representative of appropriate public and private authorities and organizations; and

WHEREAS, the Office of the New York State Historian, is supportive of the observance and commemoration of the 250th anniversary, has held regional meetings across the State, and is establishing a revolutionary NY250 website which will act as a place for information exchange, to upload Revolutionary NY250 events and appoint a New York State Historian's Revolutionary NY250 Advisory Group; and

WHEREAS, the County of Westchester, including the Department of Tourism and the Office of the County Executive, is working in coordination and in support of Revolutionary Westchester 250 Inc. to help build awareness and excitement for the events, places, ideals and people—both unsung and famous—of the Revolutionary War period in Westchester County; and

WHEREAS, the Westchester County Historical Society is supportive of the work of Revolutionary Westchester 250 and the State, regional and federal initiatives to commemorate the 250<sup>th</sup> anniversary, and;

WHEREAS, the Town of Yorktown would like to establish a local organization, called the Yorktown 250 Committee, to commemorate our local history in conjunction with the history of the U.S., New York State and Westchester County; and work in coordination with the federal, State, regional and county initiatives; and

WHEREAS, heritage is all the things that make up our story, tangible and intangible, and as we value them, we must protect them;

NOW, THEREFORE BE IT RESOLVED, that the Town of Yorktown creates the Yorktown 250 Committee as a subcommittee of the Yorktown Landmark Preservation Commission, to commemorate the 250<sup>th</sup> anniversary of our Nation in conjunction with State, regional, county and local Initiatives;
