RESOLUTIONS to be passed tonight, April 14th, 2020

RESOLVED, that the Supervisor is authorized to sign an agreement with Laberge Group for the preparation of a Funding Needs Assessment in an amount not to exceed \$5,000.

WHEREAS,

- 1. The Applicant, PCSB Bank, recently completed construction of the PSCB Bank Project located at 1990 Commerce Street. There was a Stormwater Pollution Prevention Plan (SWPPP) in place to manage stormwater during the various construction activities. As part of the SWPPP, the Applicant was also required to implement post-construction stormwater collection and treatment devices. The Town wishes to execute a Stormwater Maintenance Agreement to memorialize the responsibilities of the Applicant for long term inspection and maintenance of these devices.
- 2. One of the requirements of the Stormwater Maintenance Agreement is for the Applicant to file an annual compliance report with the Engineering Department. The Town needs to track these measures as one of the conditions of our MS4 Town-wide Stormwater Management Program.
- 3. The agreement will be subject to the review and approval of the Town Attorney.

NOW, THERFORE BE IT RESOLVED, the Town Board authorizes the Town Supervisor to sign a Stormwater Maintenance Agreement with PSCB Bank located at 1990 Commerce Street.

Authorize Town Clerk to advertise bid for John Deere OEM Parts for the Highway Department.

Authorize Town Clerk to advertise bid for Cummins OEM Parts for the Highway Department.
