### Authorize Supervisor to Execute Agreement with Sustainable Westchester

RESOLVED, that the supervisor is authorized to execute an agreement with Sustainable Westchester for a joint campaign of community solar outreach. The term of the agreement will be August 1, 2020 through December 31, 2021.

## Authorize Library Director to Sign Agreement with D.P. Wolff Inc. for HVAC Service and Maintenance

RESOLVED, that the Town's Library Director is authorized to sign an agreement with D.P. Wolff Inc. for the provision of HVAC service and maintenance in an amount not to exceed \$1,835 for services rendered. The term of the agreement will be August 1, 2020 through July 31, 2021.

Be it Further Resolved, that upon the recommendation of the Highway Superintendent, Dave Paganelli, the bid for the Asphaltic Laid-in-Place "MILLING" Section of the bid be and is hereby awarded to Intercounty Paving Company, Inc. PO Box 360, Carmel, New York 10512, now

Be it Further, Further Resolved, the contract is to begin on August 1, 2020 and terminates on July 31, 2021. The Town shall have the option to extend this contract at the same price for (3) consecutive times, for a total of four (4) years through July 31, 2024.
