Supervisor Grace would like to have the Assessor figure out what the fair market value of this small piece of town-owned property would be before making a decision on this issue.

<u>HIGHWAY DEPARTMENT</u>

Highway Superintendent Dave Paganelli spoke to the Town Board about Highway Department staffing, street lights at Jefferson Valley and Freedom Gardens (Strawberry Road).

Mr. Michael Dubovsky, (Electrician for Street Light Maintenance) stated that the cost to put street lights at East Main Street, Jefferson Valley would be approximately \$9,650.00 and Foothill Street, Shrub Oak approximately \$1,800.00. The Town Board agreed to place this on the next agenda.

PROCEDURES FOR TOWN BOARD MEETINGS

Councilman Siegel stated that she would like to establish guidelines for Courtesy of the Floor. She would also like to see the second Courtesy of the Floor put back on the agenda.

Supervisor Grace stated that he likes an open dialogue with residents of the community, is flexible with the three minute rule and does not feel that a second Courtesy of the Floor is needed. Supervisor Grace stated that he will not tolerate discourteous comments being made during Courtesy of the Floor towards anyone including disrespectful comments made to Town Board members.

Councilman Patel stated that the same time should be given to all people that speak during Courtesy of the Floor.

Supervisor Grace stated that Courtesy of the Floor should not be used for political speeches and should be cut off.

Councilwoman Siegel stated that there should be a time limit because the Town Board has business to attend to.

Councilman Patel stated that the time should be equal to all.

Supervisor Grace stated that Courtesy of the Floor should only be done at Work Sessions because they are not televised. He further stated that he will review these guidelines at a later date.

HUNTERBROOK SEWER DISTRICT #20

Acting Town Engineer Sharon Robinson stated that this is a no cost district which will include 20 or so parcels and COSTCO, she is working with Bond Counsel Tom Myers and would like the Town Board to pass a resolution asking the Westchester County Board of Legislators to include them in the Sewer District. The Town Board agreed to place this on the January 20, 2015 agenda.

Acting Town Engineer Sharon Robinson stated that she will be doing an RFP (Request for Proposals) for the renovation of the pump stations. She asked if she can just send them out. Supervisor Grace stated yes.

1805 EAST MAIN STREET – REZONING OF PROPERTY RESOLUTION #33
