TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order

PLEDGE OF ALLEGIANCE

Supervisor Grace led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

<u>DURING REPORTS FROM TOWN SUPERVISOR</u>, Supervisor Michael Grace spoke about the Alliance for Save Kids (ASK) which hosted a recent forum called Save A life. He noted that it was an excellent event.

<u>DURING REPORTS FROM TOWN COUNCIL</u>, Councilman Patel stated he attended the ASK Event, an Eagle Scout Ceremony and the Association of Towns meeting being held in New York City.

Councilwoman Siegel spoke about the Spectra Pipeline comments that the Town's Environmental Consultant is preparing for the Town to submit to the NYC DEP by the end of the month. REPORTS FROM WESTCHESTER COUNTY, Westchester County Board of Legislator Chair Michael Kaplowitz was present to update the Town Board on many issues that the Westchester County Legislators are working on. He stated that Comptroller Caporale very ably described the Tax Freeze Program and by joining with the County the Town can take advantage of NYS rebates and incentives. He also updated the Town Board on the CDBG monies which 5 million dollars was recently released, these monies will now be handled on a Federal level. He encouraged the Town to apply for this funding.
