2015 BUDGET HEARING

Supervisor Grace called to order a public hearing to consider the preliminary budget of the Town of Yorktown, Westchester County, NY for the fiscal year beginning January 1st, 2016. Affidavits of Posting and Publication were presented by the Town Clerk.

Supervisor Grace provided an overview of the budget process. He spoke about differences between the Tentative Budget and the Preliminary Budget and commended all of the department heads for their hard work.

Councilwoman Siegel announced that if anyone wanted to call into ask a question about the budget they can dial 962-5722, extension 216.

Councilman Patel thanked everyone for coming to the budget hearing.

Mr. Don Roberts stated that the Town needs a policy on how to deal with Fund Balances. He noted that the Town makes contributions to the athletic clubs and asked if the books for the clubs have been reviewed by the Town.

Supervisor Grace stated that this is his fourth budget and there continues to be better level of services with each one. Municipal financing is about projecting for the future. Budgeting is done every week not just once a year and every department in the Town has been asked to do more with less and he thanked the department heads for all their hard work.

Councilman Bernard stated that the Supervisor did a great job on the budget. Every department is understaffed and have done an excellent job working efficiently.

Supervisor Grace read questions received from Mr. Howard Frank. He stated that the Yorktown Stage tenant pays for all the repairs to the theatre and that the Town received more monies from FEMA than anticipated.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was closed. Councilman Bernard motioned, seconded by Councilman Diana.

RESOLVED, that the Town Board of the Town of Yorktown does hereby adopt such preliminary budget and be it

FURTHER RESOLVED, that the said preliminary budget as adopted by this resolution be entered in detail in the minutes of the proceedings of this Town Board and it shall be known as the Annual Budget of the Town of Yorktown for the fiscal year beginning on the 1st day of January, 2016, and be it

FURTHER RESOLVED, that the several sums estimated for expenditures in the same annual budget as adopted are hereby appropriated in the amounts for the purposes therein specified, and be it

FURTHER RESOLVED, that the several sums therein estimated as anticipated revenues and the monies necessary to be raised by tax and assessments in addition thereto, to pay the expenses of conducting the business of the Town for the purposes contemplated by the Town Law and otherwise by law, shall be and become applicable in the amounts therein named for the purposes of meeting such appropriations. FURTHER NOTICE IS HEREBY GIVEN pursuant to Section 108 of the Town Law that the following are adopted yearly salaries of Town Officers of this Town, to wit:
