The Sewer Department obtained quotes for the following scope of work: (1) furnish and install approximately 60 linear feet of 10-inch sewer piping; (2) New piping to be ductile iron, class 52; (3) pipe connections to be made with 10-inch Hydromax couplings; (4) includes road excavation and restoration of asphalt paving.

All work to be done with prevailing wage rates, certified payroll required.

Quotes were received from three (3) firms:

- 2. \$25,740 from Con-Tech Construction Technology, Inc., Yorktown Heights, NY
