Authorize Conference Attendance for Karren Perez, Section 8 Program Director

WHEREAS, the Housing Choice Voucher Program (Section 8) Program utilizes HAPPY as its software vendor and upgraded to its HAPPY Housing Pro 9 in 2015, and

WHEREAS, training continues to be required for this new software application, the Section 8 Program Director requests the Town Board's approval to attend the 2017 Users' Training Conference for this purpose, NOW THEREFORE BE IT
