Authorize the Supervisor to execute an agreement with the County of Westchester for the Town to provide transportation services

RESOLVED, the Supervisor is authorized to execute and agreement with the County of Westchester for the Town to provide transportation services to the elderly for \$4,782, for the term retroactive to April 1, 2021 through September 30, 2024. The Town will be required to contribute \$531 to the program.

Authorize the comptroller to process the following budget transfer
