TOWN BOARD MEETING

Supervisor Thomas Diana called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Esposito, seconded by Councilman Lachterman, the Town Board moved into Executive Session to discuss personnel items and/or litigation matters with legal counsel. Upon motion made by Councilman Lachterman, seconded by Councilman Esposito, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Councilman Esposito led the Pledge of Allegiance.

MOMENT OF SILENCE

Supervisor Diana asked for a moment of silence to remember all of our first responders who serve us on a daily basis, as well as the men and women of our Armed Forces, who protect our freedoms every day.

INTRODUCTIONS

Members of the Town Board introduced themselves, along with Town Clerk Diana Quast and Town Attorney Adam Rodriguez.

REPORT FROM TOWN SUPERVISOR

Supervisor Diana reported on recent events, including the following:

- Teatown Preservation's "Night in the Woods" Awards Dinner held at Lyndhurst in Tarrytown
- October is Breast Cancer Awareness month
- A new tree will be planted at the J.C. Hart Memorial Library next week to replace the diseased evergreen that was there. This tree will be used for the Annual Christmas Tree Lighting.
- Yorktown Chamber of Commerce Fall Festival will be held this coming Sunday, 11:00 am to 5:00 pm at the Jefferson Valley Mall.

NOW, THEREFORE, BE IT RESOLVED, the Town of Yorktown declares October as National Domestic Violence Awareness and Prevention Month.

Be It Resolved, that Nicholas Fasce of Yorktown Heights, New York, is hereby appointed Automotive Mechanic, job class code 0481-02, effective October 4, 2023 to be paid from Yorktown CSEA Salary Schedule A, Group 12, Step 1, which is \$65,995.00 annually with benefits such as sick days, personal days, and floating holidays to follow the CSEA agreement;

POET LAUREATE

John McMullen, Poet Laureate, read his original poem, "Ted."

OPEN FLOOR FOR PUBLIC COMMENT

The following members of the public spoke:

- John McMullen, resident, recommended and requested that the Town Board send a letter of commendation and appreciation to Congressman Michael Lawlor to be one of the first people to be against the shutdown of the government. Mr. McMullen said that Congressman Lawlor joined the coalition of 32 Democrats and 33 Republicans to come up with an alternate plan.
- Jay Kopstein, resident, spoke about the September 26, 2023 Town Board Work Session presentation to rezone a non-residential property to a multi-family residential property on the east end of the Route 6 corridor. Mr. Kopstein said that this application should be denied for the foreseeable future. He said that there are significant residential projects on the Route 6 and Route 202 corridors. Mr. Kopstein said that the actual infrastructure and school district requirements of these projects are unknown. He said that before any rezoning to residential use is considered, the Town should use the consultants hired by the Town and paid for by the applicant to examine prospective sewage flow, sewage infrastructure, sewage treatment plant capacity, the ability for Yorktown to increase its sewage flow, the fiscal impact on the sewer district, potable water usage, NWJWW's plant capacity, physical impact on the water district, additional students, student district capacity, fiscal impact on the school district, a traffic study to determine traffic flow, highway infrastructure, fiscal impact on the Highway Department, and the fiscal impact to the balance of Town departments and other districts, such as fire and EMS. Until these studies are conducted, analyzed, and reviewed, Mr. Kopstein said this application should be denied.
- Jann Mirchandani, resident and candidate for Town Supervisor, read a letter from David Rinaldi who could not attend the meeting. Mr. Rinaldi wrote that many residents of Yorktown

have been doubled taxed for many years and nothing has been done to rectify the situation. He wrote that the Town bundles library taxes into its annual tax collection; the Croton and Ossining school districts bundle library taxes with school taxes. Residents near Croton and Ossining pay library taxes to both Yorktown and to Croton and Ossining. Many Yorktown homes are in the Croton and Ossining school districts but are within Yorktown's taxing jurisdiction; these homes have been paying double taxes for decades and nothing has been done to rectify this issue. Ms. Mirchandani asked the Town Board if they were aware of this issue and would they be able to fix this before the tax bills are mailed. She asked if residents would be paid back the difference of what they have been overcharged and how this would impact the budget.

- Susan Siegel, resident, asked the Board to clarify a statement made at the previous regular meeting regarding the fluoridation and NWJWW. She said that we get our water through the Joint Waterworks, a multi-town entity, but the fluoridation system is only for Yorktown water. The cost for the new building for the fluoridation, construction costs, and the work that had to be done to correct problems that were caused by NWJWW staff, and all of the chemicals are paid for by the Yorktown Water District. The work may be done by NWJWW and they operate the system for us and Yorktown is billed for it. Ms. Siegel said it was stated at the previous meeting that this was a NWJWW's responsibility and, yes, they physically do the work but we pay the bills.
- Dan Strauss, resident, spoke about Yorktown being a great event town. He thanked his next-door neighbor for helping him to clean up litter in Town. Mr. Strauss said he was puzzled by the presentation last week for the rezoning application Mr. Kopstein spoke about and was surprised no one raised the effect it would have on the school district since this is not an age-restricted development. Mr. Strauss also spoke about the eBike and ATV issues in Town and asked if there is progress on changing the law.
- Geri Schwalb, resident, thanked the Town Board for the work on the Police Department and Court House plaza.
- Anthony Pichette, resident, spoke about the Yorktown Community Nursery School, which his youngest child is attending.
- Brian Rafael, resident, suggested to the Board that they contact NYS regarding ATV use. He said that during the winter they open FDR Park to snowmobiling and maybe they would consider ATV use. He once again raised the issue of the Town cleaning streams so that when it rains, less flooding would occur. Mr. Rafael asked about CSEA job postings; his understanding is that these postings are supposed to be up for two weeks and does not think that this is being followed and this does not give everyone a chance to apply.
- John Campobasso, resident, thanked the Town Board for all of the information during the recent rainstorm. He asked everyone to remember the first responders who head out into these storms while we are heading home. Mr. Campobasso thanked the Town Board for the proclamations recently given to the children of Town for their sports participation; he said that they mean so much.

Upon motion made by Councilman Lachterman, seconded by Councilman Esposito, Open Floor for Public Comment was closed.

Members of the Town Board responded to comments made during Open Floor for Public Comment:

Supervisor Diana spoke about how important it is to recognize the children in Town and their accomplishments. He thanked Mr. Campobasso for all of his volunteer work with the Town's sports programs. Supervisor Diana also thanked Mr. Strauss for his working cleaning up the Town's litter.

Supervisor Diana corrected Mr. Rafael's statement about CSEA job postings by stating that job postings can be posted for any amount of time that is determined. He said that the Town and the state have been out cleaning out culverts and streams and said that there is not much more they can do. He said he and the Town Engineer have been looking at some of the flooding issues in other parts of the Town. Supervisor Diana said that the Department of Health would be doing their testing at the NWJWW this Friday. Supervisor Diana said he would look into the double tax issue raised in Mr. Rinaldi's letter; he said he was not aware of this.

Councilman Lachterman said the Town Attorney is currently working on amending the law to address the ATV law. He mentioned that enforcement needed to be particularly addressed. Town Attorney Adam Rodriguez said that he has been meeting with various interested parties – Police, Parks & Recreation, etc. – and other town codes. He said it would probably take a few more weeks before

changes could be brought to the Town Board. Councilman Lachterman said the rezoning application definitely needs to be researched and what was presented was a broad overview of the project.

Councilman Esposito agreed with Mr. McMullen's request regarding Congressman Lawlor. Councilman Esposito said that the Fire Department and EMS needed to be considered when considering the rezoning application. He also addressed Mr. Rafael's comments about the flooding of the streams. He spoke about the work he had done with utilities and DOT regarding some of the issues as well as plans for future meetings with involved parties. Councilman Esposito said the addition of sewers on Route 6N as a condition of the rezoning application that was presented would help the flooding situation in the area.

Councilwoman Haughwout said that she would look into Mr. Rinaldi's issue.

Councilwoman Capoccia said that she would also speak with the Town Assessor regarding Mr. Rinaldi's tax issue.

Councilman Esposito said that they are searching for a permanent solution to the flooding problems and that it is a multi-faceted problem. He said that, yes, it is maintenance and cleaning streams but it is so much more than that because if you follow the streams and culverts, much of the property is not town-owned.
