Meeting of the Town Board, Town of Yorktown held on Tuesday, May 9, 2023 at the Town Hall, 363 Underhill Avenue, Yorktown Heights, New York 10598.

TOWN BOARD MEETING

Supervisor Thomas Diana called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilwoman Capoccia, seconded by Councilwoman Haughwout, the Town Board moved into Executive Session to discuss litigation and negotiations with the Town Attorney. Upon motion made by Councilwoman Capoccia, seconded by Councilwoman Haughwout, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Building Inspector John Landi led the Pledge of Allegiance.

MOMENT OF SILENCE

Supervisor Diana asked for a moment of silence to remember our first responders (EMS, fire, police), and the members of our military who serve to protect our freedoms both here and overseas.

REPORT FROM THE TOWN SUPERVISOR

Supervisor Diana reported on recent Town events and updates, including the following:

- The FamJam Event is coming up this weekend. FamJam supports local charities and attendance is encouraged for all residents and their families.
- "Follow the French: Rochambeau Festival" at the Yorktown Grange Fairgrounds scheduled for Saturday, May 20.

BIRD BUS

Building Inspector John Landi came before the Town Board to request a Temporary Certificate of Occupancy for Bird Bus so that they may open their business and finish their curbing and landscaping. He said the building is ready and is safe. Mr. Landi said his staff has been there throughout the week and everything looks good.

Supervisor Diana said there are some site plan issues that have been discussed and the Town is going to require a \$75,000 cash bond until those issues are resolved. He asked Mr. Landi if everything is safe and working – the sprinklers, the electrical, etc. – and Mr. Landi said everything is good, including the air circulation system.

Councilman Esposito asked Mr. Landi what is left to do and he said that it is mostly the parking lot area – curbing, plantings, etc.

Supervisor Diana said that Planning Director John Tegeder agreed that a \$75,000 cash bond is appropriate for this project.

TEMPORARY CERTIFICATE OF OCCUPANCY FOR BIRD BUS RESOLUTION #237

Upon motion made by Councilman Esposito, seconded by Councilman Lachterman,

WHEREAS, the building permit issued to Bird Bus Company for renovations to an existing automobile dealership located at 3805 Crompond Road, Cortlandt Manor, New York, also known as Section 35.08, Block 1, Lots 21 & 22 on the Town of Yorktown Tax Map, is still open for the following reason: site work items not yet complete (parking lot curbing, landscaping); and

WHEREAS, the Applicant (Bird Bus) is requesting a temporary certificate of occupancy be issued; and

WHEREAS, the Applicant will post a \$75,000 cash bond to serve as a guarantee that all work on the approved site plan will be completed; and

WHEREAS, a temporary certificate of occupancy must be authorized by the Town Board and the necessary steps to issue a temporary certificate of occupancy are described in the Town Code, Chapter 300-1967, Paragraph B;

NOW, THEREFORE, BE IT RESOLVED, the Town Board authorizes the Building Inspector to issue a temporary certificate of occupancy to Bird Bus Company, 3805 Crompond Road, for a period of 180 days.

THE CAPA SPACE

Supervisor Diana introduced Elise Graham and Tim Hartung to speak about The Capa Space. Mr. Capa was a renowned photographer who took wartime photographs.

Mr. Hartung said The Capa Space is located at 2467 Quaker Church Road and it is a photographic exhibition and education space. It is located in an auxiliary building on the Amawalk Friends Meeting House. The exhibition called "This is Robert Capa" opened on April 8. They are open on Thursdays, Fridays, and Sundays from 1:00-5:00 p.m. and on Saturdays from 11:00 a.m.-5:00 p.m. Mr. Hartung gave a brief biography of Mr. Capa and how his burial ended up being in Yorktown.

Ms. Graham spoke about the programs that are a part of the Robert Capa exhibition. She said they are asking veterans if they have any photographs during their time in service that could be submitted as part of the exhibition. She said that more information could be found on their website, www.thecapaspace.org. Ms. Graham said they are working on a theatrical presentation of a play called *George and Ruth: Letters and Songs from the Spanish Civil War*. She gave a brief synopsis of the play. The play dates are June 11 and June 15. She said a program is being led by Rod Whitehead, who is a photography and art teacher in the Ossining High School and is also a veteran. He is getting a group of his students and pairing them with veterans to view the Capa exhibition. The students will then prepare photographic essays and present them to the veterans. A show of these photographs is being planned for November.

Mr. Hartung presented the Town Board with copies of some of the photographs and information on the exhibit.

TAX ABATEMENT FOR UNDERHILL FARM PROJECT RESOLUTION #254

Upon motion made by Councilman Lachterman, seconded by Councilman Esposito,

Whereas, in November of 2020, by the adoption of Local Law 13-2020, the Town of Yorktown ("Town Board") amended Chapter 300, Zoning, of the Yorktown Town Code when it added Article XXXI, Planned Design District Overlay Zones; and,

Whereas, the Legislative Purpose and Intent of Article XXXI was stated clearly when the Town Board "found and determined that there is a need throughout the Town of Yorktown to encourage and establish further economic development. To stimulate that growth and provide for revitalization, the Town requires the use of smart-growth techniques capable of creating smarter, less wasteful, and more economically efficient development patterns. Specifically, the Town needs flexibility in land uses which bolster economic development by providing not only a diverse array of commercial businesses, but mixed-use residential and commercial parcels to both provide abundant job opportunities and contribute to the local tax base," and duly adopted the amendment; and,

Whereas, in furtherance of the purpose and intent of Article XXXI, in January of 2022, the Town Board further amended Chapter 300, Zoning, Article XXXI Planned Design District Overlay Zones, when it added Section 300-255, Yorktown Heights Planned Design District Overlay Zone; and,

Whereas, project sponsor Underhill Farms, LLC ("Underhill Farms"), sought authorization from the Town Board to have its proposed multi-family, mixed use commercial project located at the former site of the Soundview Preparatory School at 370 Underhill Avenue, in the Town of Yorktown ("Project") considered under the Overlay regulations; and,

Whereas, the Town Board found that the Project complied with the requirements of Article XXXI and deemed Project eligible to apply for site-plan under the auspices of the overlay district; and,

Whereas, Underhill Farms made application to the Town of Yorktown Planning Board ("Planning Board") for site plan review and review under the State Environmental Quality Review Act ("SEQRA" and collectively both referred to as "Site Plan Review") and that review is currently underway; and,

Whereas, during the course of the Site Plan Review, certain impacts were identified, and corresponding mitigation measures have been proposed for each impact, one such impact being the existing undesirable service level of the intersection at State Route 118 and Underhill Avenue; and,

Whereas, Underhill Farms has proposed to finance and undertake a full reconstruction of the intersection, including the installation of certain improvements that will improve service of the intersection beyond the potential impacts imposed by the Project; and,

Whereas, Underhill Farms has requested the Town Board's support in certain real-property tax abatements for eligible portions of the improvements to the intersection, through an application made to the Westchester County Industrial Development Agency ("WCIDA"); and,

Whereas, having recognized the greater community benefits offered by the Project, and in particular the proposed Intersection Improvements (attached hereto), the Town Board has agreed to support the Project's abatement proposal; and

Whereas, the N.Y.S. D.O.T. has requested confirmation that the Town and Underhill Farms have come to an understanding about the financing of the Intersection Improvements; and

Whereas, the Project is contingent upon all necessary approvals, including Site Plan Review;

Whereas, Underhill Farms has committed to contributing two hundred and twenty-five thousand dollars (\$225,000) toward Town parks and recreation purposes, in addition to the Intersection Contribution (defined below); now

Therefore be it Resolved, the Town Board supports Underhill Farms' application to the WCIDA for real-property tax abatement of eligible portions of the Project; and,

Resolved, the abatement shall adhere to the following parameters:

- 1) The period of tax abatement shall coincide with the amount of time required for Underhill Farms to recapture Eligible Expenditures (as defined below),
- 2) Underhill Farms shall contribute thusly: payments not to exceed six-hundred and twenty-seven thousand nine hundred and eighteen dollars and eighty-eight cents (\$627,918.88) ("Intersection Contribution") toward the cost of the Intersection Improvements,
- 3) The cost of construction of the Intersection Improvements beyond the Intersection Contribution ("Eligible Expenditures," which are anticipated to be \$610,148.81) shall be eligible for the real-property tax abatement for the necessary term to recapture that amount.
- 4) The abatement shall be limited to the retail/rental-unit building of the Project ("Commercial Portion"), and only regarding applicable county, town and school taxes over the current taxes of \$43,378.74 (which payment shall continue during the term of abatement and be split as follows: county \$4,407.26, town \$5,444.18 and school \$33,527.25).
- 5) The abatement on the Commercial Portion shall begin: (1) after the Intersection Improvements have been completed, i.e., after all necessary signoffs have been issued (including a certificate

- of completion/occupancy); and (2) after a reassessment based on the construction of the Commercial Portion of the Project has occurred.
- 6) The abatement is contingent upon all necessary approvals, including Site Plan approval.

Diana, Lachterman, Esposito, Haughwout, Capoccia Voting Aye Resolution adopted.
