Women's History Month

Whereas, the month of March is observed nationally as Women's History Month to promote equality and celebrate women's roles in history and society; and

Whereas, Women's History Month honors and celebrates the achievements of American women throughout the history of the United States who have struggled for over 200 years to gain rights, not simply for themselves, but for many other under-represented groups in America; and

Whereas, this year's theme for Women's History Month is "Women Who Advocate for Equity, Diversity, and Inclusion," as this theme recognizes the invaluable contributions of women who have dedicated themselves to advocating for equity, diversity, and inclusion in all aspects of society; and

Whereas, in 2024, we honor the women who have tirelessly worked to dismantle barriers, challenge prejudices, and create opportunities for all individuals, regardless of their background;

Now, Therefore, Be It Resolved, that the Town Board of the Town of Yorktown proclaims March 2024 as Women's History Month in the Town of Yorktown.

Irish American Heritage Month

Whereas, the Town of Yorktown celebrates March as Irish American Heritage Month; and

Whereas, millions of Irish passed through Ellis Island, entering New York City in the 19th Century fleeing hunger and injustice within their country; and

Whereas, one of the first immigrants to pass through Ellis Island was Annie Moore, a 17 year-old from County Cork, Ireland; and

Whereas, since 1762, Irish New Yorkers have celebrated and cherished the feast of Saint Patrick every March 17th which stands as a day to celebrate Irish heritage and share traditions with younger generations; and

Whereas, Irish Americans have defended our nation, most notably through the Irish Brigade which originally consisted of the 63rd, the Fighting 69th, and the 88th Infantry of New York whose members fought in the Civil War, World War I, World War II and Iraq; and

Whereas, Irish immigrants and Irish Americans have contributed greatly to American society, the State of New York, and the Town of Yorktown; and

Whereas, Irish Americans are deeply committed to family and community and exhibit an incredible work ethic as shown through the many contributions to our Town and society;

Now, Therefore, Be It Resolved, that the Town Board of the Town of Yorktown proclaims March 2024 as Irish American Heritage Month in the Town of Yorktown.

Developmental Disabilities Awareness Month

Whereas, Developmental Disabilities Awareness Month is recognized each March to promote respect for people with developmental disabilities and bring awareness of the barriers that people with developmental disabilities can face; and

Whereas, Yorktown is a community that is dedicated to fostering acceptance and welcome of all residents and preventing discrimination and bullying;
