TOWN BOARD MEETING

Deputy Supervisor Ed Lachterman called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Esposito, seconded by Councilman Murphy, the Town Board moved out of Executive Session and proceeded with the meeting.

PLEDGE OF ALLEGIANCE

Anthony Grasso led the Pledge of Allegiance.

Deputy Supervisor Lachterman began the meeting with a prayer led by Rabbi Heber in honor and memory of Town Supervisor Thomas P. Diana. Rabbi Heber was followed by a video presentation of commemorations of Supervisor Diana by the New York State Assembly, the New York State Senate, and the United States House of Representatives. This was followed by a montage of highlights of Supervisor Diana's career.

Deputy Supervisor Lachterman read the following Town of Yorktown Proclamation in memory of Supervisor Diana's service:

WHEREAS, CERTAIN OUTSTANDING MEMBERS OF OUR COMMUNITY WHO, THROUGH SELFLESS COMMITMENT AND DEDICATION, HAVE SERVED TO BETTER THE QUALITY OF LIFE IN OUR COMMUNITY AND HAVE HAD A MEASURABLE POSITIVE IMPACT ON THE LIVES OF ITS RESIDENTS; THOMAS P. DIANA WAS ONE SUCH INDIVIDUAL; AND

WHEREAS, IT IS WITH PROFOUND SORROW THAT THE YORKTOWN TOWN COUNCIL MOURNS THE PASSING OF THOMAS P. DIANA, NOTING THE SIGNIFICANCE OF HIS PURPOSEFUL LIFE AND ACCOMPLISHMENTS; AND

WHEREAS, THOMAS PAUL DIANA OF SHRUB OAK, NEW YORK, DIED ON FRIDAY, JANUARY 5, 2024, AT THE AGE OF 66; AND

WHEREAS, TOM WAS BORN TO THE LATE HENRY PAUL DIANA AND MAURINE AUDRA POWER DIANA; AND WAS RAISED IN SHRUB OAK, NEW YORK WHERE HE PROUDLY CONTINUED TO LIVE AND SERVE; AND

WHEREAS, A 1975 GRADUATE OF LAKELAND HIGH SCHOOL, TOM BEGAN HIS LONG AND DISTINGUISHED CAREER IN PUBLIC SERVICE AS A PUTNAM COUNTY DEPUTY SHERIFF; AFTER SERVING FOR PUTNAM COUNTY, HE TRANSFERRED TO THE YORKTOWN POLICE DEPARTMENT AS PART OF THE K9 UNIT; AND

WHEREAS, SUCCEEDING HIS EMPLOYMENT THERE HE TRANSFERRED TO THE TOWN OF CORTLANDT POLICE DEPARTMENT, WHERE HE BECAME PATROL COMMANDER SERGEANT; HE THEN FINISHED HIS LAW ENFORCEMENT CAREER IN THE WESTCHESTER COUNTY POLICE DEPARTMENT, RETIRING IN MARCH 2005; AND

WHEREAS, A SUCCESSFUL SMALL BUSINESS OWNER, TOM ALSO SERVED AS TOWN COUNCILMAN FOR YORKTOWN FOR SEVEN YEARS; HE BECAME THE INTERIM TOWN SUPERVISOR FOR YORKTOWN AND THEN WAS ELECTED AS THE CURRENT YORKTOWN TOWN SUPERVISOR IN NOVEMBER 2023; AND

WHEREAS, TOM LOVED TALKING TO PEOPLE—EVEN STRANGERS; HE WOULD DROP EVERYTHING TO HELP ANYONE IN NEED; HE HAD A QUICK WIT AND BEAUTIFUL, BLUE EYES THAT LIT UP THE ROOM; TOM HAD A JOVIAL SMILE AND LAUGH THAT MADE EVERYONE HAPPY WHENEVER HE WAS NEAR; AND

WHEREAS, OUTSIDE OF HIS LAW, SMALL BUSINESS, AND POLITICAL VENTURES, TOM ENJOYED MANY HOBBIES, HIS FAVORITE BEING DRAG RACING; HE WAS A MOMENTOUS SUPPORTER OF GUIDING EYES FOR THE BLIND, AND HE SOCIALIZED PUPS, SUCCESSFULLY RAISING A GRADUATE PUP NAMED NACHO; HE LOVED THE SEA AND SKY; HE WAS AN AVID BOATER AND A LICENSED BOAT CAPTAIN; TOM ALSO RECEIVED HIS PILOT'S LICENSE; AND

WHEREAS, A TRUE ASSET TO HIS LIFELONG COMMUNITY, TOM WAS AN INTEGRAL PART OF INITIATING THE YORKTOWN AGAINST HEROIN PROGRAM; HE HAD A PASSION FOR SOCIALIZING, MEETING NEW PEOPLE, AND SERVING HIS COMMUNITY; AND

WHEREAS, TOM WAS A MEMBER OF MANY LOCAL ORGANIZATIONS INCLUDING THE YORKTOWN ELKS, CIRCOLO DAVINCI ITALIAN CLUB, AND SONS OF THE AMERICAN LEGION; HIS LOVE OF THIS WAS EVIDENT IN HIS EVERYDAY LIFE; AND

WHEREAS, WHILE HE WAS PASSIONATE ABOUT MANY THINGS, HIS GREATEST PASSION WAS SPENDING TIME WITH HIS BELOVED FAMILY AND ADORED GRANDCHILDREN; TOM IS SURVIVED BY HIS DEVOTED, LOVING WIFE OF THIRTY YEARS, DONNA; TWO DAUGHTERS, MEGAN (WILLIAM) AND BRIANA (STEVEN); AND FOUR GRANDCHILDREN, EMMA MARIE, GRACIE LYNN, PENELOPE ROSE, AND DAISY ROW; AND

WHEREAS, TOM'S SELFLESSNESS AND BENEVOLENCE WILL SHINE ON THROUGH HIS FAMILY'S VIVID AND HAPPY MEMORIES; HIS INSIGHT AND STRENGTH WILL FOREVER SERVE AS A BEACON OF LOVE, LIGHT, AND HOPE TO THE COUNTLESS LIVES HE TOUCHED; AND

WHEREAS, TOM LEAVES BEHIND A LEGACY OF PUBLIC SERVICE THAT WILL LONG ENDURE THE PASSAGE OF TIME AND WILL REMAIN AS A COMFORTING MEMORY TO ALL WHO WERE PRIVILEGED TO HAVE KNOWN AND LOVED SUCH AN AMAZING MAN; HE WILL BE DEEPLY MISSED AND TRULY MERITS THE GRATEFUL TRIBUTE OF THIS COMMUNITY AND TOWN COUNCIL;

NOW, THEREFORE BE IT RESOLVED, THAT THIS TOWN COUNCIL PAUSE IN ITS DELIBERATIONS TO MOURN THE DEATH OF THOMAS P. DIANA, AND TO EXPRESS ITS DEEPEST CONDOLENCES TO HIS FAMILY.

Whereas, homeowners in Yorktown earning up to 100% of Area Median Income would be eligible to apply for the program; and

Whereas, there are no restrictions under the program regarding who can rent the ADU other than an exclusion of seasonal or vacation rentals such as bed and breakfasts, and the homeowners are free to rent to family members or others and to charge market rent; and

Whereas, participation in the program does not require any changes to the Town of Yorktown's existing Accessory Dwelling Unit regulations as specified in the zoning code Article VII, Section 300-38, which would govern all ADUs created or improved under the Plus One ADU Program; and

Whereas, ADUs may assist with the affordability for seniors and other homeowners and help them remain in Town, and the Plus One ADU Program will bring a financial benefit to existing homeowners in Yorktown by funding up to approximately \$100,000.00 per home for renovations; and

Whereas, Habitat for Humanity of NYC and Westchester and the Housing Action Council currently operate this program under a previous round of funding in communities including Bedford and Irvington, and they selected eligible homeowners, provide technical assistance, and oversee compliance; and

Whereas, the Yorktown Community Housing Board supports the Town of Yorktown's participation in this program; now

Be It Resolved, that the Deputy Supervisor is authorized to execute an MOU with Habitat for Humanity of NYC and Westchester and with the Housing Action Council supporting their application for funding from NYS and authorizing the Town of Yorktown to participate in the ADU Plus One Program if the funding is awarded by NYS.
