Meeting of the Town Board, Town of Yorktown held on May 23, 2017 at the Town Hall, 363 Underhill Avenue, Yorktown Heights, New York 10598.

#### **TOWN BOARD MEETING**

Supervisor Michael Grace called the meeting to order.

#### **EXECUTIVE SESSION**

Upon motion made by Councilman Bernard, seconded by Councilman Lachterman, the Town Board moved into Executive Session to discuss contract negotiations. Upon motion made by Councilman Diana, seconded by Councilman Patel, the Town Board moved out of Executive Session and proceeded with the meeting.

### REQUEST TO GO OUT TO BID FOR A NEW PACKER TRUCK

Mrs. Kim Angliss Gage requested permission from the Town Board to go out to bid for a new packer truck. She explained that because of the age of the vehicles there have been ongoing repairs and two trucks have been down for a long time. The Town Board agreed to authorize going out to bid for a new packer truck.

### MOHANSIC TRAILWAY

Mrs. Jane Daniels, Yorktown Trail Town Committee, discussed with the Town Board a project to create a trailway from Route 118 to Baldwin Road. She stated that they have received two grants which total approximately \$3,500. The Item 4 trail will be put in place by the Highway Department and an additional \$7,750 would be needed from the Town. Highway Superintendent Dave Paganelli stated that he met with representatives from AT&T and a site visit was conducted to make sure that the buried AT&T Fiber Optic Cable would not be an issue with this project.

#### **CAPITAL PROJECTS**

Supervisor Grace discussed with the Town Board capital improvement projects. He said that the Town is in great financial condition and that this Town Board will be taking care of infrastructure projects this year.

The Town Board reviewed roads that Highway Superintendent Dave Paganelli would like to pave over the next year. Different types of paving techniques were discussed. The Town Board asked that a new schedule be prepared with an estimated cost. Town Engineer Michael Quinn asked that roads with culverts be checked with the Town's new camera before being paved.

Highway Superintendent Paganelli stated that a large majority of the culverts in the Town are in need of replacement because they are over sixty years old.

The Town Board also discussed the Railroad Park Train Station Building Rehabilitation Project, Granite Knolls Sports and Recreational Facility, the Highway garage, the Zino Barn resurrection, preservation of historical graveyards around the Town, a new phone system, stand-alone senior center, rehabilitation of the tennis courts, generator for Town Hall, the purchase of new a Vac-All for the Highway Department, revamping the front of Town Hall to include new accessible parking spots, beautifying the commuter lot, and sewers.

Town Comptroller Patricia Caporale stated that an estimated total cost would be needed for all the projects anticipated.
