Meeting of the Town Board, Town of Yorktown held on November 28, 2017 at the Town Hall, 363 Underhill Avenue, Yorktown Heights, New York 10598.

TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved into Executive Session to discuss contract negotiations. Upon motion made by Councilman Lachterman, seconded by Councilman Diana, the Town Board moved out of Executive Session and proceeded with the meeting.

CON EDISON PROPOSED LOCAL LAW

The Town Board met with representatives from Con Edison to discuss a proposed local law that will require more information and additional fees from utility companies doing work in the Town. Con Edison stated that they were against a percentage fee based on overall cost of the project because they would then have to pass that fee down to its users. They would like the fee to be based on what the Town oversight of the project would be. The Town Board asked Con Edison to meet with the Highway Superintendent, Town Attorney and Town Engineer to come up with a reasonable fee structure that would be agreeable to both the Town and Con Edison.

REQUEST FOR PROPOSALS GRANITE KNOLLS

RECREATION AND SPORTS COMPLEX

The Town Board met with the Parks and Recreation Superintendent and a representative from Shaw to discuss the turf that would be placed at the Granite Knolls Recreation and Sports Complex. The Town Board decided that the higher quality turf would be more beneficial to the project.

Supervisor Grace stated that the Yorktown Athletic Club would like to have lines included on the Multi-purpose fields for baseball. There will be a meeting with the athletic clubs tomorrow night to discuss this issue.

HYATT BURIAL GROUND

Mr. Lester Rosenbaum was present to discuss with the Town Board the Hyatt Burial Ground which is located on property owned by the Bernstein Estate. He is the Executor and would like the Town to purchase the property from them. The Town Board agreed to look into this option.

2715 & 2723 HICKORY STREET REQUEST FOR A WETLANDS PERMIT

The Engineer for the property was present to discuss with the Town Board its plans to construct two homes on property located on Hickory Street. Because the work would be done in the wetlands buffer a wetlands permit will need to be issued by the Town Board. The Town Engineer stated that more information is needed so that he can review the plan. The applicant stated that they would run a sewer line up to Hickory Street. The Town Engineer would like to review the plans and see how it coincides with the Town's plans for sewers in this area. Supervisor Grace asked the applicant to give the Town its updated plans so that they can be reviewed before the scheduled public hearing on December 19, 2017.

GRANT EMERGENCY PERMIT FOR PLACEMENT OF ABOVEGROUND PROPANE TANK – PARACO GAS, 1731 EAST MAIN STREET, MOHEGAN LAKE RESOLUTION #458

Upon motion made by Councilman Diana, seconded by Councilman Lachterman,

WHEREAS:

- 1. Paraco Gas, Peekskill, NY, as Applicant for the property located at 1731 East Main Street, Mohegan Lake, requested the Town Board issue an emergency permit to temporarily place an aboveground propane tank in a wetland area.
- 2. The Proposed Action, installation of an aboveground propane tank in a New York State-designated wetland area, requires issuance of a Wetland Permit and the Approval Authority is the Town Board.
- 3. The propane service to the property provides fuel for cooking and heating of commercial establishments. Currently an underground tank serves the property; however, the tank is approaching the end of its useful life and needs repair and/or replacement. Disruption of this service will likely force temporary closure of the affected businesses so the Applicant requested an emergency permit be granted so that the work may proceed without delay.
- 4. Requirements for emergency permits are specifically addressed under the Town Code, Chapter 178, Subchapter 178-10.C.
- 5. The emergency permit was requested for a duration of 6 weeks so that the necessary repair can be done to the existing tank. An aboveground tank will be placed in the wetland area and put in service while repair work is done to the existing tank. Applicant stated that no ground disturbance will be needed to place the aboveground tank in the wetland area. It is understood that should a replacement tank (aboveground or underground) be necessary a wetland permit will need to be obtained by the Applicant, following the normal Town procedures.
- 6. It is further understood that the Applicant will obtain all necessary building permits from the Town of Yorktown for the Proposed Action. Applicant is also responsible for any NYSDEC approvals and/or permits that may be required.

NOW THEREFORE BE IT RESOLVED THAT the Town Board of the Town of Yorktown does hereby grant an emergency permit for placement of an aboveground propane tank in a wetland area for a duration not to exceed 6 weeks.

GRANT A VARIANCE TO ADRIAN AUTO BODY REGARDING TEMPORARY SIGNAGE RESOLUTION #459

WHEREAS, pursuant to Town Code Section 300-193.18 the Town Board determines that a hardship exists in connection with Adrian Auto Body's sign being obscured;

WHEREAS, the Town Board determines that a variance should be issued for the erection of a temporary sign for Adrian's Auto Body;

BE IT RESOLVED, the Town Board issues a variance to Adrian Auto Body for the erection of a temporary sign and refers Adrian Auto Body to the Building Inspector for the issuance of the necessary permit for the temporary signage.

QUINLAN STREET RADIO STATION

Police Sergeant Scatola and Dennis Palumbo explained that there is a ham radio club in Yorktown and there is an antenna on the Quinlan Street water tower that they recently did repairs on. They would like to enter into a license agreement with the Town so that its equipment can be there and it will be made available for Town use when necessary. The Town Board agreed and asked that the Town Attorney draft a license agreement.

<u>WAIVER OF PENALTY FEE – MOHEGAN AUTO TIRE CENTER</u> RESOLUTION #460

BE IT RESOLVED that the \$1,500.00 penalty fee for Mohegan Auto Tire Center for failing to obtain a building permit in advance of performing the work is waived but all other permit fees will be required to be paid.
