- 1. The proposed action will not result in a substantial adverse change in the existing air quality, ground or surface water quality or quantity, traffic or noise levels, or a substantial increase in solid waste production. The applicant is required to obtain approval for a stormwater pollution prevention plan from the Town of Yorktown Town Engineer and the NYCDEP to address potential erosion during construction and post-construction stormwater quantity and quality. PROPOSED ACQUISITIONS OF THE PERMANENT EASEMENT UPON THE KAUFMAN PARCEL, TEMPORARY EASEMENT UPON THE KAUFMAN PARCEL, AND TEMPORARY EASEMENT UPON THE SALITAN PARCEL RESOLUTION #358

WHEREAS, in order to repair the roadbed adjacent to and in the vicinity of 1225 and 1210 Baptist Church Road, and the culverts beneath said roadbed, -- a necessary public project to protect the safety of the traveling public and improve the hydrology of the watercourse below the road -- (the "Project"), the Town requires two temporary easements and one permanent easement over the parcels of real property abutting Baptist Church Road; and

WHEREAS, the downstream parcel adjacent to the Project is owned by Michael Salitan, is located at 1225 Baptist Church Road (tax map ID number 47.15-1-18), and consists of 5.08 acres (221,350 square feet) in total area ("Salitan's Parcel"); and the upstream parcel adjacent to the Project is owned by Elizabeth Kaufman, is located at 1210 Baptist Church Road (tax map ID number 47.15-1-4), and consists of 1.89 acres (82,328 square feet) in total area ("Kaufman's Parcel"); and
