Regular meeting held by the Town Board, Town of Yorktown on July 5, 2011 held at Sparkle Lake Park, 176 Granite Springs Road, Yorktown Heights, NY 10598

TOWN BOARD MEETING

Supervisor Susan Siegel called the meeting to order. Town Attorney Jeannette Koster was also present at the meeting.

PLEDGE OF ALLEGIANCE

Supervisor Siegel led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

DURING THE SUPERVISOR'S REPORT TO THE TOWN

Supervisor Siegel made several announcements:

The New York State Department of Transportation announced that paving along Route 202 will resume within the next few weeks. There was a technical problem which caused them to issue a Stop Work Order. The problem has been resolved.

Supervisor Siegel spoke about the recent 2% tax cap legislation approved by both houses of the New State Legislature. Reading from prepared remarks, she explained how the legislation differs from a tax levy.

The Supervisor provided answers to questions posed by Mr. Howard Frank at the June 21st meeting of the Town Board regarding the Yorktown's 30% water loss in 2010. The Supervisor explained that last year a Water Leak Detection Survey was done. 17 water leaks, resulting in a loss of 218,000 gallons of water a day were discovered. Unfortunately, the survey was done after the Annual Drinking Water Quality Report for 2010 was prepared. The Supervisor further stated that there were also 29 water main breaks in 2010, one of them, near the Amawalk Plant was very large. The Water Department has increased the amount of hydrant flushing it does on an annual basis. The Town of Cortlandt Water Meter Pit on Lexington Avenue and Route 202 has been broken since 2008. We have been estimating the costs to Cortlandt since then. The Supervisor further stated that the Water Distribution Superintendent has learned that there is another Water Meter Pit in Cortlandt which is newer, and has never been used. He is conducting an investigation into why the new pit can't be used.

DURING REPORTS FROM TOWN COUNCIL

Councilman Bianco welcomed everyone to Sparkle Lake. He also stated that he was shocked to learn about the 30% water loss. Several years ago, the water loss was down to less than 20%.

Councilman Patel spoke about his trip to West Point on July 4th.

COURTESY OF THE FLOOR

During Courtesy of the Floor, the following people addressed the members of the Town Board:

Mr. Steve Gardner a resident of the Sparkle Lake area stated that we have had a number of thunderstorms this year which has caused the embankment behind the beach at Sparkle Lake to wash out. He believes this occurs because there are no curbs on the road above the embankment which would direct the water into the catch basins.

Mr. Howard Frank thanked the Supervisor for her response to his questions. But, one of them were not answered. How much water is used in the plant for processing? He feels the Town might be eligible for a credit because of all of the sludge that comes out of the plant. Mr. Frank also asked that the Monthly Reports from the Building Department be read aloud before they are accepted by the Town Board.

Mr. Gil Kaufman stated that the bids for renovation work at the Yorktown Community and Cultural Center were opened some time ago. When are the results going to be made public?

Mr. John Cito, stated that when the Town Board holds its meetings out of doors, the background noise drowns out the sound from the Town Board. You need to go back to Town Hall for your meetings.

COURTESY OF THE FLOOR IS CLOSED

RESPONSES TO COURTESY OF THE FLOOR:

Supervisor Siegel provided the following responses: To Mr. Gardner:

The Parks and Recreation Department became aware of the problem with the embankment this year. They believe the problem occurred after the vegetation that was on the slope was taken away and replaced with mulch. Parks and Recreation Superintendent Jennifer Fava is working with representatives from Cornell University's Cooperative Extension Program to find out what is the appropriate vegetation to place in the area.

To Mr. Frank:

The water loss at the plant is approximately 2-3%. The loss is divided between Yorktown Somers, Cortlandt and Montrose. The Northern Westchester Joint Water Works has hired a new Operations Manager who has been coming up with plans for the plant that will save money.

Supervisor Siegel stated that she will read the Monthly Reports from the Building Department.

To Mr. Kaufman:

There are some concerns regarding the bid for the renovation work at the YCCC. We have some concerns that the low bidder is really low. The second lowest bidder has challenged the bid process. We are checking with our attorney to see if the bid process must be voided.

Planning Director John Tegeder added that the results of the bid are public.

To Mr. Cito:

She agrees that the meetings should be held in Town Hall because at times they create logistical problems. The Board did not agree with her.

Councilman Vishnu Patel congratulated the Lions Club on their 50th Anniversary. They held a wonderful celebration at Ceola Manor last Saturday. July 10th is the date of the next Concert at the Gazebo which is co-sponsored by the Lions Club and the Town of Yorktown. Councilman Patel also thanked the many volunteers who have taken the time to help plant the flowers in the planters along Commerce Street. He also thanked them for helping to place the American Flag in these planters as well. Councilman Patel asked that everyone refrain from taking the flowers out of the planters or putting garbage into the planters.

Councilman Bianco announced that New York State Senator Greg Ball has secured money to pay for work on ball fields on Route 202 and the hockey rink at Shrub Oak Park.

APPOINTMENT

JOHN WINTER – YORKTOWN BUILDING INSPECTOR RESOLUTION #321

Upon motion made by Councilman Martorano, seconded by Councilman Bianco,

BE IT RESOLVED, that John P. Winter of Katonah, NY, is hereby appointed Building Inspector, job class code 0518-01, effective July 5, 2011, to be paid \$100,000.00 annually, with four weeks of annual vacation, and for other benefits, sick days, personal days, and floating holidays to follow the CSEA agreement,

BE IT RESOLVED, that John P. Winter will have the use of a Town vehicle to take home, which can only be used when conducting Town business,

BE IT RESOLVED, contingent upon successful completion of a drug test,

BE IT RESOLVED, that John P. Winter will report to work at the Yorktown Building Department on July 18th, 2011, and this date will be used as the first date of appointment,

BE IT FURTHER RESOLVED, that this appointment is subject to a probationary period of not less than 12 nor more than 52 weeks, commencing on the first date of appointment on July 18th, 2011.

Siegel, Bianco, Martorano, Patel Voting Aye Resolution adopted.

Supervisor Siegel stated that Mr. Winter formerly worked as an Assistant Building Inspector in Yorktown. He is now the Building Inspector for the Village of Mamaroneck. He comes highly recommended.

Councilman Martorano announced that a Retirement Party for our former Building Inspector Bill Gregory will be at Travelers Rest in August.

Supervisor Siegel stated that the Town Board plans to shift the responsibility for oversight of our Town Buildings and building maintenance staff into the Building Department when Mr. Winter comes aboard.

CONVENE PUBLIC HEARING

PROPOSED LOCAL LAW AMENDING VARIOUS SECTIONS OF CHAPTER 300-SECTION 161 LOT AND BULK STANDARDS

Supervisor Siegel convened a public hearing to consider a proposed local law amending various provisions of Chapter 300 of the Code of the Town of Yorktown entitled "ZONING" with respect to Article XVI entitled "Age-Oriented Geriatric Community." The Town Clerk presented affidavits of posting and publication. Supervisor Siegel explained that this amendment to the Town Code relates to the RSP-3 zone. It is being considered because of a new plan by the Field Home to create a Continuing Care Retirement Community. Under the plan, the size of the nursing home, Field Home-Holy Comforter will be reduced. There will be no change to The Seabury, their assisted living facility. They will add 102 independent living units to its campus.

Mr. Albert Capellini explained that in order to achieve this change on the Field Home's two tax lots, we are requesting some minor text changes to the town's zoning code. We are requesting a change in The Floor Ratio Area (FAR) in the RSP-3 zone. In other residential areas, the FAR is higher. We also need an increase in height of buildings in that particular zone. The Field Home will be placing a Conservation Easement on 32 acres. The entire project will not produce any significant increase in the number of units.

Mr. John Ahern, the Chief Executive Officer of the Field Home spoke about the benefits of the Continuing Care Retirement Community concept.

Councilman Martorano asked if someone lived in one of the independent living units, would they have a guarantee of being accepted into the nursing facility if they needed it. Mr. Ahern said yes.

Mr. Ray Arnold handed the Town Board a handout showing the current law and stated that the proposed law should not say "proposed FAR". It should say something like "allowable" FAR. He further stated that this increases the bulk, not density. Mr. Arnold added that most zones do not have a FAR. He also pointed out that in the second part of the proposal, what he believes the Town is attempting to do is change the verbiage associated with Section 300-161B, but keep the chart that is currently in the code. Unfortunately, he said the proposed local law says replace everything.

Planning Director John Tegeder agreed that he did not want the chart removed from the law. He simply wanted to replace the text.

Town Attorney Koster stated that the Town Board should adjourn the meeting, make the changes and reconvene the hearing at its next meeting.

Mr. Howard Frank stated that it would be a mistake to approve these changes. This is a residential area. He doesn't believe proper notification has been made to the Field Home's neighbors. This may cause some of them to be upset. Mr. Frank further stated that this appears to be a complete renovation of the site. They should have a site plan and new parking plan. Recently he visited a patient in the nursing home and found that the parking plan was no longer valid.

Supervisor Siegel explained that Mr. Ahern and his design team have held several meetings at Glassbury Court. The Town Board has seen a conceptual plan. All issues you raise will be addressed at the Planning Board.

Mr. John Cito, a member of the Board of Directors at Glassbury Court stated that the residents of his development know about this plan and are very happy with it.

Councilmen Martorano and Bianco stated that they do not want this project delayed, they wanted it moved along.
