TOWN BOARD MEETING

Supervisor Susan Siegel called the meeting to order. Town Attorney Jeannette Koster was also present at the meeting.

PLEDGE OF ALLEGIANCE

Joe Troia, Captain of the Yorktown Ambulance Corp's Youth Group and Michael Gonzalez, a Boy Scout with Troop 173 led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

Councilman Vishnu Patel asked the members of the Yorktown Volunteer Ambulance Corp's Youth Group to stand

Supervisor Siegel read the following Proclamation:

We join today to honor you for volunteering in your community, for your exceptional service to the Yorktown Ambulance Corps and making the Town of Yorktown proud

The Yorktown Town Board offers you their hearty appreciation and congratulations!

Youth Group Captain Joe Troia, stated that they are trained in CPR and first aid. They work under the direction of a trained Emergency Medical Technician and/or paramedic for events such as the Grange Fair and Fireman's Carnival.

DURING REPORT FROM THE SUPERVISOR, Supervisor Siegel spoke about the following:

Phase I of the renovation of the Town Board Meeting Room is currently underway. We have installed a new state of the art audio video system. It will be paid for by fees from Cablevision and Verizon FIOS.

Thank you to the Chamber of Commerce and town personnel for the work they did at the Harvest Festival.

The Town of Yorktown received a \$1,000 grant from the New York State Department of Environmental Conservation to fund next year's Arbor Day Celebration.

There are openings on the Conservation Board and Ethics Board.

The Town Clerk was asked to explain changes the Board of Elections made in Election Districts and Polling Locations in the Town of Yorktown for the November elections

Supervisor Siegel continued with other announcements:

A discussion on the vandalism at the soccer field on Catherine Street. The Police Department has made a suggestion that large boulders be placed around the field to prevent ATV's from getting onto the field.

A correction of the misinformation that is circulating concerning an offer to donate land to the Town of Yorktown. Supervisor Siegel explained that someone made the offer to donate land to the Town. The Town Board referred the offer to the Conservation Board and Open Space Committee. The Board eventually decided not to accept the donation. This action by the Board, in no way puts the Yorktown Bike Path in jeopardy.

DURING REPORTS FROM THE TOWN COUNCIL.

Councilman Bianco wished Detective Colarusso the best of luck; he is retiring tonight. He suffered an injury in the line of duty and is going out on disability. Detective Colarusso will be missed. Councilman Bianco also stated that he voted to accept the property that was offered to the Town as open space. His job now is to try to get one of the three people who voted not to accept the property to change their mind.

Councilman Martorano echoed what had already been said about Detective Colarusso, he will be missed. Councilman Martorano also stated that it was his pleasure to represent the Town of Yorktown presenting a Proclamation to David Klaus who served the town for more than two years as a volunteer. Mr. Klaus stepped down from his role as Chairman of the Planning Board last year.

Councilman Murphy congratulated the Chamber of Commerce for their work on the third Annual Harvest Day Festival. More than 15,000 people attended the event. Councilman Murphy also wished Detective Colarusso the best in his retirement.

Councilman Patel spoke about the newly renovated Town Board Meeting Room. He said the Chamber's Harvest Festival was a wonderful event. The Councilman represented the Town at the last Westchester Municipal Official meeting where the major subject was the 2% tax cap.

Supervisor Siegel explained that the Supervisor's Budget (the Tentative Budget) is due on October 31, 2011. The Town Board will be meeting with Department heads on November 10 and 11th. After those meetings, the Town Board will adopt a Preliminary Budget. The Budget Hearing will take place on December 7, 2011.

Westchester County Legislator Michael Kaplowitz spoke to the Town Board on several subjects. Westchester County has just enacted the final piece of its Early Retirement Incentive Program. Under this plan, we saved \$3.2 million dollars and reduced the County workforce by ten percent. Legislator Kaplowitz wished the Town luck with its 2012 budget. He also spoke about sales tax revenue as well as the Westchester County Refuse District #1 which Yorktown is a member of until 2019. He explained that revenues generated by the County's recycling center go right back into the program.

Supervisor Siegel explained that a gentleman came before the Town Board at its last work session looking to open a recycling center on Navajo Street in Jefferson Valley.

DURING COURTESY OF THE FLOOR, the following residents addressed the Town Board:

Mr. Dale Saltzman handed the Town Board a proposed local law to amend Chapter 195, Article 18 of the Town Code. He would like the following words added; "stone walls, historic stone foundations or other historic stone structures." Mr. Saltzman also asked that the Landmarks Preservation Commission be reconstituted.

Mother Claire Woodley-Atchison, the Pastor of St. Mary's Church in Mohegan Lake asked the Town Board to adopt the proposed Affordable Housing Set-Aside Legislation.

Mother Claire was told that this is the subject of a public hearing.

She said that she could not stay but wanted the Town Board to know the position of the Interfaith Council.

Mr. Walter Daniels, a member of the Conservation Board and Co-Chair of the Open Space Committee read a prepared statement signed by his Co-Chair, John Settembrino and himself. The statement, a copy of which is on file in the Town Clerk's Office, states that the Open Space Committee was disturbed by the Town Board's decision not to accept the Gundmar land donation. It ends by asking the Town Board to reconsider its decision.

Mrs. Shireen Witkowich stated that she and her husband attended the October 11, 2011 work session. They were included in discussions pertaining to a proposed local law on accessory structures to residences. At the end of the discussion, they were satisfied with the proposal which the Town Board also appeared to be satisfied. Yesterday, they received a copy of the proposal upon which a public hearing is scheduled to take place on November 1. Mrs. Witkowich stated that the proposal is not what was agreed upon. What happened? Was there another meeting? Or is this something that the Town Attorney did? Mrs. Witkowich said she was also upset at the fact that after reading the new proposal, she sent an email to the Board, but only received responses from Councilmen Bianco and Martorano and the Town Clerk.

Mr. Nicholas Witkowich also brought up the issue of the emails that were sent questioning the proposal. Who came up with this proposal?

Mrs. Jane Daniels explained that as a volunteer she is responsible for the trails in the Town of Yorktown. She and other volunteers work very hard building these trails. Often, these trails are ruined by ATV's. Mrs. Daniels urged the Town Board to adopt a local law that requires the first time offender to pay a fine and a second offense would result in the confiscation of their vehicle.

Mr. Paul Moskowitz spoke in reference to the Gundmar land donation which was turned down by the Town Board. He explained how the North County Trailway has made the Town of Yorktown a destination. Mr. Moskowitz explained that what makes the trailway attractive is that it runs through a rustic bucolic environment. He would like to see the same thing for the Yorktown Bike Trail. Adding the property offered by Gundmar would make the experience of this particular trail more enjoyable. Having a confluence of both trails in this Town would only add to our prosperity.

Mr. John Schroeder, President of the Yorktown Land Trust stated that he wanted to express their disappointment over the Town Board decision not to accept the land donation. Mr. Schroder stated that as a Land Trust, they encourage property owners to come to the Town and make donations. He also asked the Town Board to reconsider its decision.

Mrs. Barbara Michaels, a resident of Arcady Road stated that she was here tonight to express her disapproval at the Town Board's vote to turn down the land donation. She asked the Town Board to reconsider its vote on this issue.

Mr. Gil Kaufman said he wanted to talk about recycling revenues. Why not place recycling bins in Town parks so we can take advantage of the revenue as well as help the environment.

Mr. Nicholas DiTomasso, Vice President of the UTY and Host of the Senior Forum spoke about competitive bidding stating that it guards against favoritism and fraud. Each elected official should know that serving the community is a privilege and a trust. Mr. DiTomasso stated that he was here again to demand a public hearing on the Auditor's Report.

Mr. Howard Frank, spoke about the County's Recycling Program stating that the Town should question their tipping fee. We should call for an audit of the books. He also asked wanted to know who was in charge of the incinerator.

Mr. Bill Primavera stated that earlier today, he placed several political signs on his property and they were taken. He later learned that the Code Enforcement Officer had taken them because he says they were in the Town's right-of-way. Mr. Primavera stated that he can understand why there were taken. But, he still believes there should be a time limit on how long these signs remain.

Supervisor Siegel explained that these signs come under the definition of free speech and the Town cannot put a time limit on them.

Michael Gonzalez, a Boy Scout with Troop 173 stated that he attended tonight's Town Board Meeting to work on his Citizenship in the Community merit badge. He said he would like to work on a beautification project in Mohegan Lake.

Councilman Patel stated that he would work with him.

Scout Gonzalez also wanted to know what the Town Comptroller does.

Supervisor Siegel said the Comptroller's is the Town's fiscal officer and also manages the Town's assets.

COURTESY OF THE FLOOR CLOSED

Michael Gonzalez, a Boy Scout with Troop 173 stated that he attended tonight's Town Board Meeting to work on his Citizenship in the Community merit badge. He said he would like to work on a beautification project in Mohegan Lake.

Councilman Patel stated that he would work with him.

Scout Gonzalez also wanted to know what the Town Comptroller does.

Supervisor Siegel said the Comptroller's is the Town's fiscal officer and also manages the Town's assets.

Supervisor Siegel responded to comments and questions raised during Courtesy of the Floor:

Mr. Saltzman's proposed local law will be put on a work session agenda at the end of November.

It is not practical to take every parcel of land that is offered to the Town. The Board has asked the Open Space Committee to look at the properties on the list of foreclosures.

There was some confusion with regard to the proposed local law concerning accessory structures. The Board did agree on certain things during its discussion that were not put in the proposal. The Town Attorney will re-draft the proposal. The public hearing will take place November 18, 2011.

Town Attorney Jeannette Koster said she took notes but failed to put what said in the draft. She is working on another draft and will have the Board look at it.

She thanked Mr. Kaufman for his suggestion on recycling in town parks. She will have the Parks department order the bins.

Supervisor Siegel stated that the Board has responded to the Audit by New York State, she has submitted the Town of Yorktown's Corrective Action Plan which will be put on-line.

The Code Enforcement Officer, Joe Hughes picked up Mr. Primavera's signs because they were in the right-of-way. The Town recently amended its sign law because of a challenge in Federal Court.

Councilman Martorano stated that you cannot place a time limit on free speech.

Councilman Bianco's responses to comments and questions:

He thanked Legislator Kaplowitz for explaining how the Refuse District runs.

He voted in favor of accepting the land donation.

The Town Board did give direction to the Town Attorney about what we wanted to see in the proposed law on accessory structures. The verbiage in the draft did not come from us. But, we stopped it tonight and made it clear about what we wanted to see in the proposed local law

I'm don't know too much about the tipping fee. But, the Refuse District is regulated by Westchester County.

Councilman Martorano's responses to comments and questions:

He congratulated Mrs. Daniels on receiving an award for her work on trails. He reiterated that he and Councilman Bianco were the only two who voted to accept land donation.

He was shocked that the proposed local law on accessory structures did not include what the Town Board called for.

In terms of penalties for people who ride ATV's and destroy property, there is already a law in the Penal Code which covers this, but there is no reason that we cannot adopt a local law that could concurrently go before the court.

Mr. Primavera, we thought we cleared up the matter of removing signs several years ago. In order to have any type of time limit placed on these signs, the political parties would have to come together and make an agreement.

Mr. Kaufman your idea is great.

Mr. Frank, we will look into the tipping fee.

RECONVENE PUBLIC HEARING

PROPOSED LOCAL LAW CREATING CHAPTER 102 ESTABLISHING A NEW AFFORDABLE HOUSING PROGRAM

Supervisor Siegel reconvened a public hearing for the purpose of enacting Chapter 102 of the Code of the Town of Yorktown entitled "AFFORDABLE HOUSING," establishing a new Affordable Housing Program.

Maura Gregory, a member of the Community Housing Board urged the Town Board to enact the housing set-aside proposal. Many other communities in Westchester County already have enacted a similar law. This proposal will see that Yorktown continues to receive Community Development Block Grants as well as provide workforce housing. Ms. Gregory quoted statistics on the cost of housing in Westchester County versus what the Town of Yorktown pays its labor force. She explained that what we need is more rental units. Under the Westchester County Housing Settlement, these units must be affirmatively marketed. Ms. Gregory refuted arguments made at the previous public hearing saying that homeowners while they may not be able to sell these homes at market rate, they will get back their initial investment and modest interest. She also said that the Town of Yorktown has the legal authority to adopt this housing set-aside proposal.

Mr. Howard Frank stated that he believes the Town Board has not included all of the accessory apartments in the Town of Yorktown in its count of affordable units. He believes that there are several hundred accessory apartments. But, he says the Building Department has been negligent in enforcing the law.

Mr. Ken Belfer, Chairman of the Community Housing Board stated that this is a recycled law. The Town of Yorktown adopted its first housing set aside law in 2005 as did a number of other communities including Bedford, Somers, North Salem and White Plains. He urged the Town Board to adopt the proposed law.

Mr. Ed Ciffone asked that someone show him where workforce housing is mentioned in the Westchester County Housing Settlement. If we don't take the Community Development Block Grant money, we don't have to adopt this law.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was closed. Supervisor Siegel motioned, seconded by Councilman Patel. The Town Board will accept written comments until October 28, 2011.
