EXECUTIVE SESSION

Upon motion made by Councilman Bianco, seconded by Councilman Martorano, to move into Executive Session to conduct interviews for a Building Inspector, and volunteer boards. Upon motion made by Councilman Martorano, seconded by Councilman Bianco the Town Board moved into the work session.

WORK SESSION

Supervisor Susan Siegel called the meeting to order. Town Attorney Jeannette Koster and Director of Planning John Tegeder were also present.

FIELD HOME

Field Home/Holy Comforter CEO John Ahearn was present to discus with the Town Board an organizational assessment which was done on the Field Home Holy Comforter and Catherine Field Home facility located on Catherine Street. He explained that they needed to develop a plan to ensure their long term viability in the community. They would like to expand and enhance their current facility to meet the requirements of Article 46 for a licensed CCRC, this will provide a full range of care. Field Home will apply for a Type B, Modified Life Care Program, consisting of 102 residential units and common areas shared with the new skilled nursing replacement facility. Mr. Al Capellini, Attorney for the Field Home stated they would need a textural change to the RSP-3 Zone. The Town Board agreed to move forward with this project.

AUCTION OF TOWN VEHICLES

Water Distribution Superintendent David Rambo was present to discuss with the Town Board the use of an online auction company to sell used vehicles. Mr. Rambo stated that he would like to sell used vehicles on International, Inc. which is an online auction company, there is no cost to the town but winning bidders would pay an additional fee to the auction company.

SIGN LAW

Supervisor Siegel discussed with the Town Board proposed amendments to the sign law with regards to political signs. The Town Board decided to review this proposed local law further and will discuss at a later work session.

AUDIO AND VIDEO EQUIPMENT BID
