2012 BUDGET ISSUES

Town Comptroller Joan Goldberg was present to discuss with the Town Board the impact the 2% Tax Cap will have on the 2012 Budget. The Town Board discussed not hiring anyone until the 2012 Budget is reviewed because they do not want to hire someone and have to lay them off in January 2012.

Highway Superintendent Eric DiBartolo stated that he needs to have this position filled, he has lost several positions over the past few years and it is affecting the service his department provides to the community. Mr. DiBartolo feels that he can work this position into his budget for next year and would like the opportunity from the Town Board to do so.

Highway Superintendent Eric DiBartolo stated that he wants it on the record that the lack of staffing is crippling departments and it is affecting the services that are provided to this community.

Councilman Martorano motioned, seconded by councilman Murphy, to fill the laborer position in the Highway Department with the stipulation that the laborer is aware that the position could get cut in January 2012.

Councilman Bianco stated that he would like to see an analysis from the comptroller that shows the ramifications this 2% Tax Cap will have on the 2012 Budget before the Town hires any more people.

Supervisor Siegel stated that she agrees with Councilman Bianco and we should not hire anyone until the 2012 Budget is reviewed.

Town Comptroller Goldberg suggested utilizing a Part-timer until September to help the Highway Department. This will give her time to find out more information about the 2% Tax Cap from the State.

The Town Board agreed. Councilman Martorano withdrew his motion.
