Regular meeting held by the Town Board, Town of Yorktown on February 16, 2010 held at Yorktown Town Hall, Yorktown Heights, NY.

TOWN BOARD MEETING

Supervisor Susan Siegel called the meeting to order. Interim Town Attorney Daniel Pozin were also present.

PLEDGE OF ALLEGIANCE

Supervisor Siegel led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

DURING HER REPORT TO THE TOWN,

Supervisor Siegel offered the family of Keith Wilke the Town Board's sincere regrets. He died on February 12, 2010. Mr. Wilke worked for the Town of Yorktown for nearly twenty five years.

Supervisor Siegel stated that it is with sadness and happiness that she announced the retirement of Robert (Bobby) Gage. His last day on the job will be February 26, 2010.

Mr. Gage spent 36 years working for the Town of Yorktown. In his letter of retirement, Mr. Gage states that he looks forward to restoring a muscle car and hitting many golf balls.

The Town Board accepts the letter of resignation from Donald Beaumont, a Fire Marshall with regret. Mr. Beaumont has worked as a Fire Marshall for thirty years. The Supervisor announced that the Town was currently without a Fire Marshall. The Town's Building Inspector William Gregory will be working with the Supervisor to develop a plan as to where the Town goes from here.

The Department of Environmental Conservation has come up with a new "Green" schedule card for 2010. This card saves the Town \$6,000 in printing costs and provides property owners with the curbside recycle collection schedule, the 2010 holiday kitchen trash schedule and the 2010 bulk trash collection schedule. The information is also on line. The Department of Environmental Conservation recently won a Certificate of Achievement for its outstanding job on recycling.

The New York State Department of Transportation has transferred its March 11th public hearing the John C. Hart Library to the Nutrition Center. The meeting which will begin at 7:00PM and will provide residents with the opportunity to discuss a number of traffic improvements along the Route 202/35 corridor including a proposed traffic light at Pine Grove Court, and traffic work at the Bear Mountain Triangle.

The Town Board has begun work on revising the Ethics Code.

There are two openings on the Board of Assessment and Review. Anyone interested can send a letter to the Supervisor's office. She thanked John Kincart who spent

ten years on the Board of Assessment and Review. Mr. Natale Costanza served on the Board for eight years.

The public hearing on the Comprehensive Plan has been rescheduled from March 9, 2010 to March 23, 2010.

The Town has made significant progress concerning the creation of a dog park. New York State has told the Town that it could demolish the abandoned buildings and fill in the pool at the Trump State Park on Old Baldwin Road. The Town Board believes these abandoned structures increase the Town's liability. New York State is currently running tests for lead and asbestos. We are awaiting the results of those tests. The Yorktown Heights Fire District has expressed interest in burning the building while conducting a training exercise. The Fire Chief will get the proper permits from Westchester County and New York State. We are hoping that we will have answers to all of our questions within the next several weeks.

Supervisor Siegel provided the residents of Yorktown with a quick financial update; the Town received a check for the sales tax which came in at \$446,000 more than we expected which offset our mortgage tax which came in at \$341,000 less than we expected, The Town is expected to close 2009 with a fund balance of \$2.4 million which is \$600,000 less than in succeeding years. The previous Town Board took \$500,000 from the fund balance to reduce taxes. The Town will not be able to pay cash for capital improvements.

DURING THEIR REPORTS TO THE TOWN,

Councilman Bianco complimented the Highway Department as well as other town employees who have worked to clear the roadways of snow as quickly as possible. He also announced that the snow storm which began on February 10^{th} and ended the next day cost property owners \$56,168.13 in overtime.

Councilman Martorano paid condolences to the Wilke family. He also wished Bobby Gage happiness in his retirement. Councilman Martorano stated that he was very sad to hear that Donald Beaumont had resigned.

Councilman Murphy stated that Assemblyman Gregory Ball is putting together a resolution concerning Child Safety Zones that he will be presenting to the Town Board at a future meeting.

Councilman Patel stated that he recently attended the 20th Anniversary Graduation of the DARE Program in the Town of Yorktown at Crompond School. Councilman Patel also attended the 100th Anniversary celebration of Boy Scout Pack 232.

COURTESY OF THE FLOOR

During Courtesy of the Floor, the following people addressed the members of the Town Board:

Mr. Steve Robbins, representing the Yorktown Dog Park Committee stated that it sounds like the Town is making progress with the dog park. He asked that the committee be kept informed about other issues that may arise regarding this property. Mr. Robbins wanted to know if there was a Plan B, an alternative location. He offered the services of the members of his organization. The Committee would also like the Town to establish a project time line for the dog park.

Mr. Angelo Frangella asked the Town Board for permission to paint over the graffiti that is on the sound barrier walls on Route 6 in Shrub Oak?

Dr. Charles Bierman spoke about a problem that he is having at the John C. Hart Library. He asked if it is a Library or a Community Center? Dr. Bierman stated that the days of having a quiet library are over.

RESPONSES TO COURTESY OF THE FLOOR:

Supervisor Siegel responded to nine of the issues raised during Courtesy of the Floor:

She thanked the Steve Robbins for his comments concerning the dog park. The Town still has some unanswered questions. We are gathering information relating to the cost of demolition, as well as filling in the pool. The Supervisor further stated that she has asked the Recreation Commission to look into a Plan B. She encouraged the Committee to continue their dialogue with the Town on this issue.

Highway Superintendent Eric DiBartolo asked who would hold the insurance for this live burn?

Supervisor Siegel stated that Yorktown Fire Chief Martin McGannon stated that his company will hold the insurance.

Supervisor Siegel thanked Mr. Frangello for his help in the fight against graffiti but stated that the Town could not give permission to him, that he would have to contact the New York State Department of Transportation. She stated that Mr. DiBartolo has offered to make the call for you.

Supervisor Siegel told Dr. Bierman that libraries are different today from what they were in the 1950's. She explained that her office has been in contact with him as well as the Hart Library Director. New York State law permits local Library Boards of Trustees to set standards of conduct in their libraries. The staff is apparently upholding those standards. The Town Board can not dictate what it believes should happen in a library to the Board of Trustees.

Councilman Vishnu Patel responded to a the representative of the Dog Park Committee by stating that the Town Board is one hundred percent in favor of getting this park built.

Councilman Bianco called for discussion on the motion.

Supervisor Siegel explained that the Town Board filled three positions in the sewer department with two employees from the Highway Department and one employee from the Department of Environment Conservation. She further stated that the Board decided to not fill those vacancies immediately. We decided that we would temporarily park that money within the budgets of those departments. The department heads would have to justify the need for these workers. She further stated that in addition to those the two workers who were transferred from the Highway Department to the Sewer Department there are two other vacancies, one caused by the death of Mr. Wilke, the other by the retirement of Mr. Gage. The Highway Superintendent has permission to fill those last two positions.

Councilman Bianco stated that this was the first that he is hearing that there was conversation about positions held by Mr. Wilke and Mr. Gage. He asked the Highway Superintendent to speak.

Mr. DiBartolo stated that if he cannot fill those positions, his department will suffer a 22% loss. In addition to the two sewer positions that he cannot fill, there is also a position vacated by a mechanic last year that has not been filled. One of the positions that is not being filled is in our organic waste yard. If that position is not filled, the yard would have to be closed. The other position is that of a tree worker who also works as a driver. Mr. DiBartolo suggested a meeting with the Town Board to discuss these issues and to try to reach some compromise. He further stated that by not filling the position in the Department of Environmental Protection, the employees will not be able to make all of their bulk pickups.

Councilman Patel agreed that the Town Board needed to discuss this issue further

Motion voted to table this issue.

WHEREAS, the Town of Yorktown was the Defendant in certain litigation brought by Joseph M. Adrian, Elaine M. Adrian, and Adrian Family Partners I, L.P., (collectively, "Plaintiffs") in the United States District Court of the Southern District of New York (03 Civ. 06604); and

WHEREAS, the Town's insurance carrier, Arrowood Indemnity Company, defended the Town in connection with the subject litigation; and

WHEREAS, pursuant to a jury trial, the Court dismissed the Plaintiffs' due process and equal protection claims, but Judgment was entered on January 15, 2008, on Plaintiffs' selective treatment and breach of contract claims, awarding to Plaintiffs the sum of \$150,002.00 comprised of \$1.00 each for Plaintiffs Joseph and Elaine Adrian, and \$150,000.00 for Plaintiff Adrian Family Partners I, L.P.; and

WHEREAS, said Judgment was then vacated by Decision and Order dated June 16, 2008, and thereafter reinstated by Judgment dated November 5, 2009; and

WHEREAS, the said Judgment dated November 5, 2009, reinstated the award to Plaintiffs Joseph and Elaine M. Adrian the sum of \$1.00 each and to the Plaintiff Adrian Family Partners I, L.P. the sum of \$150,000.00, together with pre-judgment interest at the rate of 9% from December 6, 2006 to January 16, 2008 in the amount of \$14,646.58, and taxable costs in the amount of \$6,259.00, whereupon the case was closed; and

WHEREAS, in accordance with the Judgment dated November 5, 2009, Plaintiffs are entitled to the total sum of \$170,907.58; and

WHEREAS, insurance counsel attended a hearing before the District Court on February 9, 2010, at which time counsel agreed that said outstanding amount would be paid to Plaintiffs whereupon the Court ordered that payment be made in advance of the next Court hearing scheduled for February 19, 2010.

NOW, THEREFORE BE IT RESOLVED, that the Town Board hereby authorizes the payment to Joseph M. Adrian, Elaine M. Adrian, and the Adrian Family Partners I, L.P. the sum of \$170,907.58, which payment the Comptroller of the Town of Yorktown is hereby authorized to remit immediately.

Receiver of Taxes Building Department

DURING COUTESY OF THE FLOOR, the following residents addressed the Town Board:

Mr. Eric DiBartolo, the Yorktown Highway Superintendent thanked the Supervisor for offering condolences to the Wilke family. Keith took over his father's job when he retired. He was a wonderful employee.

Mr. Glenn Johnson spoke about the resolution concerning the repayment of money to the Adrian family. He told the Town Board that the Town would probably have to hand over more money in the future because a Judge trying the case decided to calculate interest in a different way. Approximately \$28,000 is still outstanding.

Mr. Steve Robbins asked in light of the fact that the Supervisor stated that the dog park will not involve public funding, does that mean that the Town's offer of several years ago to prepare the site, taking down trees if necessary has gone away?

Dr. Bierman handed the members of the Town Board, and the Town Clerk copies of letters written to the Library Board of Trustees (copies of which are on file in the Town Minutes file) in the Town Clerk's Office. Dr. Bierman also spoke about instances where people were speaking in the Library and nothing was done. On one occasion, Dr. Bierman stated that people were talking and he went over to the Librarian to complained, she told him that she did not hear anything. On another occasion, the Librarian asked these people to stop speaking four times and they wouldn't. Why can't the Hart Library do what other libraries do, ask these people to leave? They instead prefer calling the police department on people such as myself who want quiet.

RESPONSES TO COURTESY OF THE FLOOR:

Supervisor Siegel gave the following responses to questions posed during Courtesy of the Floor:

Mr. Johnson is correct, additional money may have to be paid out concerning the Adrian lawsuit.

The Town has said it will help prepare the site of the dog park. The one acre site for the proposed at Trump State Park is level, it has grass with some minor brush. The issue of concern at this point is liability. As I have stated before, there are abandoned buildings on the site as well as an abandoned pool. Each of these pose a liability to the Town of Yorktown.

The issue of whether the Hart Library is a library or a community center is a matter of semantics. It is up to the library staff to speak to the patrons who might be abusing the rules or call the police department, not other patrons.
