The Town Board reviewed the proposed accessory structure local law with Building Inspector John Winter and Planning Director John Tegeder. After discussion, the Town Board amended sections of the proposed local law and will refer it out for comment.

Sole Assessor Harold Girdlestone stated that the Westchester County GIS Database would like to know if the Town wants to have the names of property owners in addition to their address available on the County GIS. Sole Assessor Harold Girdlestone stated that there was a concern with having law enforcement names and addresses available on the County GIS program. The Town Board decided to allow names and addresses to be displayed on the Westchester County GIS program.

STATELAND SCOPING

The Town Board discussed a proposal from State Land Corporation. Mr. Joe Riina discussed the changes that have been made to the proposed site plan. Planning Director John Tegeder suggested sitting down with all the parties involved and come up with a proposed plan. A formal application to rezone the property will need to be filed with the town.
