NEW CHALET RESOLUTION #20

UNDERHILL APARTMENTS LICENSE AGREEMENT

RESOLVED, that the Town Board authorizes the Supervisor to execute a revocable license agreement granting a license to YHF upon a portion of the Town Parcel encroached upon by the Underhill Apartments parking lot, for a period of 33 years, in consideration of an annual fee of \$1.00.
