TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order. Town Attorney Jeannette Koster was also present at the meeting.

PLEDGE OF ALLEGIANCE

Eagle Scout Steve Anderson led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

DURING THE SUPERVISOR'S REPORT TO THE TOWN

Supervisor Grace thanked Lisa Grace for all the work she did in preparing for the reopening of the Senior Center. He thanked several organizations for their generous donations. He spoke about the Relay for Life fundraiser "Dancing with the Stars" which was a great event. Community Day had a great turn out and thanked the Alliance for Safe Kids (ASK) for doing a marvelous job putting it together. He thanked the Fire Departments, Ambulance Corps., and Yorktown Police Department for attending as well as several restaurants for contributing to the event. Supervisor Grace explained that on May 11, 2012 an Emergency Meeting of the Town Board took place at the reopening of the Senior Center to address asbestos clean up for a roof that had collapse at the Holland Sporting Club site. Supervisor Grace stated that there are several posters hanging up in the board room from children that participated in the Arbor Day celebration.

DURING REPORTS FROM TOWN COUNCIL

Councilman Bianco reminded everyone that tonight is the School District Budget vote and urged everyone to vote in their respective school districts. He also stated that an IHOP restaurant was coming to Mohegan Lake sometime in June.

Councilman Murphy congratulated all the volunteers that help make Community Day a success. He stated that the Farmer's Market will be opening this Saturday behind the Yorktown Fire House. Councilman Murphy stated that Indian Point will be doing a siren test tomorrow. He also stated that if you received a letter from the Department of Health and Human Resources requesting information it is not a prank.

Councilman Patel stated that the Arbor Day Celebration was a success. He attended the Westchester Municipal Officials Association meeting. He spoke about the FDR clean up day, dedication of the walking bridge over the Taconic State Parkway and the Museum exhibit coming up.

PRESENTATION

Supervisor Grace acknowledged Dr. Daniel Lefkowitz, member of Yorktown Utilities Oversight Committee for being the recipient of the 2012 EPA Environmental Quality Award.

Dr. Daniel Lefkowitz explained that he received this award for his work in exposing PCBs in schools.

Dr. Patricia Podolak, Chair, Utilities Oversight Committee, spoke about Dr. Lefkowitz achievement and congratulated him on receiving this award.

Police Officer Larry Eidelman gave a presentation on the Citizens Emergency Response Team (CERT). He stated that this program will begin with a kick off meeting in June. Anyone interested in participating should contact him at 962-4141, x163, or by email leidelman@yorktownpd.org.

Mrs. Lorraine DeSisto, Assistant Planner spoke about a resolution to apply for a grant to the New York State Department of Transportation for bus transportation for the elderly and people with disabilities.

COURTESY OF THE FLOOR

During Courtesy of the Floor, the following people addressed the members of the Town Board:

Mr. Paul Moskowitz stated that the Energy Advisory Committee will be hosting a forum on the NYSERDA Grants on May 21, 2012 at 7:30 PM at the Town Hall.

Mr. Jonathan Nettlefield spoke on behalf of the Yorktown Community Dog Park and asked the Town Board to clarify something that was said at a recent Recreation Commission meeting with regards to leasing the New York State Trump State Park. He wanted to know if it was true that the Town only wanted to lease a small portion of the property rather than the entire 153 acres.

Supervisor Grace stated that we are working on this and noted that former Supervisor Linda Cooper is the new Taconic Region Commissioner for the Office of New York State Parks, Recreation and Historical preservation.

Ms. Renee Fogarty spoke about creating a Department of Public Works (DPW). She would like a referendum on the November ballot to eliminate the elected position of Highway Superintendent.

Supervisor Grace stated that he has no problem with discussing this at a work session.

Mr. Steve Gardner spoke against having an appointed person in charge of Highway and supports keeping the Elected Highway Superintendent position.

Mr. Chris Sciarra stated that there are some residents who are concerned about moving the Highway Department to Greenwood Street which is a residential area.

Supervisor Grace stated that this is really in the pros and cons stage and a lot more information has to be gathered.

Mr. Steve Gardner spoke about being able to vote for public servants, he feels that there is better accountability to residents when the Highway Superintendent is an Elected position.

Supervisor Grace stated that there are two sides to this issue. We can discuss it at a future work session.

PUBLIC HEARING

RECONVENE PROPOSED LOCAL LAW AMENDING CHAPTER 300 – ADDING HELISTOPS AS AN ACCESSORY USE IN AN OB DISTRICT AND GRANTING TO THE TOWN BOARD APPROVAL OVER DEVELOPMENT IN OB DISTRICTS

Supervisor Grace called to order a public hearing to to consider a proposed local law to amend Chapter 300 of the Code of the Town of Yorktown entitled "ZONING," to add helistops as an accessory use in OB districts subject to certain standards; and granting to the Town Board approval authority over development in OB districts. The Deputy Town Clerk presented affidavits of posting and publication.

Supervisor Grace stated that this proposed local law has had some language changes and he suggested withdrawing it and re-advertising this proposed local law with the new verbiage.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was closed. Councilman Bianco motioned, seconded by Councilman Patel. Upon motion made by Councilman Bianco, seconded by Councilman Paganelli,

To reject the proposed local law.

Grace, Bianco, Murphy, Patel, Paganelli Voting Aye Motion adopted.

PUBLIC HEARING

REQUEST FOR AN AMENDED SPECIAL USE PERMIT - MID VALLEY OIL CO. (BP GASOLINE) – 1917 COMMERCE STREET, YORKTOWN HEIGHTS, REMOVAL AND REPLACEMENT OF STORAGE TANKS AND DISPENSERS

Supervisor Grace called to order a public hearing to consider the application of Mid Valley Oil Co. (BP Gasoline) located at 1917 Commerce Street, Yorktown Heights, NY 10598. Remove two 6,000 gallon steel and one 4,000 gallon steel gasoline underground storage tanks, remove one 500 gallon steel used oil UST, and remove one 500 gallon steel fuel oil UST. All associated piping and gasoline dispensers will be removed. Replace with two double wall

fiberglass 8000 gallon gasoline USTs with new dispenser and one 500 gallon above ground fuel oil tank. The Deputy Town Clerk presented affidavits of posting and publication.

A representative from Drake Petroleum Company gave the Town Board an overview of the proposed work to be done at 1917 Commerce Street (Mid Valley Oil Co.) He explained that they would be removing two 6,000 gallon steel and one 4,000 gallon steel gasoline underground storage tanks, and one 500 gallon steel used oil underground storage tank, and one 500 gallon steel used oil underground storage tanks with two double wall fiberglass 8000 gallon gasoline underground storage tanks with new dispenser and one 500 gallon above ground fuel oil tank

Mr. Howard Frank had some concerns regarding this proposed application and stated that he believes this property is in the Urban Renewal area.

Supervisor Grace explained that several committees and Building Inspector John Winter has reviewed this application with no issue.

The applicant stated that their plan was revised so that there was no intrusion on Town property.

Supervisor Grace explained that the application is only to replace existing tanks.

Mr. Howard Orneck stated that the Town Board should look at the Zoning Board Variance for this property.

Supervisor Grace stated that the Town Board took back approval authority for gasoline stations many years ago.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was closed. Councilman Bianco motioned, seconded by Councilman Murphy.

AMENDED SPECIAL USE PERMIT - MID VALLEY OIL CO. (BP GASOLINE) 1917 COMMERCE STREET, YORKTOWN HEIGHTS, REMOVAL AND REPLACEMENT OF STORAGE TANKS AND DISPENSERS RESOLUTION #182

Upon motion made by Supervisor Grace, seconded by Councilman Bianco,

WHEREAS, on February 17, 2012, Drake Petroleum Company, Inc. (formerly known as Mid Valley Oil Co.) ("Applicant") filed an application with the Building Department for a building permit to renovate, alter and replace existing exterior site elements at a gasoline filling station, including new pump islands, dispensers, fire suppression equipment, signage and fuel storage tanks (above and underground), on a property located at 1917 Commerce Street, Yorktown Heights, which is identified on the Town of Yorktown tax rolls as Section 37.18 Block 2 Lot 65; and

WHEREAS, Section 300-46, requires any new gasoline filling station a special use permit and site plan approval from the Town Board; and

WHEREAS, the Applicant's gasoline filling station was built prior to the effective date of Section 300-46; and

WHEREAS, Applicant was directed by the Building Department to apply for a special use permit for its gasoline filling station and site plan approval from the Town Board pursuant to Section 300-46, including the proposed work for which Applicant needs a building permit; and Applicant paid an application fee of fifteen hundred dollars (\$1,500.00) for a gasoline filling station special use permit as required by Sections 300-247B and 168-1 of the Town Code; and

WHEREAS, the Applicant has represented to the Town Board that it is the lawful owner of said property; and

WHEREAS, the applicant has submitted as part of his application the following documents:

- 1. A survey dated June 20, 2007, prepared by Thomas F. Miller, Control Point Associates, Inc. for Warex Terminals Corporation;
- 2. Plans entitled; "Tank and Piping Plan" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (TK-1) (1 sheet), and
- 3. Plans entitled; "Fire Suppression System" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (FS-1) (1 sheet)z, and
- 4. Plans entitled; "Tank & Piping Standards" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (UST-1.0, UST-2.0, and UST-3.0) (3 sheets), and

WHEREAS, said application was referred to the following agencies: ABACA Building Inspector Conservation Board Planning Department Planning Board Town Engineer

WHEREAS, the Town Board declared itself lead agency and reviewed the application at a regularly scheduled meeting on April 10, 2012; and

WHEREAS, the Town Board conducted a public hearing and solicited public comment at a regularly scheduled meeting on May 15, 2012; and

WHEREAS, as the Town Board determined that there would be no significant environmental impact, the public hearing was closed May 15, 2012; and

WHEREAS, the action is a Type II action pursuant to SEQR 6 NYCRR Part 617 and as such this action has been determined not to have a significant impact on the environment and is precluded from additional environmental review under Article 8,

NOW THEREFORE BE IT RESOLVED, upon full consideration of the above, the Town Board finds that the application of Drake Petroleum Company, Inc. (formerly known as Mid Valley Oil Co.) for a Special Use Permit for a gasoline filling station as built and as

proposing to do additional work as described above is consistent with the provisions and policies of Chapter 300 of the Code of the Town of Yorktown; and

BE IT FURTHER RESOLVED, that the Town Board approves the issuance of a Special Use Permit to Applicant subject to the following conditions:

- a) All construction shall be in full accordance with the following plans and reports:
 - 1. Plans entitled; "Tank and Piping Plan" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (TK-1) (1 sheet); and
 - 2. Plans entitled; "Fire Suppression System" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (FS-1) (1 sheet); and
 - 3. Plans entitled; "Tank & Piping Standards" prepared by Alan J. Micale, P.E., for Warex Terminals Corporation dated February 10, 2012, revised 3/30/2012 (UST-1.0, UST-2.0, and UST-3.0) (3 sheets)
- b) Prior to any site disturbance and the issuance of a building permit from the Town of Yorktown Building Inspector, the following must be provided:
 - 1. Westchester County Department of Health permit to remove existing petroleum bulk storage tanks and install new tanks and to operate tanks.
- c) An as-built map must be provided by the applicant's consulting engineer or architect documenting that all site improvements have been installed in accordance with the approved plans prior to the issuance of a certificate of occupancy.
- d) Any illicit discharges discovered during the project must be corrected prior to the issuance of a certificate of occupancy.
- e) Construction on the site shall not commence until a Town of Yorktown Building Permit, Westchester County Department of Health approval for installation of petroleum bulk storage permit and NYSDEC has been satisfied.

and

BE IT FURTHER RESOLVED, that unless a building permit has been issued within 360 days of the date of this resolution, this approval will be null and void.

CONVENE PUBLIC HEARING

CHANGE OF ZONE – THE WINERY AT ST. GEORGE'S PROPERTY KNOWN ON THE TAX MAP AS SECTION 15.12, PARCEL 2, LOT 53

FROM -120 TO A TRANSITIONAL ZONE

Supervisor Grace called to order a public hearing to consider the application of the Winery at St. George, pertaining to a request to amend the Town of Yorktown Zoning Ordinance and Zoning Map, and, for related land use as it pertains to lands located at 1715 East Main Street, the Town of Yorktown, State of New York, known and designated on the Town Tax Map as Section 15.12, Parcel 2, Lot 53 totaling approximately .75 acres. The petition is for Rezoning of the subject property from the R1-20 Zoning District into the Transitional District. The Deputy Town Clerk presented affidavits of posting and publication.

Supervisor Grace stated that this application is a request to rezone property from Residential to Transitional Zone. He explained that Transitional Zones are certain sites that due to their location are between incompatible land uses.

Mr. Jeffrey Econom, Engineer for the applicant stated that the Planning Board has approved this site plan which improves traffic flow, provides parking and cleans up the wetlands.

He explained that twelve parking spaces would be created on Town property in the wetlands buffer area.

Supervisor Grace explained how the Town acquired the Ardizzone parcel. He further stated that the Town can make a municipal parking lot on Town property.

Thomas DeChiaro, applicant stated that this site plan evolved from meetings with the Conservation Board and Planning Board. It provides for safer egress, cleaning of the wetlands buffer and adds treatments to the Route 6, DOT property to help with drainage.

Councilman Bianco read comments received from the Conservation Board and are on file in the Town Clerk's office.

Mr. Jeffrey Econom stated that those comments were directed at a earlier site plan and this plan has been changed to reflect those comments.

Mr. Thomas DeChiaro stated that this area is an eyesore and he would like to clean it up and have a statue of St. George erected at the site.

Councilman Murphy stated that this plan improves the egress.

Mr. Mark Michaels spoke about the application for rezoning the property. He stated that the EAF does not reflect a Transitional Zone but a Commercial Zone and this should be updated to reflect the correct zone. He feels the application is incomplete and that allowing use of the parkland for a private use would be an alienation of parkland.

Mr. Paul Moskowitz spoke about a case of parkland being alienated in New York City. He feels that the Town Board should adhere to the law and not use parkland for a private parking lot.

Supervisor Grace asked Mr. Moskowitz what if the Town builds a parking lot to access the parkland.

Mr. Paul Moskowitz stated that his concept of parkland is not the same and this parkland should be preserved because it is part of a greater ecosystem.

Supervisor Grace stated that there is a value in cleaning up the wetlands.

Mr. Moskowitz stated that if the wetlands needs to be cleaned up then the Town should pay to have it done.

Mr. Stuart Glass stated that the Town should request an opinion from the New York State Attorney General's Office on this issue.

Mr. Anthony Grasso stated that the Town Board took this property through Eminent Domain procedures and the Judge even referred to it as parkland. He served on the Town Board during this time and feels that the intent of the Board was to dedicate it parkland. He likes the Winery at St. George but there should be no intrusion on the wetlands.

Mr. John Schroeder stated that parkland should not be used for non park purposes. He feels a Master Plan should be done and it should be carefully thought out. If the wetlands need to be restored then the Town should clean it up.

Supervisor Grace stated that the Town has owned this property for the last twenty years and has done nothing to clean it up. Public-private partnerships are sometimes good and the Town gets a major improvement.

Mr. John Schroeder stated that he has cleaned up this Town for many years, if the wetlands needs to be cleaned up then the Town should do it. He feels this is alienation of parkland.

Councilman Bianco stated that he agrees with Mr. Schroeder there needs to be more details, no land swap because this is parkland. He suggested taking this in two parts: The rezoning and then the parking issue.

Mr. Jeff Econom stated that the Town has made parking areas in buffers before and feels this can be done.

Mr. William Muscata stated that everyone here is an environmentalist with their own agenda, this piece of property represents business, the applicant is willing to use his own money to clean it up. Why wouldn't we want this to be done.

Councilman Bianco would like to see the final revised site plan.

Mr. Chris Sciarra stated that he hired Jeffrey Econom and finally something is getting done with this property.

Conservation Board Chair Phyllis Bock stated that the Conservation Board has not seen this revised site plan. She suggested that the applicant come to the next Conservation Board meeting.

Mr. Patrick Cuminskey asked how you know if this wetlands is doing its job.

Councilman Bianco stated this revised site plan should have Conservation Board approval.

Mr. William Primavera stated that from an aesthetic standpoint this needs to be done and from an accessibility standpoint it needs to be done.

Mr. Tony Fusco spoke in favor of the application.

Ms. Edwina Rand spoke in favor of the application.

Mr. Jason Jackman spoke in favor of the application.

Mr. Steve Traverse spoke in favor of the application.

Mrs. Babette Ballinger stated that she has no objection but believes in the process. Be prudent in handling.

Mr. John Rabino stated that he is please with work that the Town Board is doing. We should trust Town Board and rely on the Town Attorney.

Ms. Karen Wrechen stated that the Town's motto is Progress with Preservation, move it along.

Ms. Ziegler stated that what the Town is doing is good. Spoke in favor of application.

Planning Director John Tegeder suggested taking one more look at the site plan.

Assemblyman Steve Katz spoke in favor of winery application.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was adjourned. Councilman Bianco motioned, seconded by Supervisor Grace.
