TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order.

HIGHWAY GARAGE DISCUSSION

John Tegeder, Director of Planning, Sharon Robinson, Acting Town Attorney, Bruce Barber, Environmental Consultant and Lorraine DeSisto, Assistant Planner took part in the discussion.

As part of his Economic Revival Plan for the Town of Yorktown, Supervisor Grace spoke about the possibility of moving the Highway Garage to the Greenwood Street Sewer Plant parcel. The current site of the Highway Department could be very valuable to future development in the Heights area. We have to do an environmental assessment. There is funding available for a cleanup if necessary. We spoke to a representative involved with the Consolidated Grants. He explained that the project sounds like one that would be eligible for funding. Redeveloping the Heights area fits into the goals of the Empire Development Plan.

Yorktown Planner John Tegeder stated that the funding window is very narrow. We have to put in an application by July.

Councilman Bianco expressed concern that the residents living on Greenwood Street would not like this plan.

Councilman Paganelli expressed concern that we could be exposing ourselves to a cleanup that potentially would cost taxpayers thousands of dollars if we don't get funding. He also wondered how this would affect businesses already on Front Street.

Discussion on whether it was possible to complete a Phase I and Phase II Assessment before the grant deadline.

Acting Town Engineer Sharon Robinson stated that she was not sure Phase II would be completed.

A request for funding for a Phase I was discussed. The initial cost would possibly be \$2500. The Acting Town Engineer asked that she be permitted a sum up to \$3,000.

DURING THE SUPERVISOR'S REPORT TO THE TOWN

Supervisor Grace spoke about the following events:

Yorktown's Fireman's Parade tomorrow, June 20, 2012,

The Greenwood Street Bridge has been shut down.

Demolition work will begin at the Holland Sporting Club this week. The hygienist hired by the Town has certified the site as being clean.

DURING REPORTS FROM TOWN COUNCIL

Councilman Bianco announced that there will be a Penny Social at the John C. Hart Library on June 23, 2012.

Councilman Murphy announced that representatives of the Westchester County Clerk's Office will be in Yorktown on Thursday to process Passport applications. He also stated that the Ball Fields at the Granite Knolls site look awesome.

Councilman Patel spoke about the Rotary Dinner where Yorktown Assistant Planner Lorraine DeSisto and Councilman David Paganelli were honored for their community service. He also congratulated the 2012 valedictorian and salutatorian from Yorktown High School and Lakeland High School.

Councilman Paganelli spoke about the kick-off meeting of the CERT (Community Emergency Response Team.) Approximately 20 volunteers attended the meeting in Town Hall. The Councilman also announced that Con Edison was issuing reminders for people to conserve energy now that we're going into summer. Tomorrow's temperature is expected to be in the 90's.

Supervisor Grace spoke about the new Budget Oversight Committee. Volunteers should contact his office in Town Hall.

Councilman Paganelli announced that there was a very productive meeting at FDR Park concerning a proposed dog park for Yorktown. Former Supervisor Linda Cooper was in attendance. The location of the dog park will probably be the Donald Trump State Park.

Supervisor Grace announced that the Town had received a new para-transit van from Westchester County.

APPROVE RESOLUTIONS FROM THE JUNE 5, 2012 TOWN BOARD MEETING RESOLUTION #262

COURTESY OF THE FLOOR

During Courtesy of the Floor, the following people addressed the members of the Town Board:

Highway Superintendent Eric DiBartolo thanked Acting Town Engineer Sharon Robinson and personnel from the Parks Department and the Sewer Department for their help with work on the Greenwood Street Bridge. We will meet New York State's requirements that would allow us to open the bridge tomorrow.

Mr. Bill Stoiberg, is concerned that employees from the Highway Department are using the parking lot near their office and close to the North County Trailway. It is always filled in the morning.

The Board responded that Highway Department employees do not park in that lot. Commuters and people who work in the area park in the lot. He was advised to use the lot nearest to Town Hall.

Mr. & Mrs. Dave Leitman, residents of Cordial Road and a neighbor complained about another neighbor who is harboring eight cats. Mr. Leitman said he has gone to the Building Department, the Police Department and the Animal Control Officer for help. Everyone says there is nothing they can do. The Leitmans say these cats use their deck and garden as a toilet and they need help.

Mrs. Leitman explained that she and her neighbor visited the neighbor in question and asked the owner of the property just to keep the cats on her property. They were met with curse words and the owner stating that she could do whatever she wanted to do.

Supervisor Grace asked the Town Attorney to look and see if there was anything the Town could do.

Mrs. Renee Fogarty representing Citizens for a Department of Public Works read from prepared remarks asking Supervisor Grace to reconsider the decision not to have a work session after tonight's Town Board Meeting on the subject of placing a referendum on the November Ballot that could lead to the creation of a DPW. She said the last time the Committee met with the Town Board, they were directed to come up with a report on future savings to the Town. We prepared the information and sent it to the Board as well as the press.

Mrs. Jane Daniels, also representing the Citizens for a Department of Public Works continued the discussion by explaining the work they have done on this issue.

Supervisor Grace thanked the Committee for the work they've done. He stated that tonight's meeting began at 5:00PM and they will not be having a work session after the meeting. Supervisor Grace further stated that he has an open mind on this issue. But, some of the savings mentioned in your report are inaccurate. The report does not take into account the fact that the number of employees has dropped 10% due to attrition. He further stated that it also does not take into account all of the new regulations that the Town must adhere to. Supervisor Grace said he will set up a meeting that department heads will participate in and the meeting will be televised.

Councilman Bianco stated that some of the information in this report was given to the Committee by our former Supervisor. We had discussions with her concerning this subject while she was in office.

Mr. Dave Goldberg began his remarks by stating that the Town spends about one half million dollars a year on fuel for its vehicles, he wanted to know if Yorktown had GPS systems in our vehicles.

Highway Superintendent DiBartolo stated that there are GPS systems in 68% of the Town's vehicles.

Mr. Goldberg questioned our back flow pricing policy.

Highway Superintendent DiBartolo stated that he instituted a change in 2007 after he was assigned to work with the Water Department as Director of Labor Operations. Mr. DiBartolo stated that this was done in an effort to come into compliance with the law.

Mr. Joe Bonnano, from J&J Backflow agreed that the Town was out of compliance with the law but, he is also concerned with the Town's back flow pricing law. He asked the Town Board for a list of every property owner with a back flow system.

The Town Clerk will send Mr. Goldberg a copy of the Proposed Local Law as well as the Notice of Public Hearing.

Mrs. Linda Miller, a representative of Citizens for a DPW stated that the committee is not saying that the Town's services are not good. We are saying they can be delivered more efficiently at a lower cost.

Mr. Ken Belfer, Chairman of the Yorktown Community Housing Board stated that his committee has two vacancies. He also spoke about Mohegan Lake Day which is July 15, 2012. There will be different activities throughout the day as well as discussions about the lake.

Mr. Edward Ciffone spoke about a police investigation. He apparently is not satisfied with the outcome. He also asked that the Town Board allow him and his issue, term limits to be discussed at the meeting for the DPW.

COURTESY OF THE FLOOR - CLOSED

PUBLIC HEARING

Supervisor Grace convened the public hearing to consider a request for a wetlands permit to construct a single family house on Hanover Street. The Town Clerk presented affidavits of posting and publication.

Mr. Albert Capellini, the attorney for the applicant stated that this parcel had been approved under density zoning. In 1981 a sewer connection was approved for this site.

Mr. Kyle Kalen, also representing the applicant spoke about the project. This is a one half acre parcel. The house will have a 1350 square feet footprint and will be in the wetland buffer. The house will be built on slab. The project will require the removal of 14 trees. The property will have two rain gardens. The rain garden on the north east side of the property will handle runoff from the roof and driveway, which will be an impervious surface. The rain garden to be located on the west side of the property will be used to slow down surface runoff.

Dr. Ron Abrams, an environmental scientist from Drew Associates, Inc. stated that he did a wetland functional assessment on the property (a copy of which is on file in the Town Clerk's Office.) The conditions of the functions at the site are based on an inspection that took place in 2011 and on a study of aerial photographs and State and National Wetland Inventory maps as well as his professional judgment. Dr Abrams further stated that conditions at the site ranked low or have a negligible contribution to the region's ecology. The parcel habitat and the watercourse that passes through it are severely disturbed. The wildlife habitat has a good canopy, but the ground cover is gone. The back of the site does not have any vegetative diversity. The project outlined by M. Kalen is the best plan for this site.

Councilman Bianco asked if the wetlands had been flagged.

Environmental Consultant Bruce Barber stated that he did verify the wetlands

Mr. Kevin Green, a neighbor of this property showed the Town Board members a video of water rushing across a nearby neighbor's property.

Councilman Bianco read a letter sent to the Town Board from Mrs. Susan Loughlin who owns property to the south of the Lyhaus property. Mrs. Loughlin states that she supports everyone's right to develop property they own, but the Lyhaus parcel is a bad candidate for development.

Heidi Frazier, the owner of a neighboring parcel stated that in order to build this house, more than 14 trees would have to come down. She further stated that this house, if the board approves it, will always be subject to flooding.

Supervisor Grace asked the applicant if there was anything that can be done to help the neighborhood as well as the property.

Dr. Abrams said the applicant would be happy to look into seeing if there was a neighborhood solution to this problem.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was adjourned. Councilman Bianco motioned, seconded by Councilman Murphy.

PUBLIC HEARING

AMENDED SPECIAL USE PERMIT

Supervisor Grace called to order a public hearing to consider a request from Northern Westchester Restorative Care to consider an application to amend a Special Use Permit for a one story expansion/renovation to the Northern Westchester Restorative Center (Treetops Rehabilitation and Care Center) located on the East side of Lexington Avenue and known as Section 15.15, parcel 1, Lot 23 on the Tax Map of the Town of Yorktown. The Town Clerk presented affidavits of posting and publication.

Mr. Gabriel Tchilingurian, was present to represent the applicant.

Supervisor Grace asked if there were any questions concerning this amended Special Use Permit. The application calls for the expansion and renovation of the facility formerly known as Tree Tops Rehabilitation and Care Center.

All those present having been given the opportunity to be heard and there being no further discussion the hearing was closed. Councilman Murphy, seconded by Supervisor Grace.

GRANT AMENDED SPECIAL USE PERMIT NORTHERN WESTCHSTER RESTORATIVE CARE CENTER RESOLUTION #263

WHEREAS, the nursing home has sufficient available parking spaces and no additional patient capacity is proposed to be added and the Planning Department has concluded that an amended site plan approval by the Planning Board is not required; and

WHEREAS, the Town Board approved the existing special use permit and site plan on August 15, 2000; and

WHEREAS, a short-form EAF was submitted by the applicant, dated March 6, 2011; and

WHEREAS, on November 4, 2011 the Town Board declared its intent to be lead agency under SEQRA and referred the application to the following non-Yorktown agencies: New York City Department of Environmental Protection, New York State Department of Environmental Conservation, New York State Department of Transportation, Westchester County Planning Department, Westchester County Environmental Facilities, Town of Cortlandt; and to the following Yorktown agents and agencies: Environmental Consultant, Planning Board, Planning Department, Wetlands Code Inspector, Town Engineer, and Conservation Board; and

WHEREAS, memoranda were received back containing comments from the Planning Board, dated December 7, 2011, and the Conservation Board, dated December 19, 2011; and

WHEREAS, a duly noticed hearing was scheduled for December 6, 2011; and

WHEREAS, on December 7, 2011 the Planning Board gave comments to the Town Board on the application and recommended, *inter alia*, that the applicant seek a variance from the Zoning Board of Appeals for the north side yard; and

WHEREAS, the applicant applied to the Zoning Board of Appeals for the required variance, and on March 22, 2012, after a duly noticed hearing held on March 22, 2012, the Zoning Board of Appeals issued a variance for a 35.9' side yard where 40' is required; and

WHEREAS, the Planning Department issued a memorandum to the Town Board dated March 27, 2012 containing comments on the application;

WHEREAS, on June 5, 2012 the Town Board by resolution noticed a hearing to be held on June 19, 2012, and on June 19, 2012 said hearing was held; and

WHEREAS, the Town Board has reviewed the application, and has given consideration to the public comment and the comments of the referred agencies; and

WHEREAS, Section 617.5(c)(7) of the SEQR rules (6 NYCRR) categorize as a Type II action the construction or expansion of a primary or accessory/appurtenant, nonresidential structure or facility involving less than 4,000 square feet of gross floor area and not involving a change in zoning or a use variance and consistent with local land use controls, but not radio communication or microwave transmission facilities;

NOW THEREFORE, BE IT RESOLVED, the Town Board determines the issuance of this amended site plan and special use permit to be a Type II action under section 617.5(c)(7) of SEQRA and therefore no further review is required; and

BE IT FURTHER RESOLVED, hereby Town Board hereby approves the application of Northern Westchester Restorative Care and Rehabilitation Center for an amended special use permit and site plan titled "Site Plan prepared for Treetops Rehabilitation and Care Center, LLC d/b/a North Restorative therapy and Nursing Center" as prepared by Walden Post Land Surveying P.C., dated October 17, 2011.
