EXECUTIVE SESSION

Upon motion made by Supervisor Grace, seconded by Councilman Bianco, to move into Executive Session to discuss the employment of a particular person with Judge Raniolo.

TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order. Town Attorney Jeannette Koster, Highway Superintendent Eric DiBartolo, Acting Town Engineer Sharon Robinson, Building Inspector John Winter and Fire Inspector Ed Kolisz were also present at the meeting.

PLEDGE OF ALLEGIANCE

Supervisor Grace led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

WELCOME

Yorktown Parks and Recreation Brian Gray, in addition to speaking about upcoming events announced that this year's Outdoor Movie Screening was a huge success. More than one thousand people attended the screening of the movie "Puss in Boots."

LEO'S PRESENTATION

Meagan McGowan and Coleen Reardon, the past President and Vice President of the LEO'S were accompanied by Joseph Cerone and Collin Manzo the new President and Vice President to hand out donations to the Yorktown Police Department's PBA for the DARE Program and the Justin Veatch Foundation.

JUSTIN VEATCH FOUNDATION

Supervisor Grace asked Mr. Thomas Ianniccari, the Vice President of the Justin Veatch Foundation to speak.

Mr. Ianniccari stated that he got involved in the Justin Veatch Foundation because he is a former musician and believes that the young musicians who are a part of this organization are very talented. He also believes in the goals of the organization which are to reach out to young performing artists and to provide them with opportunities to collaborate with and to be challenged by a network of like-minded peers and professionals.

REPORT FROM SUPERVISOR MICHAEL GRACE

Supervisor Grace thanked the Highway Superintendent and his staff for the work they did at the Holland Sporting Club. The Town saved approximately \$60,000 by using its own staff versus going to an outside vendor. The low bid for this work was \$89,000. Supervisor Grace also stated that the Town hopes to do an audit and inventory of its open space. He read a letter from a resident, Jane Hanley who gave high praises to Assistant Building Inspector Joe Venitucci.

REPORTS FROM THE MEMBERS OF THE TOWN COUNCIL

Councilman Murphy thanked Brian Gray, the Parks and Recreation Superintendent and his staff for the wonderful work they are doing at maintaining the Town's pools. He also acknowledged the enormous turnout for the Outdoor Movie.

Councilman Patel spoke about the Court of Honor Ceremony that he attended for Eagle Scouts Dylan Calderaro and Alexander Hernandez, members of Boy Scout Troop 164.

APPROVE RESOLUTIONS FROM THE JUNE 19, 2012 TOWN BOARD MEETING RESOLUTION #297

Upon motion made by Councilman Bianco, seconded by Councilman Murphy,

Resolved, that the Town Board Meeting Resolutions for June 19, 2012 are approved by the Town Board.

Grace, Bianco, Murphy, Patel, Paganelli Voting Aye Resolution adopted.

DURING COURTESY OF THE FLOOR, the following people addressed the members of the Town Board:

Mr. William Kellner urged the Town Board to schedule a Public Hearing on the issue of a Department of Public Works. He lived in the Town of Cortlandt when the residents approved a referendum eliminating an elected Highway Superintendent. He says the Town Board and the Supervisor will oversee this department just like they do today with other departments.

Ms. Rene Fogarty, representing Citizens for a DPW read from prepared remarks (a copy of which is on file in the Office of the Town Clerk.) She also asked the members of the Town Board to schedule a Public Hearing for August 7th on the issue of a DPW. The law must be adopted by September 1st in order to go on the November ballot.

Mr. Patrick Cumiskey thanked the Town Board, the Highway Department and the Highway Superintendent Eric DiBartolo for completing the demolition work at the Holland Sporting Club. Mr. Kaminsky handed the Town Clerk a petition signed by his neighbors who support keeping the Holland Sporting Club a passive park. They are against alienation of this land for private development. The neighborhood would like to work with the Town Board to come up with a plan for this property.

Mr. Dave Goldberg spoke about some of the findings released in an Audit of the Town of Yorktown by the New York State Comptroller. He said serious issues were raised in the report but it doesn't appear that anyone is holding anyone, including Mr. DiBartolo accountable for what was done. Mr. Goldberg spoke about backflow devices. For years, he and other businesses have tested these devices. Several years ago, the Town of Yorktown began testing these devices. Now, the Town wants to raise its rates. The Water Department has no business in "running a business."

Mr. Goldberg was advised to come to the August 7th meeting. One of the Public Hearings scheduled for that night concerns back flow devices.

Mrs. Roz Weis stated that she was neither speaking in support or opposition to a DPW. She was speaking for democracy. The Town Board should vote to advertise a Public Hearing on a DPW.

Mrs. Molly Pretnar read from prepared remarks (a copy of which is on file in the Town Clerk's Office.) The letter speaks of her family's concerns over the noise, lights and late night activities happening across the street from her home at the Hudson Valley Islamic Community Center.

Several members of the Town Board stated that they will reach out to the leaders of the Community Center in an effort to alleviate those problems.

Mrs. Nicole Tuiolo and Mr. Ed Doherty who both live on Clearview Street both spoke about the conditions of Sharon Lane which they say is "under water."

Councilman Bianco stated that he knows that street very well and it has had water issues for some time. But, he says the Highway Superintendent plans to be in the area on Friday.

Highway Superintendent DiBartolo explained many of the drainage problems in this area were caused after a 4 ½ inch pipe was wiped out. He will be on Sharon Lane on Friday.

Mr. Walter Daniels spoke about the conditions of Mohegan Lake as well as thanked the organizers of Mohegan Lake Day.

Mr. Fred Gulitz thanked the members of Yorktown's Emergency Services; the Police Department, and the Yorktown Ambulance Corp. for their professionalism. He was transported to the Medical Center after losing a portion of a finger. Recently his mother passed away in her home. Mr. Gulitz stated that he was here tonight to speak about the proposed DPW. As a voter he is very troubled. Eric DiBartolo, the Highway Superintendent should be taken out of the equation. We should be given information that can help us form an opinion.

Mrs. Jane Daniels responded to Mr. Guiltz's last comment saying that Citizens for a DPW did do research. We got information about and from other municipalities throughout the State of New York. Mrs. Daniels urged the Town to vote to advertise a Public Hearing on the subject of a DPW. She also asked if the Town had dissolved its programs whereby young people who were adjudicated by the Courts and had to perform community services.

Supervisor Grace said the Town did not dissolve the program. It appears that fewer kids are going through the court system and being sentenced with community service.

Mr. Thomas Page, spoke about his experience with a contractor who was supposed to renovate his home and wound up leaving with the work half completed. Now, that he is able to resume the work, he was told that if he wanted to renew his Building Permit, it would cost \$3,000.

Supervisor stated that a public hearing scheduled for tonight should help you.

Mrs. Olivia Buehl asked the Town Board to advertise a Public Hearing on the subject of a DPW for August 7th.

Mr. John Monticelli, a representative of the United Tax Payers of Yorktown asked the Town Board to vote on a local law to set term limits for the members of the Council and Supervisor.

COURTESY OF THE FLOOR IS CLOSED

Speaking on the subject of a DPW, Supervisor Grace stated that both he and members of the Town Council have stated that we have an open mind on this subject. Some of the rhetoric coming from the proponents of this issue has prejudged the Town Board. This administration has been very accommodating. We have scheduled an informational meeting for July 25, 2012.

Councilman Bianco reiterated what the Supervisor just said. We are open minded on this issue.

Councilman Patel stated that he is the only member of the Town Board in favor of this issue.

DISCUSSION ON PAVING WITH THE HIGHWAY SUPERINTENDENT

Highway Superintendent DiBartolo stated that he and his department are paving. The Town received a check from FEMA and he would like the Town Board to pass a resolution allowing money from that check and money from his snow removal line to be used for paving. He also asked for an additional \$100,000 from the General Fund.

Supervisor Grace stated that he has no problem with the Highway Superintendent using his own money but would like to have a further discussion on this topic.

Town Comptroller Joan Goldberg stated that the money that the Highway Superintendent is requesting for paving, is available.

PUBLIC HEARING

BAPTIST CHURCH ROAD PIPE RELINING

EMINENT DOMAIN PROCEDURE

Supervisor Grace called to order a Public Hearing , pursuant to authority granted to the Town by Town Law \S 64(2), the Highway Law and the Eminent Domain Proceedings (EDPL) Law, the Town of Yorktown hereby gives notice of a public hearing pursuant to EDPL \S 202 as follows:

A public hearing will be held by the Town Board regarding the reconstruction and repair of two culverts under Baptist Church Road, Yorktown Heights, NY, and the full-depth

restoration and repavement of the roadbed above the culverts, for the purpose of acquiring by condemnation two temporary and one permanent easement.

WSP Sells, Inc. has prepared plans for construction of such improvements. A narrative description prepared by WSP Sells, Inc. of the project is available in the office of the Town Clerk.

In order to construct these improvements, the Town has attempted to acquire access easements (two temporary and one permanent) over certain properties. Negotiations with the following landowners for easements have been unsuccessful. The properties affected by this proceeding are as follows:

There are no other possible alternative locations for any of said properties, because the repair that is needed is located on and under the road in between these two properties. The Town Clerk presented affidavits of posting and publication.

Town Attorney Jeannette Koster stated that this public hearing is required by Article 2 of New York State Law. A complete transcript of these proceedings is being taken by a stenographer. Mrs. Koster explained that all of the procedures out lined by law have been followed.

Mr. Michael Salitan, one of the affected property owners disagreed with the Town Attorney. He told the Board that every procedure had not been followed. He learned of this issue when he found a representative of WSP Sells, trespassing on his property. He also spoke about an illegal storm drain near his property.

Mrs. Sharon Robinson, Acting Town Engineer for the Town of Yorktown explained that the catch basin which is located on Town property will be moved. This work is part of the overall project.

Mrs. Koster stated that the remedy for any alleged trespass is to file a claim for whatever damages that might have occurred and litigate it with the surveyors.

Mrs. Babette Ballinger, a resident of the area applauded the Town Board for finally addressing this issue.

Mr. Paul Moskowitz stated that he also lives in the area, but is concerned that if the road is shut down, it would cause problems particularly for emergency service workers.

Mrs. Robinson said the contract calls for one lane closure. If the road is completely shut down, we do have a planned detour. But, agreed that it will add time. This is a four month contract. The work is expected to take three months. The final month affords the contractor breakdown time.

Councilman Bianco read reports from the New York City Department of Environmental Protection and the Planning Department.

Mrs. Robinson stated that those reports go with the request for a wetlands permit, not this Public Hearing.

All those present having been given the opportunity to be heard and there being no further discussion the public hearing was closed.

Councilman Bianco motioned, seconded by Councilman Murphy.

PUBLIC HEARING

BAPTIST CHURCH ROAD PIPE RELINING

REQUEST FOR WETLANDS PERMIT

Supervisor Grace opened the Public Hearing for the wetlands permit.

Mrs. Sharon Robinson, Acting Town Engineer explained that the purpose of this project is to repair two culverts under Baptist Church Road. The contractor will clean out and reline the culverts and install three hundred linear feet of guiderail and a stone lined drainage swale. The construction cost is \$400,000.

Dr. Salitan stated that the big issue is maintenance. The Town of Yorktown has not maintained these culverts. He believes that water coming off the roadway has led to the siltation of the pond on his property.

Councilman Bianco disagreed. He spoke about conditions that he witnessed while working as The Environmental Inspector for the Town of Yorktown. He stated that some of the drainage issues are caused by the next door neighbor. Councilman Bianco further stated that property owners must be responsible for maintaining streams on their property.

Supervisor Grace stated that the contract could be amended to include work on Dr. Salitan's property.

Acting Town Engineer Sharon Robinson stated that there are preventative maintenance measures built into the work.

All those present having been given the opportunity to be heard and there being no further discussion the first portion of the public hearing was closed.

Councilman Bianco motioned, seconded by Councilman Murphy.

PUBLIC HEARING

PROPOSED LOCAL LAW AMENDING CHAPTER275-40 ADDING FIRE LANES TO THE POLICE/COURT COMPLEX

Supervisor Grace called to order a public hearing for the purpose of amending Chapter 275 of the Code of the Town of Yorktown entitled "VEHICLES AND TRAFFIC," to add a Fire Lane at the Police Department and Courthouse. The Town Clerk presented affidavits of posting and publication.

Yorktown Fire Inspector Edward Kolisz explained that at the request of Police Chief Dan McMahon, the Fire Advisory Board met to discuss the creation of fire lanes at the Court House. Due to an increase in court activity, parking has become an issue. Vehicles are parking on both sides of the access road causing emergency vehicle access to be compromised. The Fire Advisory Board voted to approve the creation of fire lanes around the Courthouse.

Mr. Edward Ciffone recommended that instead of creating fire lanes on both sides of the road, have the Police Department remove the vehicles from the front of the building and bring them to the back of the building.

Supervisor Grace said the Town Board made that suggestion. The New York City Department of Environmental Protection is using those parking spaces during daytime hours.

Mr. Kolisz stated that placing a fire lane on one side of an access road would continue to compromise emergency vehicle access.

All those present having been given the opportunity to be heard and there being no further discussion the first portion of the public hearing was closed.

Councilman Bianco motioned, seconded by Councilman Murphy.

Mr. William Primavera stated that the Town of Yorktown has not made any new landmark designations since 1976.

Mr. Edward Ciffone asked questions about the sale of the Bernstein House.

Mr. Nick DiTomasso questioned the proposed sale price of the Bernstein House saying that he was told that at one time it was worth \$4 million.

BUILDING CONSTRUCTION ADMINISTRATION

Mr. Thomas Page appeared before the Town Board earlier tonight speaking about a problem he had with a construction company. They took his money and left before completing the renovation work. Mr. Page stated that his concern now is that he is being asked to pay \$3,000 to renew his permit. The project was never completed because the construction company took off with his money.

Christine and Michael Bloom spoke about their situation. A month before their Building Permit expired, they were given a punch list of things that had to be completed, by the time they completed the tasks; the permit had expired. Their home has since been inspected and the property's assessment has increased by \$8,000; they have not picked up their building permit because they were told that the cost would be \$3,321.00 which they believe is excessive.

Building Inspector John Winter stated that the new fees will be a percentage of the original fee or a flat fee, whatever is less.

All those present having been given the opportunity to be heard and there being no further discussion, the public hearing was closed.

AN UNSAFE STRUCTURE

An inspection by the Building Inspector on April 10, 2012 determined that the structure is beyond repair. A fire destroyed most of the structure. The Fire Inspector has placed an unsafe notice on the building and caution tape was placed in front of the structure.

The Town Attorney explained that all parties were given notice of this proceeding. The property owner has a reverse mortgage. The Lender was advised of the public hearing.

Supervisor Grace explained that if the Town Board declares this structure an attractive nuisance, the property owner will be ordered to tear down the structure. If they don't, the Town will have the structure removed and place a lien against the property owner.

All those present having been given the opportunity to be heard and there being no further discussion, the public hearing was closed.

NUISANCE

RESOLUTION #303

Upon motion made by Councilman Bianco, seconded by Councilman Murphy,

WHEREAS, upon the report of John Winter, Building Inspector, dated April 10, 2012, by resolution adopted April 10, 2012, the Town Board:

- 1. Determined that, at 1481 Maiden Lane, Yorktown, New York and also known by the Tax Map designation as Section 47.13, Block 1, Lot 15 (the "Property"), a structure was destroyed by fire on or about October 7, 2011, and said structure is beyond repair (the "Structure");
- 2. Determined there is present a clear and imminent danger to the life, safety and/or health of any person or property, unless the Structure is immediately repaired and secured or demolished; and
- 3. Directed the Town Attorney to serve a Notice of Proceeding upon the owner of the subject premises in accordance with Town Code Chapter 135; and

WHEREAS, a hearing was duly held on July 17, 2012, at Town Hall, 363 Underhill Avenue, Yorktown Heights, New York, at which the Building Inspector, John Winter, testified as to the condition of the Structure, and no other person appeared to testify.

NOW THEREFORE, the Town Board hereby ORDERS the Owner or any other party in interest to immediately demolish the structure, remove all debris, and make the site safe, at that person's own expense.

BE IT FURTHER RESOLVED, that if the Owner fails to comply with the Order above, the Town Supervisor is authorized to proceed with demolition and removal of the Structure; and be it further

RESOLVED, that the Town Board hereby authorizes that the expenses of the Town in connection with the demolition and removal of the Structure, including legal fees and asbestos testing and abatement if required, be assessed against the land and shall be levied and collected as provided in Article 15 of the Town Law for the levy and collection of a special ad valorem levy; and be it further

RESOLVED, that the Town Board authorizes the Town Attorney to institute such proceedings as are necessary and appropriate to collect the costs of demolition and removal incurred by the Town, including legal expenses, including instituting a special proceeding to collect the costs of demolition and removal, including a 10% surcharge and legal expenses.
