REQUEST TO HAVE TOWN CODE CHANGED REGARDING BACKYARD CHICKENS

Mrs. Teresa Ambrose and some of her neighbors signed a petition and are now asking the Town Board to amend its Zoning Code with regard to backyard chickens.

The Town of Yorktown Town Board has determined that the proposed action described below will not have a significant environmental impact and a Draft Environmental Impact Statement will not be prepared.

Name of Action: Rehabilitation and repair by the Town of Yorktown of culverts, roadbed and supporting structure located between 1225 and 1210 Baptist Church Road, and associated actions in connection therewith, including acquisition of temporary and permanent easements and issuance of Wetland and Stormwater Permit for the Town of Yorktown, New York.

SEQRA Status: Unlisted

Conditioned Negative Declaration: No

Description of Action: The applicant is proposing reline two structurally failing culverts under Baptist Church Road between 1225 Baptist Church Road and 1210 Baptist Church Road. The work is located within a wetland and control area of a jurisdictional Town of Yorktown wetland, which is also a State wetland and within a New York City watershed. An access road will be constructed of millings which shall be removed upon completion of the project. The access road will be located on the north side of the road segment being repaired in this project. Total land disturbance is approximately less than one acre and all disturbed areas will be restored with vegetation in accordance with an approved plan. The applicant requires a Wetlands and Stormwater Permit from the Town Board. Approvals have been obtained from the New York State Department of Environmental Conservation (NYSDEC), the Army Corps of Engineers (ACOE), and informal approval from NYC DEP. The Town is in the process of acquiring easements from the adjacent property owners by negotiation or eminent domain. Location: Baptist Church Road and two private parcels on Baptist Church Road in the Town of Yorktown, Westchester County, New York.

Reasons Supporting This Determination: The Town Board has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7(c), specifically:

- 1. The proposed action will not result in a substantial adverse change in the existing air quality, ground or surface water quality or quantity, traffic or noise levels, or a substantial increase in solid waste production. WHEREAS, the roadbed adjacent to and in the vicinity of 1225 and 1210 Baptist Church Road, and the culverts beneath said roadbed, are in substandard condition and require repairs and modifications (the "Project"), and

WHEREAS, to perform Project, the Town needs access to the two properties adjacent to Baptist Church Road; and

WHEREAS, on April 3, 2012 the Town Board of the Town of Yorktown (the "Town"), declared lead agency pursuant to the New York State Environmental Quality Review Act, and determined that the Project is an Unlisted Action; and

WHEREAS, WSP Sells, Inc. (the "Engineers") has prepared plans for construction of the Project facilities consisting of relining of two culverts under Baptist Church Road; and

WHEREAS, in order to perform this work, the Town has attempted to acquire easements over certain properties through negotiation, without success. The proposed easements were appraised, and the Town offered the owners 100% of the appraised value, namely: \$2,815.00 for the permanent easement on the Kaufman property; \$797.00 for the temporary easement on the Kaufman property; and \$586.00 for the temporary easement on the Salitan property. WHEREAS, due to the culverts being located on and under the road that runs between the two properties, there are no other possible alternative locations for the Project other than over said properties, and

WHEREAS, a public hearing commencing eminent domain proceedings on these easements was held pursuant to Eminent Domain Procedure Law section 202 on July 17, 2012. Notice to the property owners was duly served and issued pursuant to the Eminent Domain Procedure Law of the State of New York. Statements and testimony were taken at the hearing

from the Town Attorney; the Town Engineer; one of the property owners from whom an easement is sought, Michael Salitan; and two owners of property in the vicinity of the Project, Babette Ballenger and Paul Moskowitz; and

WHEREAS, Michael Salitan testified a town agent had allegedly trespassed upon his property and contested

NOW THEREFORE, the Town Board hereby makes the following determinations as a result of the public hearing.

The Project will result in a public use, benefit and purpose, as the Project will make the road safe for traveling, improve the flow of stormwater through the culverts and around the road;

Two easements are sought on the Kaufman property: a rectangular permanent easement approximately 25 feet wide and approximately 50.97 feet long, and comprising approximately 1,274.31 square feet (0.02925 acre); and a rectangular temporary easement abutting the permanent easement to the west, approximately 25 feet wide, approximately 161.99 feet long, and comprising approximately 4,048.50 square feet. The easement sought on the Salitan property is a temporary one approximately 15 feet wide, approximately 195.93 feet long abutting Baptist Church Road, approximately 196.16' parallel to the southern boundary, and comprising approximately 2,940.69 square feet. Copies of the proposed easement descriptions and a map depicting the location of the easements are annexed hereto as Exhibits "A" and "B". Although the Town has made numerous and repeated attempts to reach an agreement with Salitan and Kaufman for these easements, including special visits to their properties by the Project engineers to discuss the location of the easement, Salitan and Kaufman have declined by action or inaction to grant the Town the required easements. The Town engineers consider it impossible to perform the Project from any other location in that area to avoid the necessity for these easements.

The Project's general effect on the environment has been determined as part of a review pursuant to the State Environmental Quality Review Act. The Town has applied for a State Department of Environmental Conservation wetland permit, which has been granted. A copy of that permit is on file with the Town Clerk. The Town held a hearing for a required Town wetland permit on July 17, 2012 along with the eminent domain hearing, and determined that the Project would not have a significant adverse impact on the environment. Any effects on residents of the locality will be positive, due to the improvement of Baptist Church Road and stormwater management of the watercourse beneath it at that location.

The Town Board of the Town of Yorktown, having considered the testimony of all those who came forward to testify at the public hearing, hereby determines that the Project, and these eminent domain proceedings, and the acquisition of the above-described easements, are necessary and appropriate for the improvement of Baptist Church Road.

NOW, THEREFORE, THE TOWN BOARD IN REGULAR SESSION DULY CONVENED, pursuant to its right to exercise Eminent Domain pursuant to section 402(B) of the Eminent Domain Procedure Law does hereby make the above findings and determinations and does hereby authorize and direct Town Attorney Jeannette Koster to commence proceedings against the above-listed property owners for the acquisition of the above-described easements for construction of the Project.

This Resolution shall take effect immediately.

<u>DECISION - BAPTIST CHURCH ROAD PIPE RELINING</u> <u>EMINENT DOMAIN PROCEDURE - WETLANDS PERMIT</u> <u>RESOLUTION # 334B</u>

Upon motion made by Councilman Bianco, seconded by Councilman Murphy,

WHEREAS, the applicant proposes to repair the structurally failed Baptist Church Road culverts and restore the road; and

WHEREAS, two temporary easements and one permanent easement are in the process of being obtained from the property owners for this project; and

WHEREAS, jurisdictional permits and approvals for this project have been obtained from the New York State Department of Environmental Conservation (NYSDEC), New York City Department of Environmental Protection (NYCDEP) and the Army Corps of Engineers (ACOE); and

WHEREAS, there are Town-regulated wetlands and associated buffers located on the site and temporary disturbance to a Town of Yorktown wetland will occur due to the culvert replacement; and

WHEREAS, NYSDEC stream disturbance and water-quality permits are also required; and

WHEREAS, land disturbance of less than 1 acre will be required to complete the project; and

WHEREAS, the applicant has submitted Wetland and Stormwater Permit applications in which plans have been provided to mitigate impacts to wetland and wetland buffer areas, prevent erosion and sediment from the leaving the site and prevent the introduction of pollutants to the wetlands and to mitigate for the loss of trees; and

WHEREAS, the applicant has submitted a short Environmental Assessment Form (EAF), dated April 10, 2012; and,

WHEREAS, the proposed action has been determined to be an Unlisted Action under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, the Town of Yorktown Town Board declared Lead Agency on April 3, 2012 and has received review comments from the Town of Yorktown Conservation Board; and

WHEREAS, the Town Board has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7 (c) and determined that the proposed action will not have a significant adverse impact on the environment; and

WHEREAS, the Town Board has considered all reasonably related long-term, short-term, direct, indirect, and cumulative environmental effects associated with the proposed action including other simultaneous or subsequent actions; and

WHEREAS, a public hearing on the permit application was conducted on July 17, 2012; and

NOW THEREFORE BE IT RESOLVED THAT, the public hearing for the Wetland and Stormwater Permit is hereby closed; and

BE IT FURTHER RESOLVED THAT, the following plans and documents are approved subject to the below-listed conditions;

- Town of Yorktown Wetland and Stormwater Permit Application WP-BSWPPP-062-12, dated April 3, 2012, executed by the Town of Yorktown.
- Short-form EAF dated April 10, 2012.
- Design drawings and specifications prepared by Charles H. Sells, Inc.

BE IT FURTHER RESOLVED THAT, the Wetland and Stormwater Permit is granted and shall be valid for a period of one year. All work associated with the Wetland and Stormwater Permit shall be conducted in strict compliance with the approved plans; and

BE IT FURTHER RESOLVED THAT, the Town Environmental Consultant will provide the Town Board with a report stating whether the applicant has complied with the requirements of this Resolution and the approved drawings by the end of the term of this permit; and

BE IT FURTHER RESOLVED THAT, the Wetland and Stormwater Permit shall automatically expire upon completion of work; and

BE IT FURTHER RESOLVED THAT, the below-listed conditions must be completed within six months of the date of this Resolution. Should the below-listed conditions not be completed within the allotted time frame, this Resolution shall become null and void unless an extension is requested by the applicant (in writing) within said six month period and granted by the Town Board.

Conditions that must be met prior to the Supervisor signing the Plans:

- 1. The Town Stormwater Officer shall sign the MS4 acceptance form.
- 2. Provide any/all approvals and permits from NYSDEC, NYCDEP, ACOE, and the Town of Yorktown Highway Department.
- 3. The Town Supervisor shall sign the EAF.

Conditions of the Wetland, Stormwater and Tree Permit

- 1. The applicant agrees to allow periodic inspections by the Town and its consultants.
- 2. The Town Environmental Consultant shall inspect the site at the end of construction, but prior to the issuance of a notice of satisfactory completion, to ensure compliance with the Wetland and Stormwater Permit.
- 3. No additional disturbance or modifications is permitted without prior written approval from the Acting Town Engineer.
- 4. Inspection reports prepared by the qualified inspector shall be furnished to the Acting Town Engineer with 3 calendar days of the date of inspection. Modifications to the approved plans and SWPPP shall made only with prior Town Engineer approval.

Additional Requirement:

6. The Acting Town Engineer and Town Environmental Consultant must provide a written report, no later than at the expiration date of the Wetland and Stormwater Permit, documenting the status of the implementation of the requirements of this resolution.
