PROPOSED CHANGES TO LAW REGARDING WATER METERS

Water Distribution Superintendent David Rambo stated that he would like to change the law on water meters. He stated that currently a resident can request that their water meter be tested for accuracy which cost \$5. He would like to raise this fee to \$85.

Supervisor Grace asked that draft legislation be prepared for the Town Board to review.

Councilman Paganelli raised an issue with residents that have had the new meters installed receiving large bills.

Supervisor Grace stated that he is receiving complaints on this issue every day.

Water Distribution Superintendent David Rambo explained that there are two meters one on the outside of the house and one on the inside. When the old meters are removed they are tested and it is showing a difference in the actual amount of water being used. He stated that the bills are reflecting the correct amount of water being consumed and not prevouisly billed for.

Councilman Paganelli stated that this equates to a perfect storm. There is an increase due to the new meters being installed and being more accurate, an increase in NYC water rates and an additional month was added into the last billing cycle.

Councilman Murphy suggested that everyone with new meters start fresh and move forward paying an accurate amount.

Water Distribution Superintendent David Rambo stated that about 2,000 new meters have been installed. The old meters taken out have been tested for accuracy and are reading at accuracy levels of about 80% some even lower. National Metering Systems is installing the new meters and have been directed to just replace the old meters

Councilman Paganelli stated that it might be better for the Town to wait a year before beginning replacement of the entire 7,500 remaining water meters to see if there are any issues with the new meters.

Councilman Bianco stated that we should just go ahead and finish the project.

Town Comptroller Joan Goldberg stated that this new water meter system could allow the Town to take over the billing and save additional monies.

Supervisor Grace stated that he still has issues with this bid and feels the Town will be locked a certain kind of technology.

UNSAFE STRUCTURE – 1481 MAIDEN LANE

Building Inspector John Winter stated that he is getting some complaints about the property on Maiden Lane which was recently deemed an unsafe structure by the Town. He would like to know where the money to take down the building is going to come from.

Town Attorney Jeannette Koster stated that the Town has completed its legal action to remove the building.

SEPTIC APPROVALS

Building Inspector John Winter stated that there are no septic permits on file for houses built between the 1930's and 1950's, the Town Code states that his department cannot issue Certificate of Occupancy's without having a septic permit on file.

The Town Board stated that this is a jurisdictional issue and the Town should leave this with the Westchester County Department of Health to handle.
