### TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order. Town Attorney Jeannette Koster and Deputy Town Comptroller Patricia Caporale along with a member of her staff, Sandra Serrano were also present at the meeting.

### **BUDGET REVIEW**

The Town Board completed its review of the 2013 Tentative Budget.

Supervisor Grace offered Proposed Changes to the 2013 Tentative Budget, a copy of which is attached to these minutes and labeled Exhibit 1. The changes total \$925,000.

The Town Board discussed the proposed changes with Councilman Bianco objecting to raising the administrative fee from five (5%) percent to seven (7%) percent on Special Districts which includes the Refuse District and the Water District. What you are doing is taking money from the Special Districts to offset the increase in the General Fund.

Supervisor Grace defended the change stating that administrative costs have gone up over the past ten years, but this fee hasn't. As the Budget changes, so should this fee. Supervisor Grace further also spoke about the explained the amount of work that is being done in Town Hall on behalf of the Special Districts.

Councilman Bianco offered a compromise of 6%.

Supervisor Grace also spoke about proposed raises to department heads and elected officials. The salary proposal is attached to these minutes and labeled Exhibit 2.

Discussion on the raises with some Board Members questioning whether elected officials should receive pay raises during these difficult financial times.

The Town Clerk disagreed stating that it has been years since she received a raise and questioned why this was a problem. Is it because of politics?

#### REPORT FROM SUPERVISOR MICHAEL GRACE

Supervisor Grace explained that the Town Board started this meeting at 5:00PM and has now come up with a 2013 Preliminary Budget.

Supervisor Grace explained how the 2013 Budget will affect Town residents.

Supervisor Grace explained that the overall tax levy for 2013 is less than the levy

Supervisor Grace stated that this is the first televised Town Board Meeting since Super Hurricane Sandy. He spoke about the Emergency Management Plan that went into effect. The Town of Yorktown performed incredibly well. He spoke about the Emergency Operation Center which was housed in Town Hall. Daniel McMahon, the Yorktown Police Chief, Larry Eidelman, in charge of Emergency Management Services for the Police Department, Highway Superintendent Eric DiBartolo, representatives of Con Ed and the two fire companies were in the Emergency Operation Center for approximately 18 hours each day of the crisis. Supervisor Grace stated that during this time, many people performed exemplary. Members of the Town Board handed out Certificates of appreciation to the following people:

### Certificates of Appreciation:

Cary Vigilante, Geoff Wheeler, and Thomas Sciangula made sure that information was getting out via social media and in some instances television because not everyone lost power.

Bill Talbert is a man who came in to volunteer to help, on the first day of the storm. Mr. Talbert was a member of the Emergency Management Team in New York City. He holds a CDL License which allowed us to send him for dry ice.

James Waterhouse, the Animal Control Officer provided an invaluable service of making sure residents were okay after the Emergency Operations Center received calls from their relatives.

Mr. Michael Dubovsky in addition to the duties he perform as our Environmental Officer, he is a licensed electrician and proved to be invaluable to the residents of the Town including one building in Jefferson Village.

Mr. Mark Drexel and Michael DeFreitas who are both Yorktown residents were also in the Operations Center for the crisis. They work for Con Edision

Mr. Donald Blair, from NYSEG worked with the Town to get the business district and the Beaver Ridge Senior Complex on line. Mr. Tim Karsky, another representative of NYSEG came into the Command Center on a daily basis.

Police Officer Eidelman handed out Certificates of Appreciation to the following people who are members of the CERT (Civilian Emergency Response Team) who ran our shelter at the Yorktown Community and Cultural Center where more than one thousand people were served.

Supervisor Grace handed out certificates to the staff of the Nutrition Center; Noreen Driscoll, Kim Lopez and Terrence DeVeau and Sal Amuso, a resident who volunteered to work with the staff of the Nutrition Center.

Supervisor Grace stated that while the following employees were doing the jobs they are paid to do, we appreciate that many of them left their homes, many of which had no power to work at the shelter or in Town Hall.

Steve Vitulli, Keith Kutruff, Thomas Federmack, Michael Hoy, Kieran Carney and Danny Cruz.

Supervisor Grace also expressed his appreciation to Anne Anderson as well as the entire staff of the Highway Department. He also expressed his appreciation to the work done by the Highway Superintendent.

Highway Superintendent Eric DiBartolo thanked Supervisor Grace for acknowledging the work of his team.

### REPORTS FROM TOWN BOARD MEMBERS

Councilman Murphy congratulated the members of the Lakeland School District's Girls Field Hockey Team on their recent win.

Councilman Patel thanked the hundreds of people who helped neighbors after Hurricane Sandy.

Councilman Paganelli also expressed his gratitude to everyone who volunteered to help after Storm Sandy devastated parts of our Town. He also spoke about the upcoming Holiday Light Parade which is scheduled to take place on Saturday, December 1, 2012. He also thanked Officer Eidelman for the great job he did in training the CERT Team and setting up the Shelter at the YCCC.
