Supervisor Grace continued his Report to the Town speaking about meetings that have been held with representatives of the New York City Department of Environmental Protection, New York State Department of Environmental Conservation, Westchester County Legislator Michael Kaplowitz, Westchester County Legislator John Testa, Supervisor Linda Puglisi, Supervisor Mary Beth Murphy and Peekskill Mayor Mary Foster concerning sewers. On the plus side, he said, the Town of Yorktown has not been served with any violations in connection with our Yorktown Heights Sewage Treatment Plant. He believes that there may be new opportunities to have new sewer connections. These new connections would be for existing development. He further stated that there may be opportunities to have sewage that currently flows through the Mohansic Pump to the Yorktown Heights Plant diverted to the Peekskill Sanitary Sewer District. These are some of the questions that the Town Board has to consider. But before we do anything, there must be some preliminary work done by an engineer.

Councilman Paganelli came into the meeting.

AUTHORIZE DAN CIARCIA TO PERFORM A STUDY EVALUATING THE TOWN OF YORKTOWN'S FUTURE SEWAGE DISPOSAL NEEDS RESOLUTION #99

Supervisor Grace also spoke about the Town Board's visit to the Veterans Hospital in Montrose. He recommended that the community not forget these men and women who were injured while defending our freedom.

DURING REPORTS FROM TOWN COUNCIL,

Councilman Patel spoke about a former IBM colleague, Dr. Oliver Wells, one of several scientists recently honored at the White House. The Councilman represented the Town of Yorktown at a Dinner Dance sponsored by the Foundation for Excellence where three Yorktown residents; Monica Garrigan, Jane McCarthy and Donna D'Andrea were honored for their contributions to the community. Councilman Patel also represented the Town at a Pancake Breakfast sponsored by the LEOs and Elks Club. He also attended an award ceremony at Yorktown High School where this year's valedictorian and salutatorian were among the honorees.

Councilman Bianco spoke about an opening on the Zoning Board of Appeals. The Town Board will be holding interviews for this position as well as for openings on several other advisory boards. Councilman Bianco also spoke the Yorktown Central School Board meeting he attended last night. The Councilman stated that he was there to support Yorktown's Sports clubs who oppose the School District's new user fees.

Councilman Paganelli spoke about his attendance at Thomas Jefferson School's Dr. Seuss Birthday event. He also congratulated the people who were honored during the Foundation for Excellence's dinner dance.

<u>DURING HIS REPORT FROM WHITE PLAINS</u>, Westchester County Legislator Michael Kaplowitz congratulated Supervisor Grace for his work on Yorktown's sewer issue; for the first time in nearly twenty years there appears to be some movement. Legislator Kaplowitz also spoke about the creation of a Local Development Corporation. This organization would be comprised of non-profit organizations that would be able to get funding for projects like the creation of a new wing at Northern Westchester Hospital through tax free bonds.

Supervisor Grace called upon Mrs. Sherry Hughes, spokesperson for the Yorktown Garden Club. The Garden Club of Yorktown has started a new planter program with the objective of having plants bloom year round. In addition to their partnership with the Town of Yorktown and the Yorktown Chamber of Commerce, they are reaching out to new businesses such as Natural Greenscape who came up with a prototype showing various types of flowers in a planter. Although the Garden Club has received money from the Town of Yorktown, the Chamber of Commerce aswell as funding from the Garden Club itself, they are looking to raise an additional \$3,000 for this program.

Supervisor Grace explained that a resolution on the agenda tonight to change some of the conditions on a 1991 Re-zoning Decision. The request was made by Boniello Construction and Realty, but it will not be voted upon. We are going to refer the matter to various agencies for their recommendations.
