### **WORK SESSION**

Supervisor Michael Grace called the meeting to order.

### **EXECUTIVE SESSION**

Upon motion made by Councilman Bianco, seconded by Councilman Paganelli, the Town Board came out of Executive Session and resumed the work session

### TEA TEMPTATIONS

Mr. Michael Adamovich, the owner of Tea Temptations on Route 6 asked the Town Board for permission to place an additional sign (sandwich board) outside his business.

Supervisor Grace said the Town will be organizing a committee to look at signs throughout the community in an effort to help business owners as well as improve the overall look of the community.

The Town Board agreed that Tea Temptations is permitted to have an additional sign for a period of ninety days.

# **SCORE**

The Board met with Vincent Favale, Chairman of the Putnam County Chapter of SCORE. He explained that SCORE's mission is to offer free and confidential small business advice for entrepreneurs and small businesses. SCORE is a nonprofit organization with nearly 14,000 volunteers. They service nearly a half million people a year.

SCORE is seeking to develop a working relationship with the Town Board and the Yorktown Business community. They are interested in opening a branch office in Yorktown. Many of the people they see in Putnam County are either owners of businesses in Yorktown or live in Yorktown.

The Board agreed to provide a room once a week in one of the Town's facilities.

### **UNDERHILL PLAZA DIRECTORY SIGNS**

Steve Chester, owner of Signs Inc. provided the Board with a sketch of a new building directory sign for Underhill Plaza. He explained that a portion of the sign would be located on town property.

Supervisor Grace and other members of the Board suggested a more horizontal type of sign and that the sign might be better placed on the corner.

Mr. Chester will come back to the Town Board when they have a new sign.

### PROPOSED LOCAL LAW ON STREET OPENING PERMIT FEES

Jeannette Koster, the Town Attorney presented a new draft of the proposal.

The Town Clerk will place the proposal on the next meeting agenda advertising a May 21, 2013 public hearing.

#### **MANDALAY**

Mr. Ray Baiata and Mr. Dan Ciarcia, Engineer for the applicant took part in this discussion.

Mr. Ciarcia explained that his client has amassed a total of 20 acres of property within the area known as the Bear Mountain Triangle on Old Crompond Road. He presented drawings depicting a mixed use development. The proposal calls for approximately 132 housing units, a 104 bed nursing home and an office building.

The applicant would be seeking a rezone. The property is currently zoned R120.

Councilman Bianco stated that he doesn't want to down zone this property. He spoke about the school enrollment that could be generated by this complex.

A majority of the Town Board stated that they would accept a rezoning application from this applicant.

Mr. Ciarcia stated that his client will file a formal application with the Town Board.
