WORK SESSION

STORMWATER RETROFIT PROJECT

Mr. Rahul Verma, Program Director for the East of Hudson Watershed Corp. provided the Board with an update on the stormwater retrofit project at Police Headquarters. Councilman Murphy asked if modifications can be made to this project. The Town needs additional parking spaces for the Court. Due to the lack of parking people going to the Court are parking at the Methodist Church across from the street from the Courthouse.

Mr. Verma explained that he could not pay for any modifications that the Town would want to make, but the Town could.

There was also a discussion concerning the operation and maintenance of the retrofit projects after they are completed.

The Town Clerk will place the project on the June 4th agenda for referral. Mr. Barber will write a resolution for the referral.

The Town Board also discussed the two additional stormwater retrofit projects that Mr. Verma is working on for the Town of Yorktown.

STORMWATER ANNUAL REPORT

Mr. Bruce Barber handed out copies of the MS4 Annual Report explaining what the Town has done in compliance with MS4 regulations for the period ending March 9, 2013. A copy of the Report is on file in the Town Clerk's Office.

LANDMARKS PRESERVATION COMMISSION

Mr. JF DeLaperouse, Chairman of the Yorktown Landmarks Preservation Commission spoke about the Commission's proposal to landmark 3438 Old Yorktown Road. He explained that the property owner sent a separate communication stating that she and her husband give consent to the application for landmark status of their home.

Mr. DeLaperouse was told to work with the Town Attorney in getting all of the necessary paperwork together.

REVERE DRIVE

Councilman Murphy spoke about a drainage problem on Revere Drive which has led to erosion of the roadway. A nearby resident has several trees where the roots are now exposed. The ground needs to be stabilized and trees need to be topped.
