WORK SESSION

Supervisor Michael Grace called the meeting to order.

PROPOSAL ON LAW SIGNS

Mr. Al Morales was present to request that the Town Board amend the current sign law with regards to temporary lawn signs. YORKTOWN YOUTH SOCCER CLUB

Mr. Rich Romanski and Al French representing the Yorktown Youth Soccer Club were present to discuss their Labor Day Soccer Tournament and asked the Town Board to pick up the cost for police presence at the event. The Town Board agreed to provide the police for the event.

Mr. Romanski asked if the Town Board would also pick up the cost of the custodial fees.

Supervisor Grace stated that would be a cost that the soccer club will need to pay for.

Mr. Romanski stated that the Yorktown Youth Soccer Club is willing to put up \$50,000 to re-crown the Yorktown Community and Cultural Field and has asked Mr. French to get quotes on the cost.

BUILDING PERMITS AND COMP TIME

Building Inspector John Winter was present to discuss with the Town Board the need for using comp time to keep up on issuing building permits.

Supervisor Grace asked Building Inspector John Winter to put together a projected amount of comp time that would be needed to catch up on the building permits.

UNIFORM NOTICE OF CLAIMS

The New York Stated Department of State can now accept Notice of Claims from residents in the Town of Yorktown and the Town Board needs to pass a resolution authorizing the Town Clerk as the receiving agent for the State to send them to the town after they are filed with the State. The Town Board agreed to place this resolution on the next Town Board agenda.

SUSTAINABLE ENERGY FINANCE PROGRAM – ENERGIZE

Supervisor Grace stated that the Town Board could pass a Sustainable Energy Finance Law to provide a loan program for existing commercial properties to upgrade their buildings with sustainable energy efficiencies.

Mr. Mark Thielking, from the Energy Improvement Corporation stated that the program would supply loans to existing commercial properties for the purpose of upgrades in energy efficiencies. The commercial property owners would pay back the loan through their tax bill.

Town Comptroller Patricia Caporale and Receiver of Taxes Elfriede Schmid asked what would happen should someone default on the loan.

Mr. Thielking stated that the Energy Improvement Corporation has a reserved fund set aside to address situations like that.

The Town Board agreed to place this on the next Town Board agenda to advertise for a public hearing.
