SPECIAL MEETING

PUBLIC HEARING

PROPOSED NEW YORK STATE RETIREMENT INCENTIVE PLAN

APPROVE REVISED POLICY MEDICAL BENEFITS FOPR ELECTED OFFICIALS RESOLUTION #393

WHEREAS, on February 2, 2010, the Yorktown Town Board adopted Resolution #72 clarifying the town's long standing policy regarding elected officials and health benefits, and

WHEREAS, the need has arisen to amend Resolution #72 to make it clear that the resolution was meant to apply to both part time and full time elected officials, now

THEREFORE BE IT RESOLVED, that the Town Board adopts the following policy regarding the provision of medical benefits to elected officials

Policy Regarding Medical Benefits for Elected Officials

All elected officials, regardless of the number of hours worked, are entitled to medical, dental and vision benefits in accordance with the same provisions offered to full time employees.

If an elected official declines medical coverage, he or she shall be entitled to the declination payment as outlined in the CSEA contract.

WHEREAS, Resolution #324 of July 6, 2010 authorized the sale of 11 town owned properties acquired by foreclosure that were no longer needed by the town by sealed bid, and

WHEREAS, Resolution #325 of July 6, 2010 authorized the sale of unneeded town owned property located at 3147 Old Yorktown Road acquired by donation, and

WHEREAS, the sale of 3147 Old Yorktown Road is subject to a permissive referendum, and

WHEREAS, as part of a review of the 12 parcels identified in the above resolutions, on August 3, 2010, the Town Board decided to eliminate the following two parcels from the list of properties to be sold, parcel 37.14-1-74 and parcel 69.08-1-26.11, and

WHEREAS, the Town Board has determined that it has no need for an additional town owned parcel, 299 Lewis Ave, Yorktown Heights, NY 10598, acquired by foreclosure and that this property should also be sold, and

WHEREAS, the Town Board has determined that it is in the best interests of the Town to have the following 11 parcels sold by a professional auctioneer at no cost to the town:

MOSS PROPERTY

563 UNDERHILL AVENUE

Town Attorney Koster stated that the Town Board directed her to return the deed for 563 Underhill Avenue. Mrs. Koster stated that the seller is not very happy with this decision and she is letting the Town Board know in case they would like to reconsider.

Councilman Bianco stated that the reason the Town did not close on this property was because there were some liens on the property. If there are no liens pending then we should revisit the issue of buying the property.

Supervisor Siegel stated that Water Distribution Superintendent David Rambo said that we did not need the property so why would we take property we don't need.

BANNERS FOR STREET FAIR RESOLUTION #395

Upon motion made by Councilman Martorano, seconded by Councilman Bianco,

WHEREAS, said lease agreement is subject to a permissive referendum;

RESOLVED the Town Board directs the Town Clerk to publish and post such resolution within ten (10) days from the date hereof in accordance with Town Law.

<u>LEASE EXTENSION AGREEMENT – STC FIVE LLC FOR CELL TOWER ON DARBY STREET - PERMISSIVE REFERENDUM</u> RESOLUTION #397

Upon motion made by Councilman Bianco, seconded by Councilman Martorano,

WHEREAS, Town Board Resolution #383 adopted on November 17, 2009, authorized the Supervisor to enter into a lease extension agreement with STC Five LLC for the cell tower located at the Water Department site on Darby Street; and

WHEREAS, said lease agreement is subject to a permissive referendum;

RESOLVED the Town Board directs the Town Clerk to publish and post such resolution within ten (10) days from the date hereof in accordance with Town Law.

EXECUTIVE SESSION

Councilman Bianco motioned, seconded by Councilman Murphy, to move into Executive Session for the purpose of discussing the employment of particular individuals and litigation.

***OPEN SESSION

Upon motion made by Councilman Bianco, seconded by Councilman Murphy, to go into open session and had the following discussions:

Police Staffing

Police Chief Dan McMahon reported that beginning October 1st, a dispatcher will be out for 12 weeks maternity leave and that it would cost an estimated \$8,000 a month in overtime to fill the temporary vacancy. As an alternative, he proposed that a new police officer be hired, to begin employment as soon after October 1st as possible, and that the officer be assigned as a dispatcher for 90 days before being assigned to the police academy. If the dispatcher does not return to work after her leave, then the civil service list will be canvassed for a replacement.

The Chief also advised the board that one officer had advised the department of his plans to retire at the end of December.

Supervisor Siegel pointed out that by agreeing to the above hiring plan, the board would be hiring a new officer in 2010 despite having told the chief at a recent meeting that it was not prepared to bring on a new officer this year to fill either of the two vacancies created by a retirement and a resignation. Councilman Bianco added that there was actually one vacancy as the money for one police officer had been used to hire a fire inspector.

She pointed out that if the officer scheduled to retire at the end of the year did not actually retire, then the board would have actually added an officer despite its previous decision not to hire one. She requested that the chief get a letter from the officer stating his intention to

retire by the end of the year, although it was acknowledged that the letter could not be binding on the officer.

Legal Budget

Councilman Martorano asked Town Attorney Jeannette Koster to prepare an analysis of whether hiring a second attorney next year would make sense and either be financially neutral or save the town money. Ms. Koster said she would include the information in her budget request.

Local Law Revising Chapter 15 of the Code of Yorktown

Ms. Koster told the board that Town Clerk Alice Roker had advised her that the wrong version of the new Chapter 15 (Building Code Administration) had been filed with Albany. She wasn't sure what the differences were between the actual final version and the one submitted and whether they were major or minor differences. There was a discussion about who should be submitting proposed laws to the clerk's office: the supervisor's office or the attorney's office.

Budget Meeting date

There was a discussion about the all day schedule for the November 12th budget meeting with department heads. Councilman Bianco said he had not been informed that the meeting would begin at 9am and that he would be not able to attend the meeting that early. Supervisor Siegel said that she had informed the board of the proposed earlier starting date asking board members to get back to her if anyone had a problem with the 9am starting time. As no one responded to her email, she assumed that everyone was okay with the time. Councilman Bianco felt that the starting time should have been discussed at a work session and not by email.

ADJOURN

Councilman Bianco moved, seconded by Councilman Murphy, to adjourn the Town Board meeting.
