EXECUTIVE SESSION

Councilman Murphy Bianco, seconded by Councilman Martorano, to move into Executive Session to discuss the employment of particular persons with Building Inspector William Gregory, and Department of Environmental Conservation Superintendent Patrick Lofaro.

The Town Board voted on the following changes to the Supervisor's Budget:

Upon motion made by Councilman Martorano, seconded by Councilman Bianco,

A3120.102 Increase Dog Stipends by \$4,000.00 A3120.431 Increase Dog Expense by \$4,000.00

Siegel, Bianco, Martorano, Murphy, Patel Voting Aye

Upon motion made by Councilman Martorano, seconded by Councilman Murphy,

A3120.102 Return to 2010 Budget of \$5,220,831.33

Councilman Martorano explained that he told the Chief that he would make this request of the Town Board.

Supervisor Siegel explained that if he is looking to hire new police officers, additional monies would have to be placed in the budget.

Councilman Bianco stated that adding one police officer to the budget would cost \$90,000. Adding two police officers would raise the tax increase by 2.25%

Councilman Martorano asked that the issue be tabled for the moment.

Supervisor Siegel stated that this was an oversight on her part. The money is used to pay Lorraine DeSisto to do minutes of the Planning Board Meetings and for Nancy Milanese to do minutes of the ABACA Meetings.

Upon motion made by Councilman Martorano seconded by Councilman Bianco A7450.0110 Restore Adele Hobby's hours at the Museum

Councilman Bianco stated that he would like to table this issue at this time because he believes that he has a way to pay for this along with other proposals that will be made today.

Upon motion made by Councilman Martorano, seconded by Councilman Bianco, A1010.0490 Restore Cary Vigilante to the Budget \$6,000

Councilman Bianco stated that he believes that it is important to have someone who works on the town's cable station rather than having to rely on a town employee who probably would not come into Town Hall on the weekend, as Cary does.

There was discussion concerning the new equipment that the Town will be purchasing to upgrade the government channel and the question of whether someone would be still be needed.

Supervisor Siegel reminded the Town Board that several items have yet to be funded in the proposed budget including a possible retirement, tax certioraris and the raise for the police department personnel. The total could be as much as \$800,000.

Councilman Bianco stated that he would like to make a suggestion that could pay for the employee at the Museum, as well as the other increases that were made to the budget.

Upon motion made by Councilman Bianco, seconded by Councilman Martorano,

Take \$50,000 from surplus Increase the sales tax projection by \$100,000

The Town Comptroller prepared a chart, which is hereto annexed explaining the individual line transfers of the above budget changed.
