Section I. Statement of Authority.

This Local Law is authorized by the New York State Constitution, the provisions of the New York Municipal Home Rule Law, the provisions of the Statute of Local Governments, the relevant provisions of the Town Law of the State of New York, the laws of the Town of Yorktown and the general police power vested with the Town of Yorktown to promote the health, safety and welfare of all residents and property owners in the Town.

Section II. Section 275-6A in Chapter 275, entitled "VEHICLES AND TRAFFIC," Article I, of the Town Code, entitled "Traffic and Parking Regulations," is hereby amended by adding the following location to the list of public highways upon which a driver of a vehicle shall come to a full stop unless otherwise directed by a peace officer:

East Main Street at the northwest corner of the intersection with Route 132 (in front of #990 East Main Street at approximately 41.329780N, -73.823897W)

East Main Street at the northwest corner of the intersection with Stony Street

East Main Street at the southeast corner of the intersection with Stony Street

Mark Road at the southwest corner of the intersection with White Hill Road

Mohansic Avenue (service road) at the northeast corner of the intersection with Park Lane

Mohansic Avenue (service road) at the southwest corner of the intersection with Leland Drive

Wenonah Trail at the southwest corner of the intersection with Dale Street

Wren Place at the southwest corner of the intersection with Suncrest Avenue

Section I. Severability.

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudicated finally by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this local law would have been adopted had any such provisions been excluded.

Section II. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section III. Effective Date.

This local law shall become effective upon filing in the office of the Secretary of State in accordance with the provisions of the Municipal Home Rule Law.
