A local law to amend Chapter 198 of the Code of the Town of Yorktown entitled "LANDMARK

Section I. Statement of Authority.

This local law is authorized by the New York State Constitution, the provisions of the New York Municipal Home Rule Law, the relevant provisions of the Town Law of the State of New York, the laws of the Town of Yorktown and the general police power vested with the Town of Yorktown to promote the health, safety, and welfare of all residents and property owners in the Town.

Section II.

Chapter 198 of the Code of the Town of Yorktown is hereby amended as follows:

- The title of Chapter 198 is hereby amended by replacing the word "Landmark" with the word "Heritage."
- The title of Article I of Chapter 198 is hereby amended by replacing the word "Landmarks" with the word "Heritage."
- The title of section 198-3 of Article I of Chapter 198 is hereby amended by replacing the word "Landmark" with the word "Heritage."
- The phrase "Landmarks Preservation Commission" shall be replaced with "Heritage Preservation Commission" in §§ 198-2, 198-3, 198-5(A), 198-5(B), 198-6(A), 198-7(A), 198-7(B), 198-11, 198-12(B), 198-14, 198-15(D)(3).
- Section 198-15(D)(1) is hereby amended by replacing the word "Landmarks" with the words "Heritage Preservation."

Section III. Severability.

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudicated finally by

a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this local law would have been adopted had any such provisions been excluded.

Section I. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section II. Effective Date.

This local law shall become effective upon filing in the office of the Secretary of State in accordance with the provisions of the Municipal Home Rule Law.
