Seritage SRC Finance LLC application consists of proposed interior renovations to the existing Sears building to maintain Sears (67,693 SF) and propose a 9,474 SF restaurant on the upper level, and to propose 37,201 sf of retail space and a 38,616 SF fitness center, inclusive of a 5,732 SF proposed building expansion, on the lower level. The application also includes proposed renovations to the surrounding parking area and associated site improvements, as well as a Zoning Text amendment.

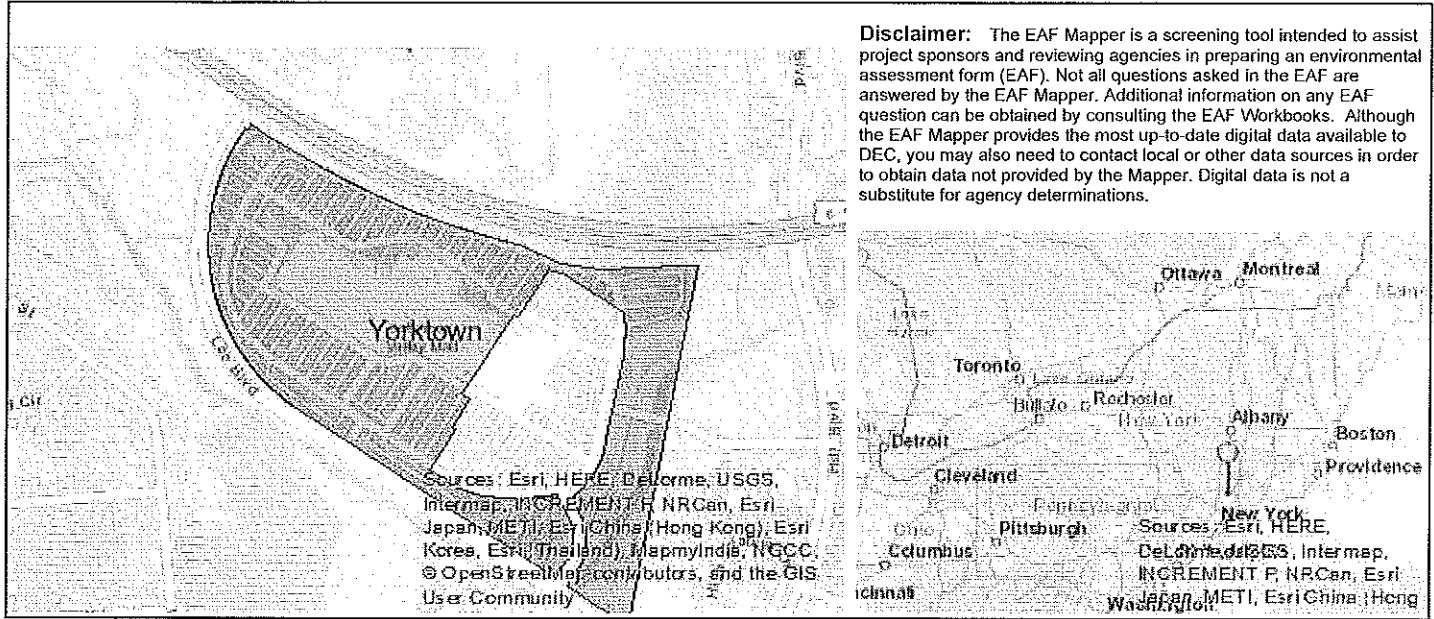
